Aussie oral insulin move

**CURTIN** University of Technology has announced plans to develop an oral insulin mimetic in conjunction with listed Australian biotech PharmAust.

PharmAust will form a joint venture between its wholly owned subsidiary Epichem Pty Ltd and Curtin, which will "expand on Curtin's existing intellectual property" in relation to the drug.

Epichem will provide the synthetic and medicinal chemistry services of one chemist for up to a year in return for 40% of the project, while Curtin will

#### Corum cash crisis

PHARMACY IT supplier Corum Group has issued a stock market announcement confirming that it's currently in breach of its banking convenants.

The firm said it's in negotiations with financiers about how to "recapitalise the Company to the satisfaction to the bank."

The company has 6.7m unsecured convertible notes on offer which were due to be redeemed or converted by 30 Sep.

However due to the low price of the shares (2.1c) and share market volatility, noteholders have not converted their notes.

Corum said it's confident of coming up with an acceptable proposal and will be advising shareholders of a meeting to approve a plan shortly.

A joint statement said that with diabetes affecting more than 194 million people across the globe it's one of the most costly health problems in the world.

"The development of an orally available insulin mimetic to avoid the use of needles would be a major breakthrough in the treatment of the disease," the statement said.

### TGA payment move

**PAYMENT** of annual Therapeutic Goods Administration charges for registered therapeutic goods will be simplified from 01 Jan 2009 under new legislation which has recently been passed in federal parliament.

The Therapeutic Goods Amendment Legislation (Annual Charges) Bill 2008 makes a number of changes relating to the "collection and imposition of annual charges, and the implementation of exemptions from liability to pay annual charges because of low value turnover of therapeutic goods."

The Act is amended to allow for the setting of a uniform date for payment of annual charges, allowing sponsors to make a single payment for all goods rather than on the anniversary dates of the listing of the items.

### **Zuellig deal done**

SYMBION Pharmacy has now been officially acquired by The Zuellig Group, with the \$505m transaction settled last Fri.

Symbion Pharmacy gm Patrick Davies said the completion heralded an "exciting new era" for the two companies."

He said Symbion is looking forward to leveraging off Zuellig's vast experience in this industry.

Zuellig is one of the largest privately-owned companies in the world, with Zuellig Australia ceo Christian Stoeckling saying "we believe we have now acquired the best performing pharmacy distribution assets in the Australian market, a region where we are committed to establishing a long-term presence."
