

### Hormone treatment price rise

**NOVO** Nordisk has announced that from 01 Jul its Kliovance, Kliogest and Trisequens hormone replacement products will no longer be included on the PBS.

The items will remain available on private prescription at an increased price, and the company also said that from 01 Jul the prices of Estrofem 1mg and 2mg, currently private prescription items, will increase.

Novo Nordisk medial director Dr John Miller said the changes are due to increased costs associated with the treatment options.

"As these costs have increased over a number of years, the reimbursed (PBS) prices have actually decreased."

He said the company had been reviewing its hormone therapy porftolio for some time, and "given this situation we have no option but to make these changes in order for us to continue to offer these treatment options to Australian women and doctors."

The new prices will be similar to other private prescription hormone therapies currently available, with the maximum recommended prices of Kliovance, Kliogest, Trisequens and Estrofem "no more than the standard PBS co-payment."

**THE** Pharmaceutical Benefits Advisory Committee will consider 42 submissions for new drugs, changes to listings and resubmissions at its next meeting.

Yesterday the meeting agenda was made public, with the PBAC calling for consumer comments by 10 June.

There are two new applications for vaccines under the National Immunisation Program, including a new pneumocccal polysaccharide injection for the immunisation of children aged 6 weeks to two years against disease caused by Streptococcus peneumonia, as well as an influenza vaccine from Sanofi Pasteur for patients 65 and over.

Other major submissions include Section 100 listings for GSK's Volibris (ambrisentan) tablets for pulmonary arterial hypertension, as well as Celgene's Vidaza (azacitidine) for leukaemia.

There's also a submission from GSK for its Avodan (dutasteride) for treatment of enlarged prostate, as well as a Pharmatel Fresenius Kabi request for an unrestricted benefit listing of Voluven (hydroxyethyl starch) for blood loss.

Eli Lilly is also applying for an authority required listing for Zyprexa Relprevv (olanzapine) for schizophrenia treatment, as well as

#### Cruise ship quarantine

**SWINE** flu is becoming more prevalent in Australia, with 32 cases now confirmed and an outbreak on board a cruise ship forcing the quarantining of about 2000 passengers.

13 passengers who were aboard the *Pacific Dawn* were hospitalised after showing flu-like symptoms, and the ship has now headed to underpopulated Willis Island for the duration of its current itinerary, to return to Brisbane on 02 Jun where a full team of health workers will assess all those on board.

It's the second Australian cruise ship to be affected by influenza A (H1N1) with the *Dawn Princess* also detained for about six hours in Sydney last Sat after returning from a cruise to Hawaii. **THE** Therapeutic Goods Administration has released the public recommendations made as a resulf of last week's meeting of the Complementary Medicines Evaluation Committee.

The CMEC considered a number of items relating to complementary medicines for cholesterol, and endorsed two coded indications as acceptable for medicines making claims in relation to cholesterol:

'May help maintain normal [and/ or healthy] cholesterol levels'; and 'May help maintain cholesterol within the normal [and/or healthy] range and improve the HDL/LDL ratio.'

The CMEC also endorsed a label advisory statement for use when

making indications/claims in relation to boold cholesterol levels: 'Not for the treatment of high

cholesterol. Blood cholesterol levels should be regularly checked.' Other recommendations included

that Calci-Tab 600 tablets are suitable for registration on the Australian Register of Therapeutic Goods, as well as a confirmation that any herbal species confirmed as containing aristolochic acids is not suitable for inclusion in Listed medicines "as there is insufficient justification for any cut-off to be applied to preparations of such species."

Consequently Asarum spp. are no longer suitable for listing, due to the increased potential for preparations of this genera to contain aristolochic acids.

The committee also recommended to the TGA that there is insufficient evidence to warrant a change to the current labelling and regulation of products containing preparations of *Cimicifuga racemosa* (Black cohosh) after a review of reports of adverse reactions.

#### Palliative package

**MINISTER** for Health and Ageing, Justine Eliot, yesterday announced a \$14.4m package of funding for palliative care, with the news coinciding with Palliative Care week.

The money includes \$11m over two years for local grants to help community groups and aged care providers support palliative care patients and their families.
