#### Intradermal delivery

IN light of the launch this week of the world-first interdermal influenza vaccine, Intanza, in Australia, the Pharmacy Guild is calling on pharmacists to engage healthy adults in dialogue about the importance of seasonal vaccination.

Intanza is an intradermal microinjection which uses a 1.5mm needle that delivers a 0.1 mL dose and  $9\mu g$  of antigen directly into the dermis, thereby exploiting its high concentration of immune cells (dendritic cells) which then create an equivalent immune response to traditional intramuscular vaccination.

# RACP slams new GMiA code Sticking with Sigma

THE Royal Australasian College of Physicians has urged the Generic Medicines Industry Association (GMiA) to further strengthen its proposed code of conduct, which is currently under consideration by the Australian Competition and Consumer Commisssion (PD 13 Apr).

In particular the College says suggestions in the Code which say that generic substitution is unlikely to change health outcomes for patients "does not stand up to scrutiny".

The RACP said that switching

between different generic medications "can potentially have substantial negative effects.

"The differing size, shape and colour of different brands of the same generic medicine can produce patient confusion, compliance problems and negative health outcomes," it added.

The RACP's submission to the ACCC enquiry also begs to differ with a GMiA assertion that brand substitution is likely to create savings for patients.

"The College would also like the GMiA to reconsider this in light of the possibility of a pharmacist changing a patient's generic brands purely as a resulf of industry promotional activities, discounting and reward schemes.

"Further, if a generic medicine is priced under the PBS co-payment, pharmacists can, and do, charge a higher price than the PBS recommended price to consumers.

"As such, brand substitution does not necessarily result in financial savings for the patient," the submission adds.

The RACP also urged that all "educational" events directed at dispensers come under the reporting code along with prescribers, saying "it appears most inappropriate to exclude the reporting of such events directed at pharmacists."

It's suggested that the GMiA make further provisions about influencing the pharmacy channel, with possible wording:

"Advertisements/promotions must not offer any personal incentive to a healthcare professional, pharmacy assistant or other non-healthcare professional sales person, to recommend or supply therapeutic goods".

The deadline for submissions to the ACCC consultation closed yesterday, and now the GMiA will have an opportunity to respond to the issues raised.

**AUSTRALIAN** Pharmaceutical Industries is yet to see any significant upturn in business from pharmacists as a result of the widely-reported travails of its rival, Sigma Pharmaceuticals.

Speaking after the announcement of the API half year result (PD yesterday), API ceo Stephen Roche admitted that Sigma's profit downgrade and consequent breaching of bank covenants (leading to tightening of trading terms) had created opportunities for API, but also said "we lost large chunks of business in the last six weeks to Sigma through arrangements, but I do think that they've now changed that attitude and we haven't seen that activity continue".

He also said any potential new large customers would have to be assessed for credit risk, and any deals on offer would also be offered in similar arrangements to API's existing customers.

"Pharmacists will stick for a period of time with their current wholesaler until they see what changes at Sigma or what management changes occur," Roche said.

# PSA on pain management

THE Pharmaceutical Society of Australia is encouraging pharmacists to play a larger part in the support and management of chronic pain patients.

"Chronic pain is a significant issue in the community with many patients unable to receive adequate support and care for their condition," said PSA Qld president and member of the National Pain Summit, Dr. Lisa Nissen.

"Some of this is due to a lack of access to appropriate medical care and pressure on an already overstretched health system."

According to Nissen, pharmacists as informed and highly trained health professionals are perfectly suited to assist patients in managing their condition.

Also available are referral pads for use by pharmacy assistants who receive requests for Pharmacist Only Medicines, including analgesics containing codeine, with Guild President Kos Sclavos saying: "Many consumers may be confused or inconvenienced by the changes, so it is important that they are properly informed that community pharmacies are required by law to comply with the new scheduling requirements".

#### HRT patches now here

ESTRADOT (oestradiol), Estalis Continuous and Sequi (oestradiol/ norethisterone acetate) hormone replacement therapy patches are now available on the Pharmaceutical Benefits Scheme as a first-line treatment for menopause.

The patches are designed to manage the short term symptoms associated menopause, and to also prevent bone density loss in postmenopausal women who are at increased risk of future osteoporotic fractures and are intolerant of, or contraindicated for, other medicinal products approved for the prevention of bone mineral density loss.

chronic pain patients who are often mostly 'invisible' within the community," she added.

As part of the pain drive, pharmacists are being urged to help link pain patients up with other support services including the Australian Pain Management Association's Pain Link Helpline (1300 340 357) and Chronic Pain Australia's National Phone Information and Support line (1800 218 921) which not only provide support for patients, but also their carers and health professionals.

"One example is the Home Medicines Review where patients can sit down in their own home with an accredited pharmacist who reviews their medications and helps them to optimise their pain management regime," Nissen said.

"In conjunction with services like the support line and the help line, the professional services and advice provided by pharmacists can make a real difference in helping chronic pain sufferers manage their condition," she concluded.

## Reporting reactions

**DUE** to a considerable spike in the number of calls to the Adverse Medicines Events hotline, the National Prescribing Service is reminding pharmacists of the importance of accurately reporting all adverse medicine events.

"Health professionals have a duty of care to report suspected reactions to new medicines and vaccines as this is the only way in which information can be accurately collected and used in the interest of public health," said NPS ceo, Dr Lynn Weekes.

The NPS is urging pharmacists to record as much info as possible including batch numbers.
