FDA Invega approval

THE US Food and Drug Administration has approved Invega (paliperidone) extended release tablets for the treatment of schizophrenia in adolescents aged 12 to 17 years.

Invega was first approved for the treatment of schizophrenia in US adults in Dec 2006.

13 student plan teams

THE Pharmacy Guild says that 13 teams from six pharmacy schools across Australia will compete in this year's \$12,000 National Student **Business Plan Competition.**

Registrations are now closed, with the strong response following a revamp of the competition making it easier to enter this year.

Sponsors include Blackmores Australia along with Gold Cross Products and PDL, with entrants given 'Foundation Pharmacy' details on which to build their innovative businesses.

Valdoxan "paradigm shift" for depression

SERVIER Laboratories says its newly released Valdoxan (agomelatine) provides a significant new treatment option for depression in Australian patients.

The product was approved by the TGA this month (PD 06 Apr) and is now available to Australian psychiatrists and GPs on private prescription.

"Valdoxan is the first antidepressant to help resyncrhonise circadian rhythms by acting on receptors in the body's masterclock located in the brain," the company said.

Valdoxan does not increase serotonin levels, but is a melatonin receptor agonist and 5-HT2c receptor agonist.

The medication is taken as one or two 25mg tablets at bedtime, with a month's supply expected to be \$59 for a 25mg/day retail at a community pharmacy.

It also appears that API may use legal means to respond to Pharmacy Alliance's threats to refer API's behaviour to the ACCC, with Roche saying it was inappropriate to comment further "as the matter is subject to potential legal redress by API".

NPS warns on Vit D testing

TESTING for Vitamin D deficiency is rising at a faster rate than any other medical test, prompting a warning from NPS Australia that greater consideration is needed before ordering a Vitamin D test.

Over the past ten years, testing for Vitamin D has increased more than tenfold, with a spike in GP interest coupled with increased media reportage of Vitamin D deficiency being cited as the main reasons for the rise.

As a result of this trend, the NPS has designed a new education program for health professionals aimed at providing clarity and guidance around common questions related to Vitamin D deficiency.

"There is a lot of conflicting information regarding vitamin D," said NPS clinical adviser, Danielle Stowasser.

"In the absence of clear Australian guidelines this NPS education program provides direction on how to identify and manage people at risk of vitamin D deficiency and those who are not,

and factors that may influence the vitamin D results you receive.

"It also addresses supplementation as a treatment option in addition to safe sun exposure," she added.

According to the NPS there are a number of different Vitamin D tests currently in use here, each with a "considerable degree of variability" between themselves and between laboratories.

In addition, the NPS said the association between Vitamin D deficiency and non-bone diseases such as type 2 diabetes and hypertension is "yet to be proven".

"This NPS program encourages assessment of risk through a targeted approach to testing rather than screening patients for vitamin D deficiency," said Stowasser.

The benefit of routine testing in low-risk populations is unclear, and studies show "moderate to severe vitamin D deficiency is uncommon in the general Australian population," she added.
