

Blackmores campaign | Guild disaster appeal launch

THE Pharmacy Guild of Australia has today launched a Members' Disaster Appeal to assist many pharmacy owners who are facing major losses as a result of the recent flooding in Queensland and Victoria.

Guild President Kos Sclavos said that many insurers in Australia do not provide any flood cover under their standard business insurance policies, and even with the Guild Insurance inclusion of 20% automatic flood cover towards replacement cost of buildings or business contents, the flooding has "clearly left some affected Members facing significant debilitating costs.

"At this time the affected Members are looking to the Guild for support to withstand this disaster and remain in business." he said, with the special appeal fund aiming to help those who have lost the most in the disaster.

The fund will start off strongly, with a \$200,000 contribution from Guild Insurance, as well as \$15,000 from Gold Cross Products and Services plus \$10,000 from each of Fred Health and

"I am grateful to the boards of these companies that they have authorised this support," he said.

The funds raised will be administered under the supervision of the National Council's Corporate Services Committee which includes representatives from the ACT, Victoria, NSW and Queensland.

Contributions to the appeal are not tax deductible, and Guild Members who have suffered significant business losses will be able to apply for help by completing a statutory declaration form which will be available from State Branches within a week or two.

Sclavos said the focus of the fund would be on loss of fixtures and fittings in excess of any insurance payout, aiming to primarily recoup "tangible losses that can be verified" rather than business interruption costs.

"This is a time to help our colleagues in the greatest need. I urge Members to contribute to this disaster appeal, knowing that it will go directly to our member colleagues in severe financial distress through this unprecedented natural disaster," he added.

PBS amendments

THE Health Dept has issued two price corrections for prices in the 01 Feb edition of the Schedule of Pharmaceutical Benefits, affecting fludarabine phosphate tablet 10mg and ezetimibe with simvastatin see www.pbs.gov.au.

DoHA crisis advice

THE Department of Health and Ageing has issued a special advice for pharmacists on dispensing medicines under emergency supply, script owing and immediate supply arrangements, in the light of Cyclone Yasi in North Oueensland and the recent flood emergency.

For patients who do not have their Medicare, DVA or Centrelink card the pharmacist should ring the PBS enquiry line 132 290 for assistance with a patient's Medicare or concession details.

Patients can receive a three day emergency supply of medication without a prescription, and pharmacists can also confirm a patient's medication details with a prescriber and dispense using the 'owing prescription' provision.

Pharmacists must ensure they keep accurate records of emergency supplies to patients.

And temporary relocations of pharmacies due to flood or cyclone damage should send an email to Medicare Australia with details which will be fast tracked within 24 hours by the Australian Community Pharmacy Authority.

TGA review public meetings

THE panel which has been appointed to undertake the Review to Improve Transparency of the Therapeutic Goods Administration (PD 21 Jan) has confirmed the details of a series of public consultations.

Events will kick off in Parramatta on Wed 23 Feb, with further meetings to be held in Albury on 28 Feb, Melbourne on 01 Mar and Perth on 04 Mar.

"In these meetings, the Panel will be particularly interested in the types of information you think the TGA should make available, and the ways you would like to receive that information," an invitation to prospective attendees reads.

The meetings will also include the opportunity for participants to share views with all attendees, as well as for discussion in small groups chaired by a member of the Panel.

NZ pharmacist facing drugs charges

AN AUCKLAND-based pharmacist is reportedly facing charges of professional misconduct according to the NZ Health Practitioners Disciplinary Tribunal.

The case relates to alleged illegal sales of a range of prescription medicines including Viagra, Cialis, Reductil, Salbutamol, Propecia and "some antibiotics".

There's also an allegation relating to more than 50,000 Sudomyl and codeine phosphate tablets which are unaccounted for.

A hearing is expected to continue until the end of the week, according to NZ publication Pharmacy Today.

UK weight loss alert

THE UK Medicines and Healthcare products Regulatory Agency is advising people not to use the herbal weight loss product 'Herbal Flos Lonicerae (Herbal Xenicol) Natural Weight Loss Formula' due to possible side effects from an "undeclared pharmaceutical substance".

HERE'S one way to reduce smoking rates.

A Buddhist monk in the kingdom of Bhutan is facing five years in prison, after being charged with "consuming and smuggling contraband tobacco".

Bhutan is aiming to become the world's first ever smoke-free nation, and has introduced a strict new law which came into effect this month.

Sales of tobacco were banned in 2005 but smoking has continued with large amounts of cigarettes smuggled across the border from nearby India.

Under the new arrangements police who suspect people of smoking are able to enter homes, imprison shopkeepers who sell tobacco, and prosecute smokers who can't produce customs receipts for imported cigarettes.

AN entire town is set to be demolished in the USA after being declared a health hazard.

But a pharmacist is the final hold-out, refusing to vacate his store in Pichler, Oklahoma after rejecting a buyout from the govt.

Pichler is badly contaminated by lead, with officials set to demolish more than 900 buildings.

Pharmacist Gary Linderman operates the last remaining store in town as well as dispensing prescriptions, and said: "It's not time for me to leave yet".

A PHARMACIST in Florida in the US has been threatened by a thief wielding a cordless drill.

Police arrested 25-year-old Michael Hendrickson of Cocoa Beach after he allegedly gave a handwritten note to a pharmacist at a Walgreens outlet "indicating he had a gun and wanted prescription medicines or he would start shooting".

The pharmacist noted a pistolshaped bulge in the man's waistband and handed over several bottles of unnamed drugs.

A short while later the alleged robber was stopped in his car and the medications recovered, along with a battery drill but no gun.
