Asthma attacked at Priceline

National Health Authority

AUSTRALIAN Health Ministers have agreed in principle on a framework creating a new National **Health Performance Authority** (NHPA), as the next stage in the nation's health reform process.

The new agreement solidifies the future creation of the NHPA, whose establishment was agreed to by COAG in February this year.

According to the Department of Health, the NHPA will fall under the Performance and Accountability

Biologicals framework

THE TGA has published the comprehensive details of the new regulatory framework for biologicals, which commenced on 31 May - details at www.tga.gov.au.

Framework, and will monitor assess and report on performance of the health system, reporting on the performance of hospitals and health networks to State and Territory Health Ministers prior to public release of the information.

Refinements to the Performance and Accountability Framework legislation agreed to by the Ministers for the establishment of the NHPA include the affirmation of the States and territories as system managers of public hospitals.

The Ministers also agreed to examine the number of national bodies to which hospitals are required to report, with a view to rationalising the data requirements; as well as details of the establishment of national hospital performance measurement criteria for application by the NHPA.

The in principle agreement reached this week is now subject to the production of a final re-worked Bill and framework.

NEW PRODUCTS

Eumovate (Clobetasone butyrate) 0.05% is a corticosteroid used topically for its glucocorticoid effects. The antiinflammatory properties of clobetasone butyrate reduce the erythema and itchiness associated with eczema and dermatitis. The cream base in Eumovate Cream has moisturising properties. It is indicated for the short-term (up to 7 days) treatment of milder forms of eczema, dermatitis and other steroid responsive skin conditions. It is contraindicated in untreated bacterial infections such as cellulitis, folliculitis, furunculosis or impetigo: fungal infections such as those associated with tinea (eg athletes foot, jock itch); viral infections including cold sores (herpes simplex), chicken pox or shingles (Varicella zoster) or vaccinia; parasitic infestations such as scabies; acne vulgaris, acne rosacea and perioral dermatitis. Topical corticosteroids inhibit wound healing processes and are contraindicated in skin ulcers, cuts and abrasions. Eumovate is available as 30g tube.

Implanon NXT (Etonogestrel) is a subdermal contraceptive implant. Each implant contains 68 mg of

etonogestrel and is recommended to be removed and replaced every three vears to ensure continued contraceptive efficacy. It is contraindicated in known or suspected pregnancy; active thromboembolic disorders; presence or history of severe hepatic disease as long as liver function values have not returned to normal; known or suspected sex steroid sensitive malignancies; known or suspected carcinoma of the breast: benign or malignant liver tumours; undiagnosed vaginal bleeding. The pack contains one implant (4.0 cm in length and 2.0 mm in diameter) which is preloaded in the stainless steel needle of a ready-to-use, disposable sterile applicator. The applicator containing the implant is packed in a blister pack made of transparent polyethylene terephthalate glycol (PETG) sealed with a foil lidding.

Twynsta (Telmisartan and amlodipine besylate) combines two antihypertensive compounds with complementary mechanisms to control blood pressure in patients with essential hypertension. It is indicated for the treatment of hypertension. Treatment should not be initiated with this fixeddose combination. It is contraindicated in pregnancy; lactation; biliary

obstructive disorders; severe hepatic impairment and cardiogenic shock. Twynsta is available as 40/5 mg 40/10 mg 80/5 mg 80/10 mg tablets and is available on the PBS (restricted benefit) in blister packs containing 28 tablets.

Kuvan (sapropterin dihydrochloride) is indicated for the treatment of hyperphenylalaninemia (HPA) in sapropterin-responsive adult and paediatric patients with phenylketonuria (PKU) or tetrahydrobiopterin (BH4) deficiency. Treatment with KUVAN must be initiated and supervised by a physician experienced in the treatment of PKU and BH4 deficiency. It is provided as a 100 mg soluble tablet and comes in a pack size of 30 tablets.

NEW INDICATIONS

Tykerb in combination with an aromatase inhibitor, is indicated for the treatment of postmenopausal women with hormone receptor-positive metastatic breast cancer whose tumours overexpress HER2 (ErbB2) and for whom hormonal therapy is indicated. The recommended dose of Tykerb in the treatment of HER2+ overexpressing metastatic breast cancer is 1250 mg

once daily continuously when taken in combination with capecitabine.

Abilify is indicated in the acute treatment of manic or mixed episodes associated with Bipolar I Disorder in adults as monotherapy and in combination with lithium or valproate and for the maintenance treatment of manic or mixed episodes in Bipolar I Disorder in adults as monotherapy.

Crestor is indicated for prevention of major cardiovascular events in men \geq 50 years old and women \geq 60 years old with no clinically evident cardiovascular disease but with at least two conventional risk factors for cardiovascular disease (hypertension, low HDL-C, smoking, or a family history of premature coronary heart disease). The recommended dose for this indication is 20 mg once daily. Crestor is also contraindicated in patients with active liver disease including unexplained, persistent elevations of serum transaminases and any serum transaminase elevation exceeding 3 x the upper limit of normal (ULN).

Neupro is indicated for the symptomatic treatment of moderate to severe idiopathic Restless Legs

Syndrome in adults. A single daily dose should be initiated at 1 mg/24 hours. Depending on the individual patient response, the dose may be increased in weekly increments of 1 ma/24 hours to a maximum dose of 3 mg/24 hours. The need for treatment continuation should be reconsidered every 6 months for riskbenefit analysis.

SAFETY RELATED CHANGES Motilium is now contraindicated in patients with moderate or severe hepatic impairment.

Velcade should be started at a reduced dose in patients with moderate or severe hepatic impairment.

Dosing recommendations for Xeloda as a combination therapy have been added - see full PI for details.

Premia should be used with caution in angioedema, exogenous oestrogens may induce or exacerbate symptoms of angioedema, particularly in women with hereditary angioedema.
