Energy drink abuse alert

ENERGY drinks such as Red Bull, V and Mother pose a significant public health risk and should have more regulation and compulsory warning labels, according to a report in this month's Medical Journal of Australia.

Authors include pharmacist Jared Brown, who's a Senior Poisons Specialist at the NSW Poisons Information Centre (NSWPIC), along with Naren Gunja, **Clinical Senior Lecturer in Emergency** Medicine at Sydney University.

They analysed calls made to the NSWPIC over the last seven years, and found that the increasing availability of the energy drinks had coincided with a significant rise in caffeine overdoses.

In 2004 callers to the centre in relation to energy drinks numbered just 12, with this figure soaring more than fivefold over the next few years to 65 in 2010. At least 128 of the patients

yesterday announced draft guidelines for the Telehealth Pilot Program, which will open for applications in Feb or Mar this year.

The National Broadband Network will provide the communications backbone for the scheme which will provide eligible participants in "NBN early rollout areas" a range of services such as having health indicators monitored remotely, or receiving medical consultations and healthy living support in the home.

"Expanding telehealth services to older Australians still living in their own homes will help health professionals identify potential health problems earlier, reduce the need for older Austalians to travel to receive treatment and increase access to healthcare services and specialists," she said.

Plibersek said that about 1200 clinicians had undertaken more than 7000 telehealth consultations to rural and remote areas over the last six months, since the govt introduced Medicare rebates for online health services.

UK pharmacist fined

A PHARMACIST in Great Britain has received the dubious honour of being the first to be prosecuted under new regulations governing practising while banned.

Mark Taylor was taken to court by the General Pharmaceutical Council - which was officially formed as the new governing body for pharmacy in the UK in 2010 - after being found to be working while under a suspension.

The committee had previously banned the pharmacist after he was accused of accessing controlled drugs in a London dispensary while off duty, as well as abusing a female colleague.

Taylor did not appear at the hearing and was found guilty in his absence, with the committee saying he had shown a "flagrant disregard for the reputation of the profession".

But shortly thereafter he was discovered during a routine audit to be working at another pharmacy and was taken to court for breaching his suspension.

Last week he was fined £1750 plus court costs and now remains suspended from the register. THE developer of one of the most widely used software packages for Australian doctors has announced the integration of Health Identifiers which will see the system comply with the National eHealth strategy.

Health Communication Network which also provides the AusDI Advanced online reference system for pharmacists - says the three key components will see the Health Identifiers introduced in Medical Director and PracSoft, while Clinical Document Architecture handling has been added to discharge summaries and specialist letters in Medical Director.

"This is a strong indicator of HCN's commitment to the National eHealth strategry with regard to improving clinical outcomes at the point of care," the company said.

The move means that more than 5700 medical practices across the country can now start using Health Identifiers.
