Pharmacist numbers up 2.3%

THERE are now more than 26,500 pharmacists across Australia, with the net overall number of registrations rising 2.3% over the last 12 months.

That equates to growth of 259 additional pharmacists, according to the second annual report of the Australian Health Practitioners Regulation Agency which was released yesterday.

AHPRA ceo Martin Fletcher said the report showed the scope of the organisation's work, with one in every 39 Australians being a registered health practitioner.

The report details areas of focus for the Pharmacy Board of Australia, including the ongoing review of the extemporaneous dispensing (compounding) guideline which is expected to be extended to address complex compounding and minimum training requirements.

There's also the review of accreditation standards for pharmacy programs, while priorities for the coming year also include the ongoing participation in the audit of pharmacists against registration standards.

The second year of operation of the National Law has also enabled a more comprehensive picture of notifications and outcomes across the country, with more than 360 pharmacist notifications received during the year - 211 about conduct, 14 over health and 151 relating to performance.

In the case of "immediate action cases" during 2011/12, one pharmacist was suspended, eight had conditions imposed and undertakings were accepted from three pharmacists.

Financial data included in the report indicates that the Pharmacy Board of Australia had registrant fees amounting to \$8.39 million along with examinations income of \$653,000 for the year.

New MRI availability

AN additional 191 Medicareeligible MRI services became available from yesterday - 161 in metropolitan locations and 30 in regional towns - with the \$104.4m funding expansion aiming to make it easier for patients to get affordable scans close to home.

Another compounding recall in the US

THE US FDA has announced a voluntary recall of all products made by a compounding pharmacy firm called Ameridose, based in Westborough, Massachusetts.

The move follows an inspection of the company's manufacturing area, with the FDA's preliminary findings having raised concern about "a lack of sterility assurance" for items produced at the facility.

Ameridose shares common management with New England Compounding Pharmacy, which was recently linked to an outbreak of fungal meningitis (*PD* 10 Oct).

However unlike NECP, the Ameridose recall is not based on reports of patients who have contracted infections as a result of using the products.

New Lantus guidance released

SANOFI has welcomed new guidance published by the Australian Diabetes Society (ADS) on the safety of insulin glargine (Lantus), which the company says has finally closed the books on any link between the drug and cancer.

The new position statement says "ADS believes that the current data do not support a relationship between the use of insulin glargine and malignancy."

It adds that patients with diabetes taking insulin glargine (Lantus) do not need to change their insulin therapy, and glargine therapy can be initiated without concerns that it will increase the risk of developing cancer.

In particular ADS says there is no increase in breast cancer rates, with Sanofi acting medical director, Dr Tal Rapke, saying the updated statment helps bring clarity to patients and doctors on the appropriateness of insulin glargine as a treatment for diabetes.

The ADS announcement follows a large-scale epidemiological program conducted by independent researchers in northern Europe as well as in California and the University of North Carolina in the USA, which found there was no increased risk of cancer in people with diabetes treated with Lantus compared to those treated with other insulins.

No PBS changes this month

USUALLY the start of a new month marks a number of changes to the Pharmaceutical Benefits Scheme, with the addition and deletion of various items.

However this month is different, with no alterations to the PBS in November because of a major transformation of the information management systems used by the Department of Health and Ageing's Pharmaceutical Benefits Division.

The new system is called PharmCIS (Pharmaceutical Consolidated Information System) and the cutover is currently under way meaning the next schedule update will be on 01 December.

The department said PharmCIS would deliver "two key changes that will support E-health initiatives now and into the future".

These include the introduction of Australian Medicines Terminology (AMT) into the published PBS schedule and its underpinning data. The National E-Health Transition Authority has been assisting the Pharmaceutical Benefits Division with implementation of the AMT and alignment with the current PBS schedule, and from next month it will include AMT identifiers and preferred term descriptions.

In particular it will use the Medicinal Product Pack as the standardised descriptor of dosage form and strength, resulting in the consistent depiction of pack size.

The introduction of PharmCIS also provides an opportunity to structure the indication information contained in restrictions, including authority required and authority required streamlined items.

The aim is for a uniform structure to simplify the development of medical software, with this change to be progressively rolled out.

New sunscreen standard

A NEW standard for sunscreens will come into effect from 10 Nov, after an update of the Australian/ New Zealand Standard 2604 Sunscreen products - Evaluation and Classification.

The new version, produced by Standards Australia and Standards New Zealand, is AS/NZS 2604:2012, superseding AS/NZS 2604:1998.

The TGA says the Therapeutic Regulations 1990 have been amended accordingly, meaning that from Saturday week new sunscreen products listed in the Australian Register of Therapeutic Goods will have to comply with the new standard.

However Regulation 49 allows products listed on the ARTG prior to 10 Nov to continue to comply with the 1998 standard.

The new standard was published in May this year, and sets out procedures for determining the performance of sunscreen products in terms of their protection factors.

It applies to products suitable for topical use to protect human skin from the adverse effects of UV rays, covering both the determination of the sun protection factor (SPF) and broad spectrum performance.

MS treatment update

CANCER drug alemtuzumab has shown effectiveness in the treatment of multiple sclerosis, according to a study published in The Lancet this month.

The trial, conducted by scientists at the University of Cambridge, say that the drug, normally used for the treatment of leukaemia, works with MS by eliminating compromised immune cells, forcing a new immune system to be "built from scratch".

The study contrasted the use of alemtuzumab with interferon beta-1a, and found the cancer treatment was about 50% more effective in preventing relapses.

The global backlash against disgraced cycling champion Lance Armstrong has seen a number of sanctions including being stripped of his Tour de France titles.

But things have gone further downhill for the drug cheat, after he was chosen as the latest celebrity to have his effigy burned during the upcoming Bonfire Night celebrations in the English town of Edenbridge.

Local residents have built a 10m-tall model of Armstrong, which will be set alight this weekend as part of the annual Guy Fawkes' night.

The effigy includes a sign saying 'For sale, racing bike, no longer required'.

A 27-year-old British man is attracting worldwide attention because of his quest to lick every cathedral in the UK.

Lawrence Edmonds is responding to a dare from a friend, who challenged him to complete the task within 2 years.

Edmonds apparently started his noble quest earlier this year at Norwich Cathedral and has now licked the walls of 60 out of the total of 64 cathedrals in Britain.

According to the UK Sun newspaper, he said that Lichfield Cathedral near Birmingham tasted best because the "reddened sandstone was beautifully warm on the tongue."

In contrast, Perth Cathedral was "a little gritty," he said.

A SUPERCOMPUTER developed by IBM is set to teach medical students at a university in Cleveland, Ohio.

The artificially-intelligent Watson gained fame when it beat human contestants on US game show Jeopardy last year, but will now be utilised to help the aspiring doctors to diagnose challenging cases.
