Paperless trial at St Stephen's

THE Department of Health has given special authorisation to St Stephen's Private Hospital to undertake a paperless prescribing, dispensing and claiming trial.

All medication transactions would be done electronically, with the government committing \$21.2m to fit out the hospital with the latest eHealth technology, the Department said.

Minister for Health Peter Dutton said the St Stephen's trial would be used to refine the hospital electronic medication chart, soon to be in widespread use in Australian hospitals.

The Australian Commission on Safety and Quality in Health Care is developing a standard medication chart for use in hospitals, with pilots in private hospitals due to start in March and in public hospitals in May, available nationally by May 2016 (PD 29 Jul). Expressions of interest for

Compounding fail

A TENNESSEE pharmacy has pleaded guilty to a misdemeanour criminal violation of the Federal Food, Drug, and Cosmetic Act.

The offence related to shipment of methylprednisolone acetate (MPA) that was adulterated because it contained microbial contamination, the US Food and Drug Administration (FDA) said.

The pharmacy recalled the batches and owner David Newbaker and company were ordered to pay a US\$25,000 fine, the FDA said. **CLICK HERE** for more.

St Stephen's would be the first hospital to participate in the final phase of the Commission's two phase trial, a transition to a completely paperless, fully digital prescribing, dispensing and claiming process, the spokeswoman said, due to be completed in 2017.

Both projects were part of the larger medcharts program managed by the Department.

They represented different components and stages in the trial, she said.

NZ cancer patient risk

MORE than 750 New Zealanders who die of cancer each year would have survived if they lived in Australia, according to a report presented at the World Cancer Congress.

Auckland University Professor Mark Elwood said over time mortality rates had dropped significantly in both countries but the gap of about 10% in outcomes for New Zealand cancer patients compared with those in Australia had not moved since a study by Otago University 12 years ago, believed to be due to specific issues

TGA ticks Vimizim

THE TGA has approved BioMarin's Vimizim (elosulfase alfa) for registration for the treatment of patients with the rare genetic condition mucopolysaccharidosis type IVA, also known as Morquio A syndrome, after the medication was reviewed under the orphan drug program, the company said.

ACCC assesses Warehouse complaint

THE Australian Competition and Consumer Commission (ACCC) is assessing whether Chemist Warehouse's alleged conduct contravenes Australian Consumer Law, after Pharmacy Guild Victoria president Anthony Tassone wrote to the Commission regarding the use of a 'normal price' and claimed savings on receipts (PD 18 Nov).



Pharmacist Employers must check registrations of staff

PHARMACISTS must have renewed their registration by 30 November. The Australian Health Practitioner Regulation Agency (AHPRA), on behalf of the Pharmacy Board of Australia, is sending registered practitioners a series of email and hard copy reminders to renew. Anyone who hasn't received a reminder to renew should phone AHPRA on 1300 419 495. Pharmacists whose application is received on time, or during the following one month late period, can continue practising while their application is processed.

Pharmacists who do not apply to renew their registration by 31 December 2014 will have lapsed registration. They will be removed from the Register of Pharmacists and will not be able to practise their profession in Australia.

As part of QCPP requirements, all QCPP accredited pharmacies must ensure each pharmacist who is employed or contracted by the pharmacy maintains registration with the Pharmacy Board of Australia. All pharmacists employers should check that your employee pharmacists have current professional registration.

PDSA boosts MM

A COLLABORATIVE qualityimprovement approach based on plan-do-study-act (PDSA) cycles can improve medication management (MM), a French teaching hospital-based study said.

With medication errors as the third leading cause of serious adverse events in France, the study, published in the International Journal of Clinical Pharmacy, demonstrated that this approach improved MM, medication reconciliation and hence reduced medication errors also, the study said.

Reliability concerns

SOME EU member states have decided to suspend the marketing authorisations of medicines that have been authorised on the basis of studies conducted at the GVK Biosciences site in Hyderabad, India, the European Medicines Agency (EMA) has said.

The EMA said it was currently reviewing findings of non compliance with good clinical practice at the site, following an inspection by the French medicines agency which "raised concerns about the reliability of studies conducted at the site between 2008 and 2014".

NZ Ebola response

EIGHTY two New Zealanders have registered interest in joining the mission to Sierra Leone to operate a 100-bed Ebola treatment centre, towards which the Australian government is contributing \$20m and the staff of which would include Australian volunteers (PD 06 Nov).

Pharmacy Today reported that this included four pharmacists.

NZ Health Minister Dr Jonathan Coleman said 24 Kiwis would be deployed, with Aspen Medical contracted to select, train and deploy the volunteers by the Australian government.

The first deployment would take place next year, he said.

Industry action - MA

MEDICINES Australia (MA) ceo Tim James has affirmed the pharmaceutical industry's commitment to the WHO Global Action plan on non-communicable diseases and access to cancer medicines.

James was presenting to the World Cancer Congress on behalf of the International Federation of Pharmaceutical Manufacturers and Associations (IFPMA) and championing the Association's new publication Enhancing Access To Cancer Care.
