#### **General Assembly** push gathers steam

SUPPORT for a "clarion" call for consolidated pharmacy conferences is gathering steam.

Community pharmacist Patrick Reid has called on the industry to discuss consolidating pharmacy conferences into a Pharmacy General Assembly held in September, saying currently only a few conferences turned a profit.

"I propose we de-clutter the calendar and provide breathing space for all – elevating the quality of conference content, delivering a Return On Investment for attendees and sponsors while maintaining a unity of purpose that transcends politics."

Pharmaceutical Society of Australia ceo Dr Lance Emerson said he was "up for a discussion" with other organisations.

Australian Association of Consultant Pharmacy ceo Grant Martin said it was an interesting idea worth having a conversation about, as small to medium conferences were struggling to make up numbers given financial pressures the sector faced.

Guild NSW branch president Paul Sinclair said he supported the idea. with many smaller conferences competing with each other for corporate support.

Expenses could be dramatically reduced if five or six conferences shared staging costs by presenting at the same time at a common venue under the larger umbrella of an event such as a General Assembly, he said.

# Osteo may affect more

THE Australian Institute of Health and Welfare (AIHW) has said osteoporosis prevalence could be higher than reported.

In 2011-12, the estimated prevalence of self-reported diagnosed osteoporosis was 15% of women and 3% of men aged over 50 years, according to the Australian Health Survey, the AIHW report found.

Based on a recent bone density study, the prevalence was estimated to be 23% of women and 6% of men over 50, for both diagnosed and undiagnosed cases, the report found.

Because osteoporosis was a 'silent' condition, with no obvious symptoms, it often went undiagnosed until a fracture occurred and so it was difficult

THE UK's National Institute for Health and Care Excellence (NICE) has published a guide recommending prescriptions carry information on drugs that known drug allergy patients should avoid.

Drugs often associated with allergies include antibiotics, general anaesthesia, and painkillers such as aspirins and ibuprofen.

to determine the actual number of those affected, spokesperson Louise York said.

Osteoporosis ceo Gail Morgan said pharmacists played an important role as frontline healthcare professionals and could talk to patients in the pharmacy about risk factors, ask patients who had broken bones recently about bone density tests and check with patients over 50, particularly women, if they were getting enough exercise, dairy servings and more.

Government should take note of the cost to healthcare of the condition, she said.

#### MA reply to RACGP

MEDICINES Australia (MA) has responded to Royal Australian College of General Practitioners (RACGP) challenges around its 18th Code of Conduct, maintaining that very strong standards of transparency are being upheld.

In an additional submission, MA said the RACGP comments related to misunderstandings of the document.

A number of submissions to the ACCC referenced 'lavish meals' or 'entertainment' neither of which were allowed with meals at capped prices and no entertainment possible at all under the "existing rigorous provisions in the code", the result of extensive consultation with the Transparency Working Group, MA said.

#### Sinclair's FIP election

PHARMACY Guild NSW branch president Paul Sinclair has been elected president of the Community Pharmacy Section of the International Pharmaceutical Federation (FIP).

Guild acting national president Tim Logan said Sinclair dealt on a day to day basis with community pharmacy owners across a range of issues and had a "strong appreciation" at grassroots level of the issues facing the sector.

#### SPD prices confirmed

THE October price disclosure prices have been confirmed, and now include price to pharmacy for pack size, or price including wholesaler mark-up where applicable, figures.

The prices, which take effect as of 01 Oct, were released by the Department of Health (PD breaking news yesterday) and confirm drops of more than 50% for some drugs (**PD** 20 Jun).

These include atorvastatin, which would drop from \$13.72 to \$7.42 for the 20mg tablet, with a price to pharmacy of \$7.98.

Alzheimer's Disease treatment donepezil (tablet containing donepezil hydrochloride 10mg), will see a percentage difference of 58.13%, dropping to \$26.59, with a price to pharmacy of \$28.59.

Irbesartan (tablet 150mg) will drop to \$4.75 and see a price to pharmacy of \$5.11 while cholesterol medication rosuvastatin (tablet 40mg) will drop to \$39.33 and a price to pharmacy of \$42.29.

# Scopes of practice

THE Canadian Academy of Health Sciences (CAHS) has said six principal parties should work together to optimise scopes of practice to achieve a transformed health care system.

In an assessment, the CAHS said the scopes of practice of some health care professionals, including pharmacists, had expanded but in some cases, this had occurred without understanding of how this would fit into existing service delivery models or impact on existing scopes of practice.

"Beyond extending scopes of practice for some health care professions, optimisation of existing scopes of practice must be determined in alignment with the models of care in which they function."

Debate has been called for in Australia recently around expanding the role of pharmacists (PD 04 Sep).

The report recommended that six parties, including Federal and provincial governments, regulatory colleges and accrediting bodies, work together to optimise scopes

of practice to enable collaborative responsibility for shared care.

"This strategy will ensure that the right provider gives the best care, and the health care team or institution is accountable for assigning appropriate and optimal scopes of practice within a regulated structure."

#### **Authority review**

THE regulatory burden imposed by the Authority Required PBS listings model has been identified by review submissions.

Roche said the burden of completion of complex forms either took away consultation time or was delegated to someone with less familiarity with patient history.

AstraZeneca similarly identified the "regulatory and administrative burden for prescribers and dispensers of medicines".

Arthritis Australia and the Australian Rheumatology Association also highlighted the administrative burden.
