#### Managing vaccine anaphylaxis in store

**VACCINATION** in pharmacies has been safe, effective and successful in increasing coverage in a number of countries, but pharmacists will need to learn how to manage anaphylactic shock from vaccination, according to researcher Mary Bushell and her Charles Darwin University colleague Professor Patrick Ball.

The researchers have published in the latest issue of the Journal of Pharmacy Practice and Research with specific training recommendations around screening for risk of anaphylaxis, managing anaphylactic shock and other legal and medical procedures to follow.

## Labor: make CPA neg public

MINISTER for Health Sussan Lev should commit to making the full details of her Sixth Community Pharmacy Agreement (6CPA) negotiations public, Shadow Minister for Health Catherine King has said.

Ley said Labor needed to answer "serious questions" about the \$15b Fifth Agreement, following the Australian National Audit Office report which identified "persistent shortcomings in departmental record-keeping" related to the administration of the agreement (PD 06 Mar).

Minister Ley said she was "deeply concerned" by the findings, which went to the "core" of the agreement and its management, and would consider the report closely as part of negotiations for the 6CPA, SMH reported.

King said given Ley's "strong words", Labor looked forward to the Minister implementing the report's findings, including making details of negotiations public and publishing detailed financial costing of "every aspect" of the Agreement.

King said the report showed the former government made "significant savings" in the 5CPA.

Estimated savings from the 5CPA initiatives were around \$0.4b rather than the \$0.6b estimated in the 2010-11 Budget papers (PD 06 Mar).

Australian Greens health spokesperson Dr Richard Di Natale said the report showed a need for a new process of negotiation, calling the agreement "devastatingly

The party called for a public inquiry into the previous negotiation and development of a "new approach.

"We cannot allow the next fiveyear agreement to be determined by the same process of closed door negotiations between the Department of Health and the Pharmacy Guild.

"Neither the parliament or the community have any reason to place our trust in that process given the findings of the audit."

#### Methadone program regulation review call

AN AMENDMENT to the Victorian policy for Maintenance Pharmacotherapy for Opioid Dependence has been recommended after an inquest.

In the Coroner's report for Phillip Black, who died from combined methadone, diazepam, and clonazepam toxicity, Coroner Paresa Spanos recommended the Royal Australasian College of General Practitioners remind its members who prescribed methadone to regularly review the National **Clinical Guidelines and Procedures** for the use of methadone in the Maintenance Treatment of Opioid Dependence, and that the Maintenance Pharmacotherapy policy be amended to include mandatory compliance with the guidelines by prescribers as well as ongoing training and audit. #### **Review FDA** accelerated approval

**THE** Breast Cancer Network Australia has recommended a review of the US Food and Drug Administration's (FDA) Accelerated Approvals Program as a possible model for Australia, to ensure early access to important new cancer drugs.

In its submission to the Senate Standing Committee inquiry on the availability of new, innovative and specialist cancer drugs in Australia, the organisation cited the example of the FDA's approval of pertuzumab in six months under the priority program.

#### **DUSC:** high gliptin use 'concerning'

THE Drug Utilisation Sub-Committee (DUSC) has said the apparent high use of a gliptin with metformin in lieu of a sulfonylurea with metformin is "concerning".

Analyses from the October 2012 and February 2013 meetings of the Committee found that 49% of all patients starting on gliptin therapy had not taken metformin and a sulfonylurea in the two year period prior.

This increased to 55% for patients starting on a gliptin and metformin for a fixed dose combination product, the Committee said.

This apparent high use of a gliptin with metformin in lieu of a sulfonylurea with metformin was "concerning.

"Gliptins cost a lot more than sulfonylureas and are not PBS listed as an alternative to those drugs unless there is a contraindication or intolerance.

"The prevalence of true intolerance to sulfonylureas is low.

"Use outside the criteria for subsidisation is occurring more frequently with Fixed Dose Combination products."

SNIFF out that thyroid.

Dogs are not only illicit drug sniffers but also cancer detectors, apparently.

With an olfactory system that has 10 times the sensitivity of a human's, a trained dog has learnt to use its sense of smell to detect thyroid cancer in patients not yet diagnosed, according to an article in BBC News.

The canine thyroid cancer sleuth was successful in 30 out of 34 cases including two patients who would otherwise have been falsely given the all clear, the article said.

The animal detects a subtle change in hormone levels and while the use of dogs would be impractical as a diagnostic tool, mimicking the dog's olfactory system sensitivity may lead to a 'mechanical nose' that can detect these changes, University of Arkansas for Medical Sciences researchers told the publication.

Dogs had already been used to detect the presence of lung and bowel cancer or infections, the report said.

#### **COSMETIC** ephedrine?

If you noticed anyone buying a whole heap of hair and talcum powder products in your pharmacy recently, mystery solved.

Sydney Airport Australian **Customs and Border Protection** Service officers seized approximately 10 kgs of ephedrine concealed in cosmetic products on Wednesday.

A 28 year old Vietnamese traveller's baggage held 18 containers of hair and talcum powder products, some of which tested positive for ephedrine, Customs reported.


