



**CREDENTIALLED** Diabetes

Educators are well placed to assist GPs as part of PM Turnbull's 'Health Care Homes' package, according to the Australian Diabetes Educators Association (ADEA) in a statement.

ADEA president Tracy Aylen, says that while the organisation would like to see more detail first, "ADEA is very supportive of this trial and believes it will be very beneficial for people with diabetes to receive coordinated care from GPs and practice nurses, who could work collaboratively with specialist Credentialled Diabetes Educators".

Statistics from Deloitte Access Economics 2014 show that Australian healthcare cost savings in 2014 would have totalled \$3.9 billion and thousands of lives would have improved if diabetes education programs were made available to all 1.37 million Australians with diabetes, Aylen highlighted.

AUSTRALIAN vitamins group Swisse Wellness has declared a \$49m profit for its first three months under the ownership of Biostime International, propelling Many of these patients are reliant the brand to pole position in manage their conditions, Tambassis healthcare on the two large Chinese online sites of Tmall and Taobao according to Fairfax media.

The results are now being made public for the first time as a result of being part of Hong Kong stock exchange listed company Biostime.

For the three months to end Dec 2015 Swisse contributed revenue of 838.1 million yuan or approximately AU\$169m.

If that result was extrapolated to a full year's business it would challenge the result of ASX-listed Blackmores, stated for the six months ended Dec 2015 as \$342m, up 66% with net profit tripled to \$48.3m (PD 25 Feb).

EBOS ceo Patrick Davies says he is confident of delivering another year of double-digit profit growth for shareholders in 2016, with the company's half yearly report released this week indicating "sound performances" across both its healthcare and animal care operations.

Davies said the half year result (PD 24 Feb) saw solid wholesale revenue growth in the Australian pharmacy market for EBOS, assisted by "increased levels of activity, particularly in the non-prescription channel".

He said the first half group results with revenue of \$3.4b, up 8.3%, also reflected the benefits of acquisitions and investments undertaken in previous periods, which have now cycled through a full 12 months of ownership.

Pharmacy wholesaling comprised 44% of the company's total operational revenue, while the group's retail pharmacy amounted to 6% of the total.

Earnings before income tax, depreciation and amortisation for the healthcare business increased 12.7% with strong growth in both Australian and New Zealand

operations.

**EBOS confident of future** 

Australian operations reflected convincing performances across pharmacy, institutional healthcare and contract logistics Davies said.

Non-prescription business activity dominated the growth of wholesaling revenue, he added, with the company's Onelink Australia business profiling the firm's operational capacity as well as the expertise of staff and supporting infrastructure.

**RESEARCHERS** have some bad news for Chewbacca.

A study in Japan of the effects of space travel on the activity of genes in the hair follicles of astronauts has found hair growth can halt in space.

MEANWHILE, in the Chinese city of Guangzhou, narcotics officials have recruited "dancing grannies" in their fight against drugs.

The so-called "damas" - known for showing off their routines to music in public spaces - are groups of mainly middle age and retired women.

More than 100 damas have been recruited and have been busy going door-to-door handing out flyers, and have also taken part in a special gala aimed at educating people about the dangers of drugs.

The women are chosen for the job as they're more familiar with their local area than the police teams and can quickly identify unusual visitors in the neighbourhood and alert police.

IN GUAYAMA, on the Caribbean coast of Puerto Rico, a patient stole an ambulance on the way to the hospital for psychiatric care and crashed into 15 cars.

The patient, Jaime Rodriguez Figueroa, was arrested after he hit two paramedics and took over the ambulance while accompanied by his mother and aunt.

Police said Rodriguez caused a huge traffic jam on one of the island's main highways after crashing into multiple cars.

No one was injured from the incident, which occurred late Sun.
