## MyHealth Record app

**CONSUMERS** who have registered for My Health Record (MyHR) can now access and view their data on mobile devices with the soft launch of the Healthi app, reports Pulse+IT.

The new offering is the first authorised consumer app to link into the national system since the My Child's eHealth Record app was released back in 2013.

Developed by Adelaide-based IT consulting firm Chamonix, Healthi accesses data through MyGov.

## US psoriasis drug OK

THE US Food and Drug Administration has announced the approval of Valeant Pharmaceuticals' Siliq (brodalumab) injection for the treatment of adults with moderate-to-severe plaque psoriasis.

Brodalumab binds to a protein that causes inflammation, inhibiting the inflammatory response that plays a role in the development of the condition.

Under the authorisation, patients must sign a Patient-Prescriber Agreement Form because of an observed risk of suicidal ideation and behaviour associated with the medication.

In addition, pharmacies must be certified with the program and must only dispense to patients who are authorised to receive Silig.



of cannabis for their patient groups include Liz Callaghan (Palliative Care Australia), Carol Ireland (Epilepsy Action Australia) and Professor Helen Zorbas (Cancer Australia).

Other members of the council have expertise in palliative care and pain, while there are also representatives of the Australian Federal Police and the NSW Department of Primary Industry.

The Health Department said "the medicinal cannabis scheme allows for the safe cultivation and manufacture of medicinal cannabis products that will be safe to use and have standardised dosing [to] benefit adults and children suffering from painful and chronic conditions".

# **Qld dispensing catchup**

**RECENT** changes to Queensland legislation mean that community pharmacies across Australia can now ensure the continued supply of some medicines to patients, according to an article in the latest Pharmacy Guild *Forefront*.

The adjustments to legislation in Queensland bring the state into line with the rest of the country under the Continued Dispensing of PBS Medicines in Defined Circumstances arrangements.

At this stage Continued Dispensing applies only to statins and oral contraceptives, allowing the continued supply of a single full pack (maximum PBS quantity).

The legislation provides for pharmacists to continue supply when "it is not practicable to obtain

The Guild said it believed Continued Dispensing could be extended to other medicines used for chronic health conditions, such as for cardiovascular disease, diabetes, asthma and mental health so that patients who meet the conditions can receive a full pack of their medicine as a PBS benefit, without the added stress of needing to see their GP within a few days to ensure ongoing treatment with that medicine.

The cost to the Federal Government was "negligible", the Guild said, and would address barriers to improved adherence. Expansion of the scheme would also be of great value in times of catastrophe such as floods, fires and cyclones to ensure patients had

ongoing supply. CLICK HERE for more details.

## **PBS pause in March**

**THE** Health Department has confirmed its intention to "pause" the Schedule of Pharmaceutical Benefits next month, as part of a major system upgrade.

Because of this the full set of files and outputs will not be produced for the Mar 2017 schedule, with the current schedule to remain effective until the Apr 2017 schedule is published.

## SAS consultation

**THE** Therapeutic Goods Administration (TGA) has launched a new consultation about proposed changes to accessing unapproved therapeutic goods via the Authorised Prescriber (AP) and Special Access Schemes (SAS).

Another initiative resulting from the government's response to the Review of Medicines and Medical Devices Regulation, the TGA is proposing the development of an online system to improve the pathways for access to unapproved therapeutic goods, which includes allowing applicants to enter information directly into the system.

An analysis of Authorised Prescriber applications shows that less than 1% were rejected, and those rejections arose because there was an alternative product included in the ARTG.

Of 20,000 Special Access Scheme category B (non-life-threatening) applications received annually just 0.3% were rejected - but despite this there was a high administrative burden for applicants and the TGA.

"The percentage of rejections identifies that a significant number of therapeutic goods currently used under the SAS B do not appear to pose an issue for public health and safety," the consultation document states.

Accordingly the TGA proposes to enable access to certain unapproved therapeutic goods via a notification process - rather than the current approval process.

Feedback on the proposals is sought, with a deadline for responses of 29 Mar 2017. See tga.gov.au.

## **Beauty Prescription success**

ONLY in America.

A shortage of drugs used for executions carried out by lethal injection has led to a "bring your own" plan in Arizona.

A newly issued death row protocol states that lawyers for condemned inmates are invited to provide the drugs themselves.

"The inmate's counsel... may provide the department with pentobarbital or sodium pentothal if they can obtain it from a certified or licensed pharmacist, pharmacy, compound pharmacy, manufacturer or supplier," the protocol reads.

Lundbeck banned the use of pentobarbitol in executions in 2011, while an attempt by Arizona to illegally import sodium pentothal from India in 2015 was blocked by customs officials in Phoenix, reports The Guardian.



**AND** probably in the same category, authorities on the US/ Mexico border have dismantled a massive catapult which they believe was used to fling packages of drugs to smugglers.

The contraption was discovered by officers who saw some people running away from a border fence as they approached.

Searching the area revealed two large bundles of marijuana which had been hurled across from Mexico using the giant springloaded device.
