Ice abuse trend

WHILE recent abuse of methamphetamines has fallen, there is a continuing trend toward 'ice' rather than other forms, such a powder, according to a new report from the Australian Institute of Health and Welfare (AIHW).

The report presents first results from the 2016 National Drug Strategy Household Survey, including information on nearly 24,000 Australians' use of, and attitudes toward, tobacco, alcohol and illicit drugs, with encouraging results around the proportion of non-smoker Australians.

The report said that in 2016, 57% of methamphetamine users were mainly using ice, up from 22% in 2010.

"Overall, the most common recently used drugs were cannabis (10%), misuse of pharmaceuticals (5%), cocaine (3%), and ecstasy (2%)," AIHW spokesperson Matthew James said.

"Other drugs, including ecstasy and cocaine, had a higher number of recent users than methamphetamines," James said.

"Australians are, overall, less concerned about the impact of cannabis, heroin and cocaine than in the past," he added.

Stemetil recall

SANOFI-AVENTIS Australia, in consultation with the Therapeutic Goods Administration (TGA), is recalling one batch of Stemetil (prochlorperazine maleate) 5 mg tablets (batch number 16N0060, expiry date 06/2018).

It appears that the product may have suffered tampering with a missing blister sheet and supply may be affected for 3-4 weeks.

There are no issues with the quality, safety or efficacy of Stemetil tablets from the batch involved and no other batches are included in this recall, the TGA said. Packs from this batch may be returned to the wholesaler. Any concerns, ring 1800 152 416.

SUSMP #17 posted

THE Jun edition (#17) of the Standard for the Uniform Scheduling of Medicines and Poisons (SUSMP) incorporates numerous changes to the Poisons Standard Feb 2017.

Among the more obvious changes are those related to international harmonisation to standard spelling of drugs such as "ph" to "f" as in "alfa" and "th" to "t" as in "metamfetamine".

Pharmacist fatigue

PHARMACISTS and pharmacy technicians in Minnesota will no longer be able to work more than a 12 hour shift under a new law intended to reduce the errors resulting from fatigue, according to a report in Drug Topics.

The new ruling, which takes effect 01 Jul, also demands that pharmacists be given "reasonable time" for breaks.

If they work more than six hours, they are entitled to a 30-minute, uninterrupted break.

In addition, pharmacy personnel are allowed "reasonable time" to use the restroom every four hours.

Minnesota pharmacists came under fire after a Fox TV report found that errors at Minnesota pharmacies were on the increase.

The report referred to a case in which a customer suffered a stroke after a pharmacy gave the customer the wrong prescription.

"We are concerned that pharmacies are being asked to do more work and that the prescription volumes are increasing," said Cody Wiberg, PharmD, executive director of the Minnesota Board of Pharmacy.

"Even the best of pharmacists, if you put them in the environment where there are hundreds of prescriptions to fill ... and they are working twelve hours without a break, [mistakes can occur]."

According to the new law, Minnesota pharmacies with only one pharmacist on duty may stay open while the pharmacist is on a break, but cannot dispense prescriptions while the pharmacist is absent.

HEALTH Minister Greg Hunt yesterday announced nine appointments to the Pharmaceutical Benefits Advisory Committee, in the process increasing the total PBAC membership to 19.

The nine additions include five new appointments and four reappointments, with Hunt saying expanding the committee would give it greater capacity to deal with a "growing number of increasingly complex submissions".

NZ cannabis scripts

NEW Zealand medicines regulatory body Medsafe has provided guidance for prescribers on writing cannabis products, emphasising that an application to the Ministry of Health is required in most cases and a specialist prescriber needs to be involved in the application process.

The details are part of the latest Medsafe Prescriber Update which also references Quetiapine, Levetiracetam, fluoride in toothpaste, dopamine agonists, mitochondrial disorders, blood glucose control products and recent safety communications.

Community pharmacist David Newby was reappointed to the PBAC along with consumer nominee Jo Watson, general practitioner Rashmi Sharma, and clinical pharmacologist Christopher Etherton-Beer.

In May 2015 the government committed to increasing PBAC membership to 21 under the PBS Access and Sustainability package of reforms, with further appointments set to be named.

The package also created the PBAC Executive which is now in operation to "triage" applications to improve the capacity, efficiency, flexibility and operations of the Committee, Hunt said.

The Executive includes the chairs of the PBAC and its supporting subcommittees along with a consumer nominee, and "demonstrates the Australian government's commitment to streamline the committee's processes to improve patient access to important treatments on the PBS," he added.
