AZ direct supply backdown

Special Access Scheme online system

THE Therapeutic Goods Administration has released details of its new online system to enable the electronic submission of Special Access Scheme (SAS) applications and notifications to the TGA.

This month the system was updated to allow the submission of Authorised Prescriber applications, with the system aiming to reduce the adminstrative burden on health practitioners.

While lodgement of SAS and AP applications and notifications via the online system is not mandatory, it is the preferred method of submission, with the TGA aiming to move the submission of all SAS and AP requests online by 01 Jul 2019.

The TGA noted that in certain circumstances the SAS online system should not be used for medicinal cannabis submissions.

Such situations include where the prescriber of the unapproved therapeutic good is not a medical practitioner, or where the prescriber is in possession of a current TGA approval and the notification/application only relates to a particular state or territory.

Medical practitioners actually prescribing the medicinal cannabis product must make the submission via the system - tga.gov.au.

ASTRAZENECA (AZ) has announced a transition away from its current exclusive direct supply arrangements for 14 high-cost medicines (PD 31

Oct 2017), with the full range of products to become available both through current provider DHL and the key pharmaceutical wholesalers from 01 Feb 2019 (PD breaking news

yesterday).

The change means AstraZeneca's controversial direct supply model will have only lasted for just over twelve months, and during a transition period which started yesterday the full range of AZ medications will be available from DHL, while transitional arrangements with the other wholesalers are finalised.

AZ Country President, Liz Chatwin, said the move follows feedback received following last year's decision to make particular items available directly, and exclusively, to pharmacy via DHL.

"Community pharmacy and wholesalers asked us for choice and access to all of our medicines.

"We are confident that our new model will provide this, it will be competitive, and deliver for patients," Chatwin said.

"It won't cherry-pick and there will be no exclusive distribution," she added.

The announcement came just



direct supply by not allowing any CSO payments in relation to items which are subject to exclusive arrangements.

AstraZeneca will partner with Arrow Pharmaceuticals during the transition to support pharmacists, and

also confirmed that the 14 exclusive supply medications would return to wholesalers, meaning the full range of 77 items is available through the normal distribution chain.

Chatwin said the company was committed to rolling out the new model as fast as possible, bearing in mind the busy Christmas and New Year period coming up.

"Our transition to our new distribution model is a process that we want to get right by working with all relevant stakeholders," she said. with the 01 Feb deadline set to give wholesalers the access they have asked for "in a timeframe we can deliver on".

Pharmacy Guild National President George Tambassis thanked AstraZeneca for addressing concerns about direct supply.

"Our members will now have choice, which we welcome, to ensure patients have acces to these important medicines from multiple sources," Tambassis said.

PBS forms online

THE Department of Human Services has made new forms available online for pharmacists and customers to download.

The range includes "PBS/RPBS Safety Net prescription record form and application for a Safety Net Card" (PB240) which is used to help customers keep a record of how much they have spent on PBS medicines; "PBS Safety Net claim for payment" (PB241) used to make a claim for issuing customers with a PBS Safety Net Card; and "Approved supplier manual payment reconciliation" (PB242) for approved suppliers to use when manually claiming or reconciling a payment for supplying PBS items or highly specialised drugs.

Old paper forms in stock can be used until they run out.

Maxigesic study

A NEW large randomised trial just published in Clinical Therapeutics comparing a US formulation of Maxigesic to equivalent doses of paracetamol and ibuprofen shows that combined product provides significantly superior pain relief than either paracetamol or ibuprofen on their own.

The work, published in Clinical Therapeutics, showed Maxigesic also "reduced opioid rescue medication use and shortened time to meaningful pain relief".



Fasenra onto PBS

ASTRAZENECA has announced the Pharmaceutical Benefits Scheme listing of its Fasenra (benralizumab) for patients with severe eosiniphilic asthma who meet specific criteria.

Fasenra is a monoclonal antibody that works with the body's immune system to specifically target eosinophils, a particular type of white blood cell which are present in half of Australians with uncontrolled severe asthma.

It is administered by a healthcare professional as a subcutaneous injection every eight weeks, following initiation with three fourweekly doses.

Medlab to Europe

LISTED medical life sciences company Medlab Clinical Limited has launched a wholly owned subsidiary in the EU, with the aim of managing current and future dealings with its NanaBis and proposed drug registration models with the European Medicines Agency (EMA).

The newly incorporated MDC Europe will further the agenda advised during the company's recent annual general meeting, which detailed discussions with the EMA on the pathway for registration of NanaBis.

Conditional approval is likely, but registration with a significant fee reduction requires the company to be domiciled in Europe.

A rose by any other...

"A ROSE by any other name would smell as sweet", said William Shakespeare's Juliet, but a drug name pronounced differently may not, according to an editorial in this month's edition of *Australian Prescriber*, the official organ of NPS MedicineWise.

Former editor of *NPS RADAR* Craig Patterson highlights the challenges facing dispensers and clinicians trying to pronounce some new drugs such as xekizumab, rovalpituzumab, tofacitinib and idelalisib.

"The problem of lookalike and soundalike drug and brand names is well recognised, but there is an evidence gap regarding any impact that mispronunciation may have on patient safety," Patterson wrote.

Telephone orders between prescribers, clinical handovers, voice-recognition software and text-to-speech systems are all part of the problem - see the threeminute read at nps.org.au.

Omega-3 health

THE secret to healthy ageing may, in part, be linked to consuming an extra serving of fish each week, new research published in the *British Medical Journal* has reported this week.

Higher levels of long chain omega-3 fatty acids were associated with 18% lower risk of unhealthy ageing among older adults - visit bmj.com.

New Products

- Benralizumab (rch) (Fasenra) is a humanised monoclonal antibody selective for the alpha subunit of the human interleukin-5 receptor (IL-5Rα). The IL-5 receptor is specifically expressed on the surface of eosinophils and basophils. Benralizumab reduces eosinophilic inflammation through immune effector cell mediated apoptosis of eosinophils and basophils. Fasenra is indicated as add-on therapy in patients aged ≥ 12 years with severe eosinophilic asthma (blood eosinophil count ≥ 300 cells/microlitre or ≥ 150 cells/microlitre if on oral corticosteroid treatment). Fasenra should be prescribed by a healthcare professional in consultation with a specialist physician experienced in the diagnosis and treatment of severe asthma. Treatment with high dose inhaled corticosteroids and long-acting β-agonists should be optimised prior to commencement of treatment with Fasenra. Fasenra solution for subcutaneous injection prefilled syringe contains benralizumab 30 mg/1 mL and is available in a pack of 1.
- Ertugliflozin (pyroglutamic acid) (Steglatro) is a sodium-glucose co-transporter 2 (SGLT2) inhibitor. Steglatro is indicated as an adjunct to diet and exercise to improve glycaemic control in adults with type 2 diabetes mellitus: as monotherapy when metformin is considered inappropriate due to intolerance; in combination with other antihyperglycaemic agents. Steglatro is contraindicated in patients with chronic kidney disease (CKD) receiving dialysis; eGFR < 30 mL/min/1.73 m² or eGFR persistently < 45 mL/min/1.73 m² (CKD stage 3B, 4 and 5). The efficacy of Steglatro is dependent on renal function. Steglatro tablets contain ertugliflozin 5 mg or 15 mg in a pack size of 28.
- Ertugliflozin (pyroglutamic acid)/sitagliptin (phosphate monohydrate) (Steglujan) combines two antihyperglycaemic agents with complementary mechanisms of action to improve glycaemic control in patients with type 2 diabetes: ertugliflozin (a SGLT2 inhibitor) and sitagliptin (a dipeptidyl peptidase-4 [DPP-4] inhibitor). Steglujan is indicated as an adjunct to diet and exercise to improve glycaemic control in adults with type 2 diabetes mellitus when treatment with both ertugliflozin and sitagliptin is appropriate. Steglujan is contraindicated in patients with CKD receiving dialysis; eGFR < 30 mL/min/1.73 m² or eGFR persistently < 45 mL/min/1.73 m² (CKD stage 3B, 4 and 5). The efficacy of Steglujan is dependent on renal function. Steglujan tablets contain ertugliflozin 5 mg/sitagliptin 100 mg (Steglujan 5/100) or ertugliflozin 15 mg/sitagliptin 100 mg (Steglujan 15/100) in a pack size of 28.
- Migalastat (Galafold) is a pharmacological chaperone that selectively and reversibly binds with high affinity to the active sites of certain mutant (abnormally folded and unstable) forms of lysosomal enzyme α-galactosidase A (α-Gal A), stabilising the mutant enzymes. Mutations in the *GLA* gene result in a deficiency of α-Gal A in the lysosomal storage disorder Fabry disease. Galafold is indicated for long-term treatment of adults and adolescents ≥ 16 years with a confirmed diagnosis of Fabry disease (α-Gal A deficiency) and who have an amenable mutation. Galafold capsules contain migalastat 123 mg and are available in a pack size of 14.
- **Tenofovir alafenamide (fumarate) (Vemlidy)** is a phosphonamidate prodrug of tenofovir. Intracellular tenofovir is phosphorylated to the pharmacologically active metabolite tenofovir diphosphate. Tenofovir diphosphate inhibits hepatitis B virus (HBV) replication through incorporation into viral DNA by the HBV reverse transcriptase, which results in DNA chain termination. Tenofovir has antiviral activity specific to HBV and human immunodeficiency virus (HIV-1 and HIV-2). Vemlidy is indicated for the treatment of chronic hepatitis B in adults. Vemlidy tablets contain tenofovir alafenamide 25 mg and are available in a pack size of 30.

New Indications

- Cabozantinib ((S)-malate) (Cabometyx) is now indicated for the treatment of advanced renal cell carcinoma in treatment naïve adults with intermediate or poor risk.
- Lenvatinib (mesylate) (Lenvima) is now indicated for the first-line treatment of unresectable hepatocellular carcinoma.
- Pembrolizumab (Keytruda) is now indicated for the treatment of adult and paediatric patients with refractory primary mediastinal B-cell lymphoma, or who have relapsed after 2 or more prior lines of therapy. The approval of this indication is on the basis of objective response rate and duration of response from non-randomised studies.
- Quadrivalent influenza vaccine (split virion, inactivated) (Fluarix Tetra) is now indicated for active immunisation of children from 6 months of age for the prevention of influenza disease caused by the influenza virus types A and B contained in the vaccine.
- Venetoclax (Venclexta) in combination with rituximab is now indicated for the treatment of adults with chronic lymphocytic leukaemia who have received at least one prior therapy.

New Contraindications

- Pralatrexate (Folotyn) is now contraindicated in pregnancy.
- **Protamine sulfate (Fisons Protamine Sulfate Injection BP)** is now contraindicated with hypersensitivity to protamine (including protamine contained in insulin NPH [Neutral Protamine Hagedorn]).
- Tretinoin (ReTrieve Cream, Stieva-A) is now contraindicated in pregnancy and women planning a pregnancy.
