## **Apotex recalls** valsartan medications

APOTEX has announced the recall of four strengths of its APO-Valsartan tablet blister packs, due to the presence of trace elements of N-Nitrosodiisopropylamine (NDIPA) in the finished products.

NDIPA belongs to the N-nitroso chemical class known to contain mutagens and carcinogens, with the recall being conducted in consultation with the Therapeutic Goods Administration.

The products being recalled include APO-Valsartan tablets in the 40mg, 80mg, 160mg and 320mg strengths, with Apotex saying patients returning affected packs of the product should be given a full refund and offered an alternative equivalent product by the pharmacist, or referred to their doctor immediately.

Apotex said based on information available it expects the health risk posed by the use of APO-Valsartan tablets to be very low.

The Apotex recall follows a similar action undertaken by Alphapharm trading as Mylan Australia, which initiated a nationwide consumerlevel recall of all batches of its Dilart and Dilart HCT valsartan medicines in Australia last month (PD 26 Nov) due to potential contamination with NDEA (N-nitorsodiethylamine).

Manufacturing issues have affected a range of valsartan products across the globe this year, impacting products containing ingredients from a number of Chinese and Indian manufacturers.

## **PSA** pharmacist wage alert

THE Pharmaceutical Society of Australia has slammed a decision by the Fair Work Commission to "stagnate the minimum safety net pay for community pharmacists," with PSA National President Chris Freeman saying the ruling was a "completely inadequate reflection of the complex work that pharmacists do".

The Commission has decided the current base pharmacy award rate of just over \$27 per hour should remain in place, with Freeman saying the figure "does not reflect the profession's significant training, expertise and accountability".

However Freeman has also urged that in the context of the broader pharmacy sector, any increase in

## **Anti-vax warning**

**THE** NSW Health Care Complaints Commission has issued a public warning under s94A of the Health Care Compliants Act 1993 regarding "Misleading and Unsafe Practices by Anti-Vaccination Campaigners".

The HCCC said it was concerned about a number of complaints it continues to receive from such campaigners and the potential risks that such persons and associations pose to public health and safety.

"Anti-vax messages have the potential to engender fear and alarm in the community, often targeting vulnerable members of the community through misinformation which may have a detrimental effect on the health care decisions of individuals," the Commission warned.

The HCCC particularly highlighted selective quotes from scientific research and studies in support of anti-vax claims, including "exaggerating the risks and minimising or discrediting the benefits of vaccines.

"The research presented does not align with the evidence base on which independent and government bodies make recommendations," the HCCC said, urging consumers to exercise caution when relying on information promoted via social media and websites that are not government affiliated or endorsed. the award rate should be met with a corresponding boost to funding into the pharmacy sector to make pay rises affordable.

"We urge all pharmacists to discuss fair remuneration with their employers when accepting employment and at regular intervals," the PSA National President said.

He said the issue of fair pay for pharmacists went far beyond the minimum wage.

"Pharmacists need to be appropriately remunerated for their significant training as healthcare professionals with the most expertise in the quality use of medicines," Freeman added.

He noted that the recent PSA case put to the Fair Work Commission focused on the change in scope of practice for the profession.

"Our health system has seen a significant change in the complexity of health problems faced by patients, and pharmacists are now practising at a deeper and more intense level.

"The current division of base pharmacist wage categories are simply antiquated," Freeman said.

"Pharmacists should be paid a fair day's wage...without which, our profession will never meet its full potential, promulgating the professional dissatisfaction and disenfranchisement experienced by so many," he concluded.

## China push for Pharmacy 4 Less

THE Pharmacy 4 Less group has signed a new agreement with Chinese e-commerce and logistics group JD Worldwide, which will significantly reduce delivery times for the pharmacy group's customers across China.

## **Mayne US rights**

MAYNE Pharma has assumed control of the US rights for SUBAitraconazole in patients with Basal Cell Carcinoma Nevus Syndrome (BCCNS, commonly known as Gorlin Syndrome) following the revision of an agreement with HedgePath Pharmaceuticals Inc.

Under the terms of the revised deal Mayne Pharma will pay a 9% royalty on net sales of SUBAitraconazole for the treatment of BCCNS in the US to HedgePath, as well as committing up to \$5 million in funding to HedgePath to progress the development of the product to other cancer indications.

SUBA-itraconazole is a patented formulation with improved absorption and reduced variability compared to conventional itraconazole capsules, which are used to treat fungal infections but also have anti-cancer properties.

## Dispensary Corner

A DERMATOLOGICALLY aware bank manager in the UK failed to confront a masked robber while he was standing in line because she feared he had a skin condition and didn't want to cause offence.

London's *Daily Telegraph* reports the thief had remained silently in a queue in a Durham bank for 15 minutes while wearing blue latex gloves, a hood and a facemask.

The bank's manager had approached him and asked if she could assist, but he had replied "no" and continued to wait.

It was only when served that the man said he had an acid bomb, and forced the cashier to place £370 in his bag.

When asked why the bank had allowed the man to remain in the queue, Prosecutor Jane Waugh told a UK court the manager was concerned the man might have had a skin condition and didn't want to upset him.

Despite the bank's concern for his health, the thief was jailed.

THE US Food and Drug Administration is taking its role seriously this festive season, issuing a consumer update warning people to make sure glitter is edible before they eat it.

The official guidelines aim to help bakers determine exactly which types of the sparkly stuff can be sprinkled onto cupcakes, and which are better left for craft.

Edible glitter is required to include a list of ingredients such as sugar, gum arabic, corn starch and colouring, and should be clearly labelled as such.

However phrases on packets such as "non-toxic" do not indicate it is edible, the FDA said.
