

## Indications under fire

A PROPOSED new TGA list of permitted indications for complementary medicines has been blasted as “bizarre” and “not supported by scientific evidence” in a major *Fairfax* report today.

The indications are part of the Therapeutic Goods Amendment bill, with the front page *Sydney Morning Herald* story today accompanied by an opinion piece from health activist Ken Harvey.

Health claims highlighted include “tonifies kidney essence” and “opens body orifices,” with almost all of the particularly offending claims related to Chinese traditional medicine usages.

Critics say the extensive list, with more than 1,000 indications, is “misleading, potentially harmful and based on pseudoscience,” the report states, citing TGA Advertising Complaints Resolution Panel chair Allan Asher as saying “The TGA held industry consultations and lost the plot; it gave them a licence to deceive”.

If the legislation is passed complementary medicine sponsors will only be able to draw from the list of permitted indications when registering and labelling products.

The report also quotes RACGP president Dr Bastian Seidel saying the TGA “should not endorse wannabe indications that are not based on science, logic or common sense...its role is to protect the public from made-up claims”.

Consumer group CHOICE is calling for mandatory disclaimers saying the claims are “not accepted by most modern medical experts”.

## New Vic pharmacy rules

THE Victorian Pharmacy Authority (VPA) has warned of significant changes to approval processes for new pharmacy premises, including consideration of cases where there may be “undisclosed proprietary interests or undue influence”.

The measures are seen as likely to impact on pharmacies launching under a range of strongly-branded franchise groups such as Chemist Warehouse, Ramsay Pharmacy and others, involving “increased scrutiny of pharmacy business commercial arrangements”.

Applications will be assessed on a case-by-case basis, and those initially assessed as high risk - involving complex and technical commercial arrangements or having apparent gaps in supplied documentation - to be referred to

a monthly meeting of the Authority for further consideration.

The committee then may refer these applications to external lawyers, accountants or auditors.

The VPA has warned the new processes may result in increased costs to licensees as well as extended processing times.

Guidelines on pharmacy business commercial arrangements are currently being developed, with further details available this month.

“The Authority will continue to assess franchise agreements for compliance with the ownership and undue influence provisions of the Act progressively on a risk basis,” a VPA communiqué said yesterday.

## SafeScript regulations

THE Victorian Government has released the details of proposed new legislation governing the operation of the state’s SafeScript real-time prescription monitoring system (**PD 20 Oct 2017**), with input from stakeholders sought.

SafeScript is being developed by Guild offshoot Fred IT, with funding of \$29.5 million and expectations it will roll out from later this year.

All 58 medicines will be covered by the system as well as other high-risk medicines, with a planned 18 month phase-in period before SafeScript becomes compulsory.

## Malaria drug review

THE US Food and Drug Administration has granted Priority Review Designation for a new drug to help prevent malaria.

Tafenoquine from 60 Degrees Pharmaceuticals was developed under a cooperative agreement with the US Army, and offers a weekly dosing regimen for malaria prophylaxis.

## New data breach laws

**MOST** community pharmacies in Australia will be subject to new legislation on “data breaches” when the laws come into effect on 22 Feb 2018, after being passed by Federal Parliament this week.

The *Privacy Amendment (Notifiable Data Breaches) Bill 2016* means the Australian Information Commissioner and people compromised by any ‘eligible data breach’ must be notified.

Businesses that fail to report a breach face fines of up to \$360,000 for individuals and \$1.8 million for organisations.

The law applies to data breaches where there is unauthorised access to or disclosure of personal information, or a loss of personal information held by an entity; that is likely to result in serious harm to one or more individuals; and that the entity has not been able to prevent the risk of serious harm with remedial action.

The Pharmacy Guild says it will be providing further information to support members with their obligations under the new laws in the coming weeks.

## Pain alternative?

THE compounding pharmacy sector may have a “gentler, non-addictive answer” for sufferers of chronic pain, according to National Custom Compounding (NCC), which is highlighting the benefits of palmitoyletanolamide (PEA).

Described as a “curious old compound,” the endogenous fatty acid amide is the subject of a paper published in the *Journal of Pain Research* which outlines several case studies where PEA significantly reduced the level of pain experienced by long-term chronic pain sufferers, NCC said.

The company said PEA is currently classified as a food product and an “unscheduled supplement” by the Therapeutic Goods Administration - [customcompounding.com.au](http://customcompounding.com.au).
