## Close the Gap, urges PSA

**THE** Pharmaceutical Society of Australia has called for a national approach to integrate non-dispensing pharmacists into Aboriginal Health Services.

Such an initiative would help to Close the Gap for Indigenous Australians, according to PSA president Shane Jackson, who said the Society is currently developing an evidence-based primary care and funding model to boost health outcomes among Aboriginal and Torres Strait Islander peoples.

Jackson said having a culturally responsive practice pharmacist integrated with an Aboriginal Health Service (AHS) builds better relationships between patients and staff, leading to improved results in chronic disease management and Quality Use of Medicines.

"The integration of a non-dispensing pharmacist in an AHS has the potential to improve medication adherence, reduce chronic disease, reduce medication misadventure and decrease

preventable medication-related hospital admissions to help Close the Gap," Dr Jackson said.

Last year Health Minister Greg Hunt launched a 'Pharmacists in Aboriginal Health Services' trial under the Sixth Community Pharmacy Agreement (**PD** 31 Jul 2017), with the PSA developing the trial in partnership with the National Aboriginal Community Controlled Health Organisation.

The PSA has also established a national ACCHO Pharmacist Leadership Group (**PD** 01 Nov 2017) to foster collaboration and inform policy in support of pharmacists working in Indigenous health.

**MEANWHILE** Indigenous Health Minister Ken Wyatt on Fri announced a four-year Tackling Indigenous Smoking (TIS) program, which will provide "certainty, continuity and record funding for proven local campaigns and new initiatives to save lives and reduce the devastating impacts of tobacco-related disease".

## Tropical disease work

**SYDNEY** University researchers have launched a new drug discovery project which takes an "open source approach" to find compounds for the treatment of mycetoma, a tropical infectious disease which causes devastating deformities.

The Mycetoma Open Source (MycetOS) project is backed by the Drugs for Neglected Diseases initiative and ErasmusMC, inviting the global scientific community to review a manuscript sharing results of early work to screen 800 molecules for active compounds against the causative pathogen of eumycetoma.

MycetOS will "progress drug discovery efforts through community-driven, in-kind scientific contributions and a robust, fully transparent online presence" with all ideas and results to be published immediately in real time to an open-access database.

Twitter will be used for communication while Github will share data and key project files.

## Dispensary Corner

## VentureWise splits with MedReleaf

**NPS** MedicineWise offshoot VentureWise has formally announced the discontinuation of its partnership with medicinal cannabis company MedReleaf (**PD** 06 Feb), which included the development of educational resources on medicinal cannabis for pharmacists, GPs and specialists.

VentureWise managing director Greg Hughes issued a statement on Fri afternoon, confirming that his organisation had been engaged by MedReleaf "to

develop independent information for healthcare professionals to improve prescriber knowledge about medicinal cannabis and the regulatory framework".

Hughes said the project aligned with the NPS MedicineWise group's overarching mission of improving the quality use of medicines in Australia.

However "unfortunately the scope of the project was presented by MedReleaf beyond what we originally agreed, and as a result our partnership will cease effective immediately," Hughes said.

"We wish MedReleaf all the best with their future endeavours."

MedReleaf Australia is headed up by pharmacist Russell Harding, who has established a joint venture with Canada's Medreleaf Corp, an ISO 9001 and GMP certified producer of medicinal cannabis.

MedReleaf plans to sponsor universities in Qld and South Australia to perform a series of trials involving the firm's products across several disease states.

## Sunset for sunset

**THE** Federal House of Representatives last week passed an amendment to the National Health Act which will remove the sunset clause on pharmacy Location Rules.

The legislation changes fulfil a promise by Health Minister Greg Hunt (**PD** 09 May 2017) to remove a provision which could have seen Location Rules phased out in 2020.

The bill now moves to the Senate.
