PBS over Easter

THE Health Department has confirmed it will remit Pharmaceutical Benefits Scheme (PBS) Online payments in advance over the Easter period.

If payments are due on Good Friday, 30 Mar 2018, they will be processed early on Thu 29 Mar 2018, with no payments to be made on 30 Mar.

Claims lodged with PBS online from Thu 22 Mar through to Wed 28 Mar 2018 this year will be processed as normal on Fri 06 Apr.

Self-care strategy lacking

DRAWING the boundaries between individual self care and professional health care is a complex minefield with a lack of strategic direction in the Australian healthcare environment, according to a report by the Australian Health Policy Collaboration.

The report is the result of an ad-hoc alliance between three funding organisations: the Australian Self Medication Industry (ASMI), HCF & Remedy Healthcare, and the Australian Health Policy Collaboration at Victoria University.

Reviewing the report, ASMI said that while there were considerable efforts being made to support better self-care throughout the country and there is a multiplicity of sources of information, there is an "overall lack of strategic direction to help people navigate the complex boundary between individual and professional responsibilities for health.

"There is scant evidence that people who most need support with self-care and self-management are being effectively targeted by existing programs," ASMI said.

The World Health Organization defines self care as "the ability of individuals, families and communities to promote health, prevent disease, and maintain health and to cope with illness and disability with or without the support of a health-care provider".

with "the potential of responsible self-care by informed individuals" not being effectively harnessed, the narrative around this as a healthcare first option "needs to shift in response to profound social changes, including in patterns of disease in the population.

"A healthy population is achieved through a functional relationship between active and informed individuals, health care services that empower and support people, and governments that invest in the capabilities of individuals and communities to look after their health," the report added.

ASMI summarised in its review of the report, that in relation to self-care, "it is time to think again."

Spironolactone scripts for acne up

WITH antibiotic resistance continuing to cause concern, one physician recommends that more dermatologists consider hormonal treatments for acne and hirsutism, reports *Dermatology Times*.

University of Birmingham clinical associate professor of dermatology Julie C. Harper was quoted as saying that with the number of spironolactone courses per 100 females with acne rising from 2.08 to 8.13 among dermatologists and from 1.43 to 4.09 among nondermatologists, between 2004 and 2013, "We are heading in the right direction".

Board codeine advice

THE Pharmacy Board of Australia has reminded pharmacists of their obligations in the event they receive prescriptions for large quantities of combination analgesics containing codeine, in light of this month's up-scheduling of the products.

A Board communiqué issued yesterday noted consideration should be given to legal requirements relevant to pharmacy practice, training materials and other resources developed by the TGA (such as the Codeine Information Hub at tga.gov.au) and pharmacy organisations, practice standards and guidelines, as well as the Board's code of conduct.

In particular "at all times the dispensing of a prescription or any other action taken by the pharmacist must be consistent with the safety of the patient," the Board said, with the guideline outlining that "professional judgement must be exercised by the pharmacist in deciding appropriate action to take, and to consult the patient and the prescriber about any alternative options available to the patient regarding their medication needs".

MEANWHILE the communiqué also details a new Guide for National Boards on applications to the Ministerial Council for approval of endorsement for scheduled medicines, including procedures around stakeholder engagement and key considerations for concept development.

GBMA appoints new ceo

THE Generics and Biosimilar Medicines Association (GBMA) has confirmed the appointment of Marnie Peterson as its new Chief Executive Officer.



Peterson (pictured) is currently based in Melbourne as

head of commercial for Dr Reddy's Laboratories, with a range of previous pharmaceutical industry roles in marketing with Actavis/Allergan and Apotex.

She takes the place of Belinda Wood, who resigned as GBMA ceo last year after about five years in the role (PD 20 Oct 2017).

GBMA chair Allan Tillack said he was delighted to welcome Peterson, hailing her "vast

experience and a strong record of accomplishment in the generics sector and actioning strategic objectives.

Tillack said the association has a full agenda for 2018, with the GBMA working to deliver the outcomes

identified as part of its strategic agreement extension negotiated in the 2017 Federal Budget.

"Marnie is well placed to progress this exciting agenda and we are looking forward to her joining us towards the end of March," he said.

SMS suspension

A PHARMACIST in Canada has been ordered to pay a fine of CAD\$17,000 for texting information about a patient to someone who was outside the "circle of care".

Diane Roy was suspended in Oct 2016, with a formal complaint lodged last Nov with the New Brunswick College of Pharmacists.

At a hearing earlier this week the pharmacist admitted to sending a text message with a full list of the patient's medications to an unnamed person, with sanctions including a three month licence suspension, a written reprimand and required training on ethics and confidentiality.

A \$2,000 fine was exacted along with \$15,000 in costs.

Board application date extended

THE Pharmacy Board of Australia is accepting late applications for practitioner member vacancies, which can now be lodged through until 5pm on 09 Mar 2018.

The Board said the closing date had been extended to "give registered practitioners more time to express interest in being part of health practitioner regulation nationally".

Pharmacists from the Northern Territory and the Australian Capital Territory are especially encouraged to apply, according to a Board communique issued yesterday.

The three-yearly recruitment rounds are an opportunity for Australian Health Ministers to consider appointments so that National Boards have the best mix of experience, new and diverse views to help inform their regulatory decision-making.

Registered practitioners are also able to express interest in the role of Board Chair, while Aboriginal and Torres Strait Islander people are strongly encouraged to apply, as are people from rural or regional areas of the country.

There are eight practitioner member positions available.

Alcohol-linked deaths

ALMOST 6,000 Australians died from alcohol-attributable disease in a single year, about one every 90 minutes, according to new research released by Curtin University's National Drug Research Institute (NDRI).



The National Alcohol Indicators project revealed an estimated 5,785 Australians died from alcohol-attributable causes in 2015 with cancer responsible for 2,106 (36%) of deaths while injuries, cardiovascular diseases and digestive diseases were the next leading cause (17%, about 1,000 deaths each).

Alcohol-caused breast cancer (18%) and liver disease (15%) were the most common among women, while among men, liver disease (18%) and bowel cancer (10%) were the most common.

Hospitalisations attributable to alcohol exceeded 144,000 in 2012-13, an average of about 400 a day with the main causes recorded as alcohol dependence (21%), falls (12%) and alcohol abuse (10%).

Education and research director at Cancer Council WA Terry Slevin said, "It is likely most people will be quite shocked to learn that more than one third of alcohol related deaths are due to cancer".

Muscular atrophy win

NEUROSCIENCE pharmaceutical company Biogen together with Ionis Pharmaceuticals announced successful Phase III trial results with spinal muscular atrophy (SMA) hopeful drug Spinraza (nusinersen).

Published in the *New England Journal of Medicine*, the study was able to demonstrate "stabilisation or improvement in motor function in individuals with spinal muscular atrophy (SMA) where the natural history of the disease is a decline in motor function over time".
