Hunt responds to Review

Sigma honours

AMCAL and Guardian's top pharmacies and pharmacy staff were honoured in a gala awards dinner wrapping up the Sigma Retail conference on Wed - see page four for the winner details. **HEALTH** Minister Greg Hunt has released the government's response to the controversial King Review of Pharmacy Remuneration and Regulation (*PD* breaking news), with the majority of the recommendations from the report being rejected.

Speaking to delegates at APP, Hunt said his basic principle had been to ensure the ongoing sustainability of pharmacies, with

the government already having legislated to remove the five-year "sunset clause" around Location Rules - in contradiction to one of the review's key recommendations.

Machine dispensing was rejected out of hand (**see page 3**) along with a proposed "tender" system for sourcing of generic pharmaceuticals with Hunt making the point that he didn't want to put in place "new threats or challenges" to pharmacies which make an "immense contribution to community health in Australia".

The government did accept "in principle" a recommendation that funding arrangements for high cost medicines be changed, with the Therapeutic Goods Administration late yesterday confirming the new system would increase consumer access to high cost medicines via community pharmacy, as well as "address the financial risks associated with the payment of large rebates from medicines companies to government".

Consultations will continue to develop technical details of the new payment administration arrangements, with a planned implementation from 01 Jul 2019.

Hunt said no decision had been made about the \$1 PBS script discount issue.

During his APP presentation the Minister also made reference to pleasing progress in recent weeks on the national real-time prescription monitoring system concept, and announced a new \$3m Pharmacy Trial in South Australian aged care homes.

HEALTH Minister Greg Hunt yesterday revealed that the key rationale for the government's acceptance or rejection of recommendations from the King Review (**see page 1**) was ensuring the ongoing sustainability of the community pharmacy sector.

However when it came to recommendation 3-4 which relate to machine dispensing, Hunt said he had another reason for not moving forward with the proposal to trial remote vending machines for medicines - potentially leading to the replacement of pharmacists.

"We know there is a very important role for new technologies...but it just wouldn't be the same coming to APP2019 and just looking out at a bank of servers," he quipped.

Guild MHR training

THE Pharmacy Guild of Australia has announced the development of three training modules which will provide pharmacists with education on using the new My Health Record (MHR) platform.

The modules have been created in partnership with the Australian Digital Health Agency.

With the MHR system moving to "opt out" participation toward the end of the year, the Health Department estimates 98% of Australians will be on board at that time, creating an important source of patients' key health information.

The modules revolve around accessing information about prescribed and dispensed medicines, clinical information contained in Discharge Summaries and Event Summaries as well as clinical information contained in a Shared Health Summary.

The first module is already available, with the others to be launched later this month.

Guild president George Tambassis urged pharmacies to register their participation with MHR and to undertake the CPD-accredited training - visit myCPD.org.au.



MedAdvisor to create TWC branded app

MEDADVISOR yesterday announced a three year agreement with TerryWhite Chemmart (*PD* breaking news), which includes the roll-out of a white-labelled TWC version of the MedAdvisor app.

Customisation of the app has already commenced, with the TWC branding expected to be available on the various smartphone app stores later this month.

MedAdvisor's PlusOne platform is already in place in a number of TerryWhite Chemmart stores, supporting the group's "ambition to drive healthier communities by helping stores identify, recruit, book and record and claim services delivered to patients".

MedAdvisor ceo Robert Read said the customised version was a result of the value that the existing stores using the platform were receiving.

He said the rollout across TWC would see additional stores sign up to MedAdvisor, "extending our pharmacy network and patient acquisition opportunity".

New Products

- Dupixent (dupilumab (rch)) is a fully human recombinant monoclonal antibody that inhibits interleukin (IL)-4 and IL-13 signaling by specifically binding to the IL-4Rα subunit shared by the IL-4 and IL-13 receptor complexes. Dupixent inhibits IL-4 signaling via the type I receptor (IL-4Rα/γc), and both IL-4 and IL-13 signaling through the type II receptor (IL-4Rα/IL-13Rα). IL-4 and IL-13 are key type 2 (including Th2) cytokines involved in atopic disease. Dupixent is indicated for the treatment of moderate to severe atopic dermatitis in adults who are candidates for chronic systemic therapy. Dupixent is not intended for episodic use. Dupixent prefilled syringe (300 mg/2 mL) is available in packs of 2.
- Odomzo (sonidegib) is a selective Smoothened (Smo) antagonist. Smo is a G-protein coupled receptor-like molecule that positively regulates the Hedgehog (Hh) signal transduction pathway, which is linked to the pathogenesis of several types of cancer including basal cell carcinoma (BCC). Odomzo is indicated for the treatment of adults with: locally advanced BCC who are not amenable to curative surgery or radiation therapy; metastatic BCC. Odomzo is contraindicated in women who are pregnant or breastfeeding, and women of childbearing potential (unless two reliable methods of contraception are used during treatment and for 20 months after the last dose). Odomzo 200 mg tablets are available in packs of 30.
- Vosevi (sofosbuvir/velpatasvir/voxilaprevir) is a fixed dose combination tablet containing the active substances sofosbuvir, velpatasvir and voxilaprevir. Sofosbuvir is a pan-genotypic inhibitor of the hepatitis C virus (HCV) NS5B RNA-dependent RNA polymerase, which is essential for viral replication. Velpatasvir is a pan-genotypic HCV inhibitor targeting the HCV NS5A protein, which is essential for both RNA replication and the assembly of HCV virions. Voxilaprevir is a pan-genotypic inhibitor of the NS3/4A protease. Vosevi is indicated for the treatment of chronic HCV infection in adults, without cirrhosis or with compensated cirrhosis, who have: genotype 1, 2, 3, 4, 5, or 6 infection and have previously been treated with an HCV regimen containing an NS5A inhibitor. Vosevi is contraindicated with rifampicin and rosuvastatin. Vosevi (sofosbuvir 400 mg/velpatasvir 100 mg/voxilaprevir 100 mg) tablets are available in packs of 28.

New Contraindications

- Duratocin (carbetocin) should not be used in patients with cardiovascular disease, especially coronary artery disease, valvular heart disease, cardiomyopathy and heart failure.
- Ubistesin and Ubistesin Forte (articaine hydrochloride/adrenaline (epinephrine) (as hydrochloride)) is now contraindicated with phaeochromocytoma, uncontrolled hyperthyroidism, and complete heart block not compensated by a pacemaker.
