## Rosacea sufferers seek OTC solutions

**PEOPLE** living with rosacea are more likely to self-treat with over-the-counter (OTC) products when they are experiencing a flare-up, than go to their doctor, a survey reveals.

Research released by Galderma, found many patients were avoiding their doctors after being prescribed treatments had proven unsuccessful in the past.

The Rosacea: Beyond the visible global report, published in 2018, revealed 82% of people with the condition felt their rosacea was not fully controlled.

The survey found that more than half of sufferers who were employed said it had impacted their productivity.

More than 86% of respondents said they significantly altered their behaviour to avoid triggered flareups, as a result of experiencing a strain in their everyday lives.

In an open letter to doctors, four international dermatology experts called on healthcare professionals to reach out to patients.

"To improve the situation, we must start by acknowledging the problem...if you are a doctor - reach out," they said.

"This isn't a futile conversation - together we may be able to improve outcomes."

## **Guild stalling progress?**

PHARMACISTS are failing to reach their full professional potential because the Pharmacy Guild of Australia wants to maintain the status quo, a former civil servant believes.

Retired chair of the South Australian Generational Health Review and former News Limited General Manager, John Menadue, accused the Guild of corralling pharmacists into being shopkeepers rather than health professionals.

In a blog post published in the wake of the Federal Government's decision not to allow doctors to provide scripts for double supplies, Menadue said the Guild's successful lobbying had stymied the profession's progress.

"Pharmacists are the most underutilised health professionals in the country [and] the Guild is happy to keep it that way," he said.

Menadue said the current model of community pharmacy was unsustainable and called on dissatisfied pharmacists to challenge the status quo.

"Some pharmacists have expressed to me their dissatisfaction that their professional skills are not fully utilised and extended," he said.

"But despite the interest in increased professionalisation of many pharmacists there is not yet sufficient will amongst pharmacists generally to make the change that is necessary?

"They let the Pharmacy Guild of Australia lead them by the nose." Menadue said the current pharmacy model was "comfortable and financially rewarding for owners", but needed to be challenged to create a focus on preventative health, with pharmacists playing a greater role in disease prevention and multidisciplinary healthcare teams.

"It is quite remarkable that the Guild has consistently opposed direct relationships developing between GPs and accredited pharmacists," he said.

"It insists that the relationship must be with the patient's nominated community pharmacy.

"This is quite contrary to normal health referral practices. The Guild is a serious barrier to the advancement of professionalism in pharmacy," Menadue concluded.

### New illicit drugs book

A NEW book on illicit drugs and health, written by



experts from the National Drug and Alcohol Research Centre (NDARC) at UNSW Sydney, will be available from 16 Apr providing vital guidance for health professionals on the impact of illicit drug use.

The book covers the major drug types: stimulants, opioids, cannabis, hallucinogens, and the new emerging class of 'novel psychoactive substances' (NPS).

### **Docs fear CAM ban**

**DOCTORS** who practice integrative medicine feel they have been blind-sided by the Medical Board of Australia's proposed new guidelines for complementary and unconventional medicines.

In an interview with the ABC, Australasian College of Nutritional and Environmental Medicine Board member, Nadine Perlen, said doctors were alarmed by the proposed rules, which could restrict their use of complementary and alternative medicines (CAMs).

"They have lumped doctors like myself, who are doing that kind of practice in general practice, with doctors who are doing more fringe practices," she said.

The Australasian Integrative Medicine Association (AIMA) has also voiced its concerns about the Board's proposals, saying there was no evidence to suggest the guidelines would improve patient safety.

In a letter to the Board AIMA President, Dr Penelope Caldicott, wrote "the proposed guidelines are fundamentally flawed".

"COAG principles have not been upheld and the guidelines have been developed without any evidence of need," she said.

However, Board chair, Anne Tonkin, told the ABC that "there are a number of cases where harm has been done to members of the public from the practice of complementary and alternative and all those other emerging therapies".

Criticism of the Board's proposals has grown since Marcus Blackmore published an open letter to the Board (*PD* 04 Apr).

### **Guild seeks Liberal letter**



**SENIOR** officials from the Pharmacy Guild of Australia met with Prime Minister Scott Morrison last week to discuss the government's support for community pharmacy.

President Trent Twomey and National President George Tambassis (pictured with the PM) took the opportunity to "raise a couple of outstanding issues," as well as to "reaffirm our hope that the Coalition will provide the Pharmacy Guild and our members with a strong letter of support for community pharmacy before the election".

According to an update to Guild members from Tambassis last Thu, Prime Minister Morrison undertook to provide such a letter.

Tambassis noted that the ALP had already provided its own letter of support for the community pharmacy sector, adding that "we will circulate the Coalition letter as soon as it is received for the information of members, and to assist you in weighing your choices in Federal Election 2019".

### FDA test strip alert

THE US Food and Drug Administration (FDA) has issued a warning about the risks of home use test strips that are "pre-owned" or not authorized for sale in US, including those for testing of glucose or warfarin levels.

The notice explains that the test strips may be a potential source of infection or lead to inaccurate test results, with possible dire consequences to health.

Driven by the possible cost savings, people have been buying pre-used or unauthorised imports but thereby put themselves at severe risk of harm - see fda.gov.

## Pharmacist reprimanded

A NSW pharmacist has been found guilty of unsatisfactory professional conduct and professional misconduct resulting from a referral by the state's Health Care Complaints Commission, and has been issued with a reprimand with a suite of conditions.

The order was handed down yesterday on Simon Elias by the Civil and Administrative Tribunal of New South Wales.

There were three conditions imposed on Elias' registration for a period of 12 months as a result, covering mentoring, auditing and performance reviews.

Elias is to nominate a registered experienced pharmacist to act as his professional mentor for approval by the Pharmacy Council of NSW in accordance with the Council's Mentoring Policy.

The mentoring will include Elias' management of his pharmacy practice, supervision of pharmacy staff and compliance issues around poisons and therapeutic goods.

The audit process will require Elias to submit to an audit of his

practice by a person nominated by the Council starting no later than 10 Jul 2019.

The pharmacist will also be required to meet all costs associated with the audit process.

Performance assessments will be conducted by a person nominated by the Council, to be conducted no later than 10 Nov 2019.

The performance assessment requirement is to remain in place for 12 months or such longer period as determined by the Council.
