Bronchi-Cough recall



THE Therapeutic Goods Administration (TGA) has announced a recall of Bronchi-Cough Pills (qiguanyan kesou tanchuanwan; AUST L 144659) "due to

contamination with substances that pose an unacceptable risk to health".

Both currently available batches of the product (Batch 16080020 and Batch 4080015) are contaminated with low levels of amygdalin and in addition, Batch 16080020 is also contaminated with very low levels of aristolochic acid.

The TGA says there is no safe level of exposure to these contaminants. See tga.gov.au for more.

New PBS listings

HEALTH Minister Greg Hunt announced on Friday the funding for Pharmaceutical Benefits Scheme (PBS) listing of a therapy for sufferers of seizures associated with a rare genetic disease.

Affinitor (everolimus) from Novartis helps patients with tuberous sclerosis complex (TSC); they are afflicted with benign tumours impacting the nervous system and frequently experience as many as 50 seizures a day.

Also newly PBS-listed is Otsuka Australia Pharmaceuticals' Jinarc (tolvaptan) which is now being reimbursed for the treatment of autosomal dominant polycystic kidney disease (ADPKD) which is estimated to affect about 10,000 Australian patients.

Jinarc blocks the activity of the naturally occurring hormone vasopressin, which is elevated in ADPKD patients and contributes to the growth of cysts on the kidneys.

NSW pharmacist vaccines

PHARMACISTS in New South Wales have now been added to the cohort of accredited immunisers able to deliver a wider range of injections, including those for measles and whooping cough, for anyone over the age of 16.

The new arrangements were announced in Oct last year (**PD** 25 Oct breaking news) by Health Minister Brad Hazzard, and came into effect yesterday creating a "new era of accessibility of vaccination for all residents, even in rural and regional areas".

Trained NSW pharmacist vaccinators can now give both the diphtheria, tetanus and whooping cough combination vaccine and the measles, mumps and rubella (MMR) vaccine, in addition to the flu vaccine, to people over 16.

Health Care Homes trial extension

THE Government has announced the extension of the Health Care Homes program for an additional 18 months through until 30 Jun 2021, and is also now allowing patient enrolment until 30 Jun 2019.

The extension is also applicable to the Community Pharmacy in Health Care Homes trial, according to an update on the Sixth Community Pharmacy Agreement website. The Government said extending

the trial will give general practices, Aboriginal medical services and providers participating in the trial "more time and funding to implement the integrated and patient-centred model of care for enrolled patients".

The extension only applies to Health Care Homes currently participating in the trial.

The target for enrolled patients has also been slashed from 65,000 down to just 12,000, with the revised figure based on current patient enrolment rates.

Enrolled patients will continue to benefit from referral to their chosen pharmacy for review of their medications and development of a collaborative medication management plan until 30 Jun 2021. Qualified pharmacists have established private rooms on the pharmacy premises with trained pharmacists conducting prejab assessments to assess each person's current health status.

Once administered, the shots are reported to the Australian Immunisation Register as a matter of course.

Hazzard said the record high rates of vaccination in NSW are a great public health achievement.

"Now, with this additional range of vaccinations available from pharmacists, we want to encourage new grandparents, carers of infants, and partners of pregnant women to get vaccinated to ensure they don't catch whooping cough and pass it on to their babies," Hazzard said.

"NSW has achieved its highest vaccination rates ever and is spending a record \$22.75 million in 2018-19 on state-wide immunisation programs."

"People eligible for free government-funded vaccines, including children under five, Aboriginal people, those with chronic illnesses, pregnant women and people over 65 will still need to access these vaccines via their GP, so they can get a health assessment at the same time," Hazzard added.

Terry White Group now part of EBOS

EBOS Group Limited has completed its acquisition of the minority shares in Terry White Group Limited (*PD* breaking news 24 Dec 2018), meaning TWG is now a wholly owned subsidiary of EBOS.

The \$50 million transaction was first announced on 19 Oct last year and has seen EBOS acquire the TWG shares it did not already hold via a Scheme of Arrangement.

TWG shareholders received \$3.55 per share, with the deal said to "enable Terry White Group and the TerryWhite Chemmart pharmacy network to achieve the scale and strength required to fulfil its potential to become Australia's favourite pharmacy brand".

PBS co-payments up

THE Schedule of Pharmaceutical Benefits has been updated, highlighting new fees, patient contributions and Safety Net Thresholds.

Concessional patient co-payments are now at \$6.50 and general copayments have been increased to \$40.30, while dispensing fees are now set at \$7.29.

The site also identifies drugs subject to price disclosure as at 01 Jan - more at pbs.gov.au.

"Little evidence" for CMs - AMA

THE Australian Medical Association has released an updated position statement on complementary medicines, saying there is "little evidence to support the therapeutic claims made for most of these medicines and therapies".

AMA President Tony Bartone noted that in 2017 the revenue of the industry had reached \$4.9 billion, including \$630 million spent on herbal products and \$430 million on weight loss items.

"The majority of complementary medicines do not meet the same standards of safety, quality and efficacy as mainstream medicines, as they are not as rigorously tested," Bartone said. He claimed that CMs pose a risk to patient health, either directly through misuse, or indirectly if a patient puts off seeking medical advice "or has spent so much on these products

that they cannot afford necessary, evidence-based treatment".

The AMA is also urging better regulation of non-registered health practitioners such as naturopaths, herbalists and Ayurveda practitioners, and the establishment of a national public register of those who have been banned from working in their state or territory.

"When I cast the asparagus, it creates patterns and it is the patterns I interpret," she explained, with a success rate of between 75% and 90%.


