PSA supports Uluru Statement

THE Pharmaceutical Society of Australia (PSA) has endorsed the historic 'Uluru Statement from the Heart', which calls for a First Nations Voice to be enshrined in the Constitution and for a Makarrata Commission as a process for agreement making and truth telling.

PSA National President Dr Chris Freeman said PSA was proud to add its voice to the call for recognition of the First Peoples of Australia in the Constitution.

"PSA is committed to ongoing work to support the health and wellbeing of Aboriginal and Torres Strait Islander people.

"We are proud to add our voice to this movement for a better future.

"As the peak national body for pharmacists, PSA has long advocated for closing the gap by supporting pharmacists to play an active role in improving medication management for Aboriginal and Torres Strait Islander people," Freeman concluded.

WA pharmacist misconduct THE Western Australian State Administrative Tribunal has found Perth pharmacist Emson Nyoni

guilty of professional misconduct after dispensing S8 drugs in contravention of conditions applied to his registration.

The long-running case followed the revocation of his authority to dispense the medications in 2013, with the pharmacist subsequently continuing to offer S8 items on at least 160 occasions.

A number of proceedings in the interim included assertions by Nyoni that the conditions placed on his registration were "nugatory" and that the regulatory authorities were trying to "assassinate his

Podcasts multiply

PODCASTS have exploded in popularity as a way for the public to engage with science prompting a study by Durham University, UK, to analyse the numbers.

The study looked at nearly 1,000 science podcasts and analysed them to find that mainly scientists host science podcasts, and that most are geared towards the public.

Most of the science podcasts didn't appear to have any supporting income, giving the impression that they are being made simply in order to help educate consumers - **CLICK HERE**.

MHRA pings trio

THREE UK men were sentenced this week at Southwark Crown court for their involvement in the illegal supply of potentially dangerous prescription-only medicines.

The Medicines and Healthcare products Regulatory Agency (MHRA) successfully brought the charges for supplying unauthorised medicines, including diazepam, zolpidem and zopiclone.

The regulatory agency seized more than 300,000 tablets, worth in excess of £315,000.

Dispense fail injury

OCULAR chemical injury was caused to a Scottish patient when she was given an erectile dysfunction cream (Vitaros) instead of an ocular lubricant (VitA-POS).

Neither the GP, pharmacist or patient picked up on the error that an erectile dysfunction drug was being given to a female with instructions for application to the eyes.

NZ pharmacies speed GP access



AN UNKNOWN number of New Zealand pharmacies are cutting out the wait time for patients to see a GP by providing tablets or other internet-enabled devices for patients to use on the pharmacy premises to access SwiftMed.

The online GP access website provides a face to face general practice service which advertises: "Our qualified doctors can provide diagnoses, treatment, and prescribe medication for more than 60 common medical conditions".

The company boasts no wait times, no membership fees and no monthly premiums and prescriptions are provided and if necessary delivered to the home, office or pharmacy of choice. See swiftmed.co.nz.

USA meds adverts up

SPENDING by pharma companies promoting their medicines in the USA rose by more than 60% over the last two decades according to a study reported by *Scimex*.

Marketing of drugs, disease awareness campaigns, health services and laboratory testing increased to \$29.9 billion in 2016 from \$17.7 billion in 1997.

The data showed that while most of the advertising was angled at health professionals, direct-toconsumer advertising grew to \$9.6 billion, representing about one third of the investment.

Aussie success story shines

ARGUABLY one of Australia's great industry success stories, global biotech company CSL presented its credentials at the JP Morgan
