# Greg Hunt confirmed to open APP 2019



**HEALTH** Minister Greg Hunt will deliver the opening keynote address at the upcoming Australian Pharmacy Professional Conference.

APP2019 will take place on the Gold Coast from 07-10 Mar 2019, with Conference Chairman Kos Sclavos saying it was an honour to have the Minister once again participating in the event.

"With 2019 being an election year and the Federal Budget being handed down within a month of APP, this may be his most important presentation ever held," he said.

Hunt will also announce the 2019 Pharmacy of the Year winners, with the opening session starting at 8.30am on Thu 07 Mar.

Sclavos reminded delegates that daylight saving is not observed in Queensland, urging them to lock in travel plans early to ensure they do not miss this important session.

# Pharmacy graduates most employable

**STUDENTS** graduating from pharmacy degrees have once again topped the table in terms of employment outcomes, with the latest Graduate Outcomes Survey indicating 95.5% in full-time work shortly after completing their study.

The government-funded survey also compared figures between 2015 and 2018 and found the largest increase in salaries over the period, up 78% (\$32,800) but from a relatively low base of \$42,300.

Results found a large gender gap among pharmacy graduates, with female pharmacists earning 12% less (\$10,300) on average than their male counterparts three years after graduation.

# 6CPA program transition

AUSTRALIAN Healthcare Associates (AHA) has released details of the transition of management of 23 Community Pharmacy Programs which are being taken over from the Pharmacy Guild effective from the start of next month.

AHA was last year awarded the contract to administer the programs currently funded under the Sixth Community Pharmacy Agreement (*PD* 29 Oct 2018) following a competitive tender process undertaken by the Department of Health.

An update yesterday confirmed the Guild would continue to run the programs up to and including 31 Jan 2019, meaning it will receive and process claims until then and also make payments and resolve issues in relation to these claims.

Effective 01 Feb 2019 AHA, which will be operating under the name "Pharmacy Programs Administrator" (PPA) will take over.

# Garlic extract shows hypertension impact

**A NEW** Australian study has been hailed as showing that Kyolic Aged Garlic Extract is comparable to traditional blood pressure drugs.

The research, published last month in *Frontiers of Nutrition*, found the product reduced blood pressure in hypertensive patients to a similar degree to first-line standard antihypertensives.

However the study also warned that increasing dietary garlic did not have the same benefits.

Researchers said the patient group who took the Kyolic product also experienced positive changes in pulse wave velocity, arterial stiffness, inflammatory markets and gut microbiota.

A total of 49 participants with uncontrolled hypertension completed a double-blind randomised placebo-controlled 12 week trial, investigating the effect of daily intake of aged garlic extract or placebo on a range of measures. See frontiersin.org for the study.

# Microsoft seals major pharmacy deal



TECHNOLOGY giant Microsoft has announced a new strategic partnership with Walgreens Boots Alliance, which operates pharmacy brands across the US and Europe with a presence in 25 countries.

The companies will work together to "develop new health care delivery models, technology and retail innovations to advance and improve the future of health care".

As well as a joint multi-year R&D investment, Walgreens Boots Alliance will pilot up to 12 instore "digital health corners" to merchandise a range of health-related hardware and devices.

Microsoft also becomes

provider" with plans to migrate
the majority of its IT infrastructure
onto the Microsoft Azure platform
and roll out Microsoft 365 to over
380,000 employees worldwide.

# TGA issues e-cigarette warning

**THE** Therapeutic Goods Administration has issued a formal alert for consumers about the potential risks of purchasing electronic cigarette liquid.

The advice stems from a study which found "undisclosed and potentially harmful ingredients" in e-cigarette liquid being sold in Australia, including nicotine and other chemicals in liquid that claimed to be "nicotine-free".

The Medical Journal of Australia published research yesterday detailing how scientists purchased 10 "nicotine-free" e-cigarette liquids both online and over the counter in Australia.

Testing found 60% of the products actually contained nicotine, which is classified as a Schedule 7

Dangerous Poison.

All liquids tested also contained traces of 2-chlorophenol, a common breakdown product of some insecticides, herbicides and disinfectants and is a known irritant to human airways and skin.

Contaminants included 2-aminooctanoic acid, routinely found the blood, urine and faeces of mammals, the researchers found.

The TGA noted that at this time no electronic cigarettes have been approved in Australia as a therapeutic good for smoking cessation, and noted concerns from Europe and the USA that significant use of nicotine-containing electronic cigarettes by adolescents can lead to longer-term cigarette smoking.
