WOOLWORTH'S New Zealand subsidiary, Countdown, is continuing the roll out of its free prescriptions strategy, extending the service to three Bay of Plenty stores

The program had previously been introduced to the supermarket chain's in-store pharmacies in

Countdown's head pharmacist, Jeremy Armes, said the introduction of the supermarket's free script plan in three pharmacies in the Tauranga region, in Fraser Cove, Bayfair and The Valley, could save local patients more than NZ\$135,000 The New Zealand Herald reported.

"We've trialled free pharmacy prescriptions in our Auckland stores and the feedback was extremely positive," he said.

"We're pleased to now be able to extend this offer to more of our



Countdown pharmacies, including here in Tauranga.

"Our in-store pharmacist expertise will continue to focus on patient care, while at the same time providing customers with lower prices and free prescriptions for their pharmacy needs."

Armes said Countdown was committed to improving access to healthcare and making it more affordable, through its pharmacies, adding that the roll out of free prescription services in Tauranga was a logical step to achieve that.

The supermarket chain gained access to the community pharmacy sector in New Zealand in 2012, and now has 30 pharmacies in its stores across the Shaky Isles.



PDL issues steroid update

PHARMACISTS should have a "contemporary knowledge of the drugs that are subject to abuse or misuse," according to Pharmaceutical Defence Limited, which has released a bulletin providing details of off-label use of steroids and hormone therapies.

PDL said many individuals source anabolic steroids from coaches, friends, teammates or gym employees - as well as health workers such as doctors, veterinarians or pharmacists.

Injectable steroids subject to abuse include Sustanon, Primoteson and Reandron, but PDL also noted the potential for diversion of tamoxifen and armidex/anastrozole, to prevent gynaecomastia associated with the use of anabolic steroids.

Other potential medications in this class include pregnyl/ human chronic gonadotrophin (to stimulate the testes when withdrawing from exogenous androgens) and clomid/clomifene (to raise testosterone levels).

Pharmacists presented with prescriptions for drugs which are susceptible to misuse or abuse are being told to treat such requests "circumspectly," because of manipulative behaviour by individuals seeking these drugs for inappropriate purposes.



MEANWHILE PDL's latest update also highlights several common issues with the provision of medicines via staged supply.

"While the benefits are apparent for the patient, prescribers and pharmacies, there are also challenges for pharmacists responsible for managing the supply process," PDL noted.

Themes included requests for early supply, unclear or inconsistent instructions from the prescriber, patient financial difficulties and allegations of mismanagement of remaining stock on hand.

PDL urged that patients be provided with a very clear understanding of prescribers' directions, including the supply interval, adding that "it should be agreed that it's the patient's responsibility to contact the prescriber and seek approval for any change to the prescription".

Retail pharmacy business analysis

AN EXPLANATORY list of nine key performance indicators (KPIs) used in the general retail environment are equally applicable to community pharmacy retail endeavours according to Pharmacy Accountants Director of Peak Strategies, John Thornett.

Writing in a Pharmacy Guild of Australia blog, Thornett said these were often overlooked in pharmacy, but help owners review their pharmacy practice "in a different way".

In what amounts to a brief Retail Business Analysis 101 course, he identified Average Customer Spend/Basket Size calculated as sales divided by the number of transactions, but pointed out that Gross Profit Per Transaction was more useful and more accurate and is calculated as Gross Profit divided by the number of transactions.

Sell Through Rate can be measured by units sold divided by opening units on hand.

Cash Conversion Cycle is a formula: Debtor Days + Stock



Days – Creditor Days and Thornett defined each element.

Other key elements to this analysis are Customer Loyalty Program KPI's which include the Members to Non-Member ratio, Active vs Non-Active Members, Net Member Growth, Average Transaction Values Member to Non-Member and the Percentage of Transactions that involve a loyalty card.

The pharmacy blogger recommended setting up a monthly self-reporting framework to track trends.

US pharmacy chain steps up security

CVS Pharmacies is taking steps to combat robberies in its Michigan stores, and improve the security of its opioid medications.

On Mon the group announced it had completed the roll out of time delay safes across its 318 pharmacy stores across the state.

The company first introduced the safes in Indianapolis in 2015, in response to a surge in robberies in the city.

CVS Pharmacy reported the time delay safes were a deterrent for robbers, with the company seeing a 70% drop in robberies following their installation in



stores across Indianapolis.

The Detroit Free Press said that Michigan's Attorney General, Dana Nessel, also believed the safes would help slash pharmacy robbery rates.
