# Health professionals top cyber targets

**PHARMACY** owners are being urged by the Office of the Australian Information Commissioner (OAIC) to embrace guidelines introduced to minimise their risk of data breaches.

Launching the guide this week, OAIC Commissioner, Angelene Falk, noted that health professionals had been the leading source of notifiable breaches since Feb 2018, when reporting was mandated.

Falk warned that pharmacists could face penalties of up to \$2.1 million per privacy breach.

Pharmacy Guild of Australia Victoria Branch President, Anthony Tassone, told **Pharmacy Daily** the guide highlighted the need for pharmacy owners to ensure they adopt security measures to minimise cyber attacks and human errors, noting insurance products can assist risk management.

"Like other health care practices, pharmacies have a particular responsibility to protect data due to the sensitive nature of much of the information stored including information concerning the use of scheduled medicines, delivery of health services and patient health records," he said.

"This is further the case in the current environment of digital health/e-health initiatives encompassing electronic transfer of prescriptions, My Health Record and the Australian Immunisation Register to name a few.

"Pharmacies are a custodian of their patients' personal information and this responsibility underpins community pharmacy's highly trusted role in the community.

"It's important to be reminded that data breaches are not limited to malicious actions, but may also arise from internal errors or failure to follow information handling policies that cause accidental loss or disclosure of information.

"Sadly, none of us are immune to the risks of cyber attacks and in the modern digital age we all must be absolutely vigilant both at work



and at home to protect sensitive information of ourselves and those of patients in the pharmacy."

Tassone encouraged pharmacy owners and managers to visit www. staysmartonline.gov.au for more resources and information about cyber security.

The OAIC also published a privacy action plan for health practitioners to limit their risk of data breaches, which is available at oaic.gov.au.

# PDL raises dispensing concerns

**PHARMACISTS** are being urged by indemnity insurer, Pharmaceutical Defence Limited (PDL), to follow established dispensing protocols in order to avoid errors.

The warning follows a report of an alleged error by a pharmacist working at a discount chemist, in which the mother of a sevenmonth-old boy claimed the pharmacist provided directions that would have seen the child receive doses eight-times the recommended amount.

Speaking to *Pharmacy Daily*, PDL Professional Officer, Gary West, said the organisation would not comment on specific allegations, but stressed the need for pharmacists to follow the insurer's Guide to Good Dispensing. "We remind pharmacists of the

need to be mindful of risks," he said. "Distractions can be a factor,

interruptions are certainly a factor... pharmacists need to have a good system... there are a lot of steps in the dispensing process."

West said PDL had not seen a significant increase in claims relating to errors, that have been flagged by regulators, but noted that people were more likely to lodge complaints than in the past.

"The ability to make a complaint is easier to report," he said.

"[So there] probably has been an increase in formal notifications."

### RACGP members unimpressed by ad

A CAMPAIGN designed to push for the end of the Federal Government's Medicare rebate freeze has left many Royal Australian College of General Practitioners (RAGCP) members unimpressed

Only one-in-two members of the RACGP supported the ad campaign, however RACGP President, Harry Nespolon, described it as a success. "We stand by our campaign which highlighted how Medicare rebates are failing to keep pace with inflation and reflect the true cost of delivering GP services," he said.

It seems the ad wasn't popular among the public either, with just one in four surveyed Australians saying it resonated with them.

# Q Fever in GP – Recognition, Treatment and Prevention
