COMMUNITY pharmacists are being accused of price gouging, with a fresh report from News Corp claiming dispensing fees "paid to chemists to stick a label on drugs" were significantly increasing the cost of Pharmaceutical Benefits Scheme (PBS) medicines.

The article, published on Fri, noted pharmacists pay \$2.95 for atorvastatin, however general patients pay \$20.43 for the medicine on the PBS, after pharmacists receive fees for dispensing, administration and handling, recording the medicine on the patient's safety net record and a \$4.53 charge for general patients.

A spokesperson for the Pharmacy Guild of Australia described the article as "disappointing" adding the description of pharmacists' practice was inaccurate.

"This is an unfair misrepresentation of the skill, expertise, knowledge, training and responsibilities of professional pharmacists as health professionals," the Guild spokesperson said.

"The statin atorvastatin referred to in the story is one of the medicines which has come down in price very significantly over the past 10 years.

"Concession cardholders and pensioners, to whom about 70% of PBS scripts are dispensed, pay no more than \$6.50 for PBS prescriptions.

"After they reach the safety net, concession cardholders and pensioners pay zero per script." **MEANWHILE**, Australian

Healthcare Alliance Chair, Jennifer Doggett, hit out at the Community Pharmacy Agreement (CPA), during a discussion on ABC Radio Nightlife, describing it as a "non-transparent" way of funding pharmacy-based health services.

"Decisions about where that funding goes should be based on consumer and community interests, not based on what's best



for pharmacists," she said. Guild Victorian Branch President, Anthony Tassone, rejected suggestions the 6CPA was not transparent.

"The whole agreement is in a publicly available document, searchable via Google, and fully itemised," he said on Twitter.

"It's an \$18.9 billion agreement, of which \$15.5 billion are direct PBS subsidies for patients."

AMA goes "Wakefield"

CLAIMS by Australian Medical Association (AMA) President, Dr Tony Bartone, that pharmacists administered old vaccine stock to patients ahead of this years influenza season, are a "Wakefield statement", according to Pharmaceutical Society of Australia (PSA) Interim CEO, Dr Shane Jackson.

Jackson warned the AMA chief's comments could have a long-lasting and negative impact on future flu vaccination uptake.

"This is a Wakefield statement by the AMA President," he said on Twitter, referring to controversial British researcher Andrew Wakefield whose erroneous claims about MMR vaccinations have impacted global immunisation rates.

"[It] only seems to undermine vaccination efforts by all health professionals," Jackson said.

PSA National President, Dr Chris Freeman, called on Bartone to retract his claims that pharmacists had used expired vaccines.



"Pharmacists take seriously their essential role in providing safe and appropriate medicines," he said.

"All pharmacist immunisers are trained to the same standard as other immunisers in Australia, and pharmacists have stringent quality controls that prevent the use of expired or superseded stock, including influenza vaccines.

"In 2018, more than one million Australians safely received their flu vaccinations from a pharmacist.

"Vaccination against preventable diseases is one of the most effective and safe health interventions available to Australians," he added.

Medlab optimistic as revenues rise

ASX-LISTED medical and life sciences company, Medlab, has reported a 46% increase in revenues for the 2019 financial year, to \$8.1 million.

In its annual report the company noted the roll out of its self-branded nutraceutical range to pharmacy banner groups in the Jun quarter had generated revenues in excess of \$3 million.

Medlab CEO, Dr Sean Hall, added the company "now has access to approximately 4,500 pharmacies (up from approximately 500) and the company is projecting a continued increase in revenue



over the short to mid-term". Medlab also reported significant progress in its medical cannabis range, with a stage two trial of NanaBis at Royal North Shore Hospital close to completion, while its NanaCBD product is due to come online next month, the company said.

A SOUTH Australian pharmacist has been treated for minor injuries after being hit on the head with a printer during an armed robbery.

The bandit initially threatened Amir Hanna with a knife while demanding cash and prescription medicines, during an evening raid on the Meylin St, Port Macdonnell store, before "striking him on the head with a printer", SA Police reported.

A 28-year-old man from Mount Gambier, was apprehended shortly after the 22 Aug robbery, when police stopped a Mazda



sedan on Glenelg Road. The cash and prescription medications allegedly stolen from the pharmacy were also discovered in the car.

The man was charged with aggravated robbery.

CWH moral high ground: AMA

Dispensary Corner

NSW police have arrested a 34-year-old woman on suspicion of fraud after she attempted to take the idea of a repeat prescription to a new level.

When the woman confidently presented the script for OxyNorm at a pharmacy in the regional township of Parkes, sharp-eyed staff noticed it had previously been filled and alerted police.

Further enquires revealed it was not even the second time the prescription had been presented to a dispensary, with the woman seemingly seeking to have the script filled at multiple other pharmacies, the Parkes Champion-Post reported.

SECURITY staff at London's Gatwick Airport are licking their wounds (and perhaps their fingers) after seizing 25 bags of suspicious white powder.

Initially billed as a "huge drugs bust," after testing the powder was ultimately found to be cake ingredients for a vegan bakery.

British Transport Police issued a tweet about the incident, saying the powder was "soon reunited with the owner who has promised officers and staff a slice of cake in return".

The traveller was transporting the ingredients for his employer, Purezza Vegan Pizzeria when he was stopped by officers.

The restaurant, which has stores in London and Brighton, tweeted "Thanks for going easy on us guys! A slab of cake all round is in order when you're next in Brighton".

DISCOUNT pharmacy group, Chemist Warehouse, will "hold the moral authority" over the Pharmaceutical Society of Australia (PSA), while the organisation continues to support the Pharmacy Guild of Australia and the sale of "pseudo-science", according to Australian Medical Association (AMA) WA President, Dr Andrew Miller.

Commenting on a social media post by PSA Interim CEO, Dr Shane Jackson rejecting the AMA's push for GPs to be allowed to own pharmacies, Dr Miller hit out at the pharmacy ownership laws.

"Until you drop support for [the] Guild and for selling pseudo science you betray pharmacy grads and patients - the 90% [of] non-owners and Chemist Warehouse hold the moral authority," he said.

When challenged on the AMA's routine attacks on Chemist Warehouse's business model, Miller said, "I don't like their sales of nonsense... but in regard to calling out location and ownership rules it is ironic that Chemist Warehouse says nothing we disagree with".



Responding to Miller's tweets, PSA South Australia/Northern Territory Branch Vice President, Samuel Keitannpaa, questioned whether the two groups were genuinely aligned on pharmacy ownership.

"They [Chemist Warehouse] want deregulation of total number and ownership rules so they can use their loss-leading, high volume of sales focused strategy to force the closure of other stores and become a monopoly," he said.

"So their goals align with yours on this?"
