Use pharmacy to boost vax rates

PHARMACIST immunisers should be engaged to support efforts to ensure children in Victoria receive vaccines as scheduled, Pharmacy Guild of Australia Victorian Branch President, Anthony Tassone, believes.

Tassone was responding to a Victorian Department of Health and Human Services (DHHS) statement noting two-in-three families in the State had delayed or cancelled appointments to have their children vaccinated since Jun as a result of the COVID-19 crisis in the state.

The DHHS warned disruptions to routine childhood immunisations put individual children at increased risk of contracting vaccinepreventable illnesses.

"It's essential that pharmacist immunisers are fully utilised to the full scope of their training, and this includes for vaccination of children against the preventable diseases we have received training in," Tassone said.

"The Guild and the pharmacy community at large would encourage patients and their families to not hold off on important medical and health care during the COVID pandemic.

Australia needs an overdose strategy

NO STONE should be left unturned in developing a national strategy to combat the rate of overdose-related deaths in Australian, the Penington Institute believes.

Commenting on the findings of the Penington Institute's Australia's Annual Overdose Report 2020, which revealed there were more than 2,000 overdose deaths for the fifth year running, CEO John Ryan, called on the Federal Government to implement three policies to tackle the issue.

"We simply can't accept that 2,000 of our sons and daughters, mums and dads, and brothers and sisters die every year from a drug overdose," Ryan said.

"Over 400 more Australians die of unintentional overdoses than on the roads every year – and the gap is widening.

"Concerted campaigning, investment in evidence-based policies and community education

"We must tackle our overdose crisis in the same way.

"That is why today, which is also International Overdose Awareness Day, Penington Institute is calling on the Commonwealth to bring down the overdose toll by committing to the following policies:

"Firstly, it must commit to a National Overdose Prevention Strategy. This strategy must leave no stone unturned. It should examine the drivers of overdose risk, access to proven interventions, and the adequacy of our existing efforts.

"Secondly, it must - as a priority - expand the current pilot of Take Home Naloxone from NSW. SA and WA to every state and territory. Naloxone is a safe, proven intervention that saves countless lives.

"Thirdly, the Commonwealth must be realistic about the planned

Of the 2,070 drug induced deaths across Australia in 2020, 1,556 were classified as unintentional. of which 900 involved opioids, 684 were linked to benzodiazepines, with 442 associated with stimulants.

The report also found Aboriginal and Torres Strait Islander people were almost three-times as likely to suffer an unintentional fatal overdose in 2018, with 17.3 deaths per 100,000, compared with six deaths per 100,000 in the non-Indigenous population.

Dispensary Corner

TRUST your wholesaler is the lesson coming from the College of Pharmacists of British Columbia disciplinary hearing.

Canadian pharmacy owner, Laurent Pierre Roy, has landed a year-long ban and a C\$25,000 fine after being found to have stocked up his store with medication and supplies stolen from the Shuswap Lake General Hospital.

In a decision handed down last week, Roy confessed that between "at least 2011 and 2018" he had purchased pharmacy supplies from a hospital employee, who had "diverted" the goods from the hospital's pharmacy.

"Evidence in the form a communication suggested the registrant [Roy] was aware of the diverted nature of the supplies he purchased, and that some of the cash he paid for supplies to the hospital employee were diverted away from hospital accounts," the College reported.

"The registrant may have benefited financially by purchasing the supplies from the hospital employee and then reselling the supplies from his pharmacy."

On top of a 365-day ban from practicing as a pharmacist and the C\$25,000 fine, Roy has been barred from acting as a pharmacy manager or director until 24 Aug 2024, and will be unable to be a preceptor or supervisor of pharmacy students.

He will also have to pass an ethics course if he wishes to return to practice.

LIBERAL MP, Craig Kelly, is free to express his opinions on the use of hydroxychloroquine, but the Australian public should rely on evidence, Pharmaceutical Society of Australia (PSA) National President, Dr Chris Freeman, believes.

Kelly issued an attack on rules restricting the prescribing of the anti-malarial and rheumatoid arthritis treatment after commentators, including US President, Donald Trump, promoted its use for the treatment and prevention of COVID-19.

Speaking in the House of Representatives on Tue 25 Aug, Kelly claimed the National COVID-19 Clinical Evidence Taskforce had based its recommendation to limit access to hydroxychloroquine on research that did not assess how the medication "should be used".

Responding to Kelly's comments, Freeman told Pharmacy Daily that the PSA stood by its calls for limits to be placed on the prescribing on hydrochloroquine.
