Guild brokers CFS partnership

No need to rush COVAX approval

AUSTRALIAN regulators should "hold the line [and] wait for robust data" before approving COVID-19 vaccines, former Pharmaceutical Society of Australia National President, Shane Jackson, believes.

Responding to a statement issued by Federal Health minister, Greg Hunt, welcoming Britain's move to grant emergency approval for the Pfizer vaccine. Jackson tweeted that Australia had the "luxury of time on our side", adding, "confidence in approval processes [is] paramount for vaccine uptake".

A statement from the Therapeutic Goods Administration (TGA) said, "the UK emergency use authorisation is temporary and only relates to a limited number of specific batches of the COVID-19 vaccine BNT162b2 supplied by Pfizer and BioNTech, in response to the increased spread of COVID-19 and loss of life".

"This emergency approval is not a market authorisation, therefore

there is no general authorisation to place this vaccine on the market in the UK," the TGA said.

"This emergency authorisation is in response to the very high disease load in the UK at present, noting that sadly the UK has had over 13,400 new COVID cases in the last 24 hours (Dec 1 2020) and has had over 59,000 deaths."

Meanwhile, the European Medicines Agency (EMA), which is responsible for approving potential COVID-19 vaccines in the EU, has voiced criticism of the Britain's Medicines and Healthcare Regulatory Agency (MHRA) ultrafast emergency approval process.

The EMA started reviewing preliminary data from the BNT162b2 trials on 06 Oct, with the aim of accelerating its approval process, while the MHRA commenced its analysis on 30 Oct, using less information than the EU's regulator.

Former EMA Executive Director,



Guido Rasi, said he was surprised by the British move to grant emergency approval.

"Personally, I would have expected a robust review of all available data, which the British Government has not done," Rasi said.

The EMA said it expects to be in a position to make a decision on whether or not to grant emergency approval for the vaccine on 29 Dec.

Be alert but not alarmed PDL warns

PHARMACISTS are being urged to slow down and "scan everything" to reduce the risk of dispensing errors.

A practice alert issued by indemnity insurer, Pharmaceutical Defence Limited (PDL), noted dispensing errors accounted for close to 60% of issues reported to date in 2020.

PDL reported that the most common types of dispensing errors were, "wrong drug supplied" and "wrong strength supplied of the prescribed drug".

PDL's Professional Officers said the most frequent causes of these errors stemmed from incorrect data entry of prescription details, incorrect selection of the wrong drug or strength in the dispensing software, and incorrect selection of the wrong drug or strength from the shelf.

Similar packaging, brand or drug names, were identified as factors



associated with dispensing errors.

"PDL strongly urges all pharmacists and dispensing technicians to be aware of these areas of risk and to be consistent and vigilant in how they prepare prescriptions for supply," the alert said.

The insurer said pharmacists should "slow down, check carefully and always check the duplication" to avoid errors.

PDL said pharmacists should "scan everything and ensure you actually

check that a product has scanned correctly", while also making sure they scan "every single box" when dispensing multiple packs of a medication.

Separating look alike, sound alike medicines within the dispensary was recommended to mitigate against potential errors.

Pharmacy owners and managers were also advised to schedule regular meetings involving all dispensary staff to discuss risk management and review any "near misses" or errors.

South Australia joins e-script rollout

PHARMACIES across South Australia are now able to dispense electronic prescriptions as the rollout of the new technology continues, with patients across Victoria, the ACT and metropolitan Sydney already having access to paperless scripts.

Federal Health Minister, Greg Hunt, described e-scripts as a "critical component" of the Government's digital health strategy during the COVID-19 pandemic.

"It's bringing the delivery of medicines into the 21st century,"

"Along with the rollout of telehealth, this is a critical component of the Government's utilisation of digital health infrastructure and services, which has been brought to the fore during the summer bushfires and the COVID-19 pandemic.

"These initiatives are critical in delivering health services for all Australians now and into the future."



Welcoming the expansion of e-scripts, Pharmaceutical Society of Australia SA/NT Branch President, Robyn Johns, told *Nine News* that there were a number of benefits to using the new technology.

"It's going to increase the speed and accuracy of dispensing," she

With more than one million

e-scripts issued to date, Federal Minister for Regional Health, Mark Coulton, said the new system had played a significant role in assisting patients in rural and remote parts of the country access medications.

"Technology is helping to overcome the challenges of distances faced by communities in regional, rural and remote Australia when accessing healthcare and medications," he said.

PBS lists Fostair

INHALED combination asthma therapy, Fostair (beclometasone dipropionate and formoterol fumarate dihydrate) has been added to the Pharmaceutical Benefits Scheme (PBS) from 01 Dec.

The medication is indicated in adults (18 years and older) for the regular treatment of asthma where the use of a combination product is appropriate.

Fostair can be prescribed as a daily maintenance therapy in conjunction with a shortacting beta2 agonist, such as salbutamol, as the reliever.
