



One pharmacy town set to lose store

PATIENTS living in the rural Western Australian town of Mullewa will have to make a round trip of almost 200km to access medicines when the only pharmacy in the area closes next month.

Mullewa La Croix Pharmacy owner, Michael Ibrahim, told *The West Australian* that the town's declining population meant the business was no longer viable.

Ibrahim said he had tried to give the pharmacy away, but could not find anyone willing to take on the business in the town which had a population of 447 when the last census was taken in 2016.

With the pharmacy closing on 10 Jan 2021, the nearest pharmacies will be in Geraldton to the west, or south to Morawa - both close to 100km from Mullewa.

"It's going to have a huge impact on people who don't have a car and people who can't drive," he said.

The announcement of the pharmacy's closure comes just over a year after Ibrahim was forced to close another pharmacy he was



co-owner of in Mount Magnet (**PD** 02 Dec 2019).

At the time the Rural Pharmacy Network Australia (RPNA) warned that more pharmacies would go out of business if there was not a Rural Pharmacy Viability Package included in the Seventh Community Pharmacy Agreement (7CPA) (*PD* 04 Dec 2019).

The 7CPA included an allocation of \$24.6 million for rural support programs, including a 10% increase in the Rural Pharmacy Maintenance Allowance (*PD* 18 Jun).

DISCOUNT pharmacy group, Chemist Warehouse (CWH), is preparing an initial public offering in early 2021, *The Australian* reports.

The News Corp publication said the business had been working with advisory firm, Rothschild, to prepare the company structure to be listed on the Australian Securities Exchange.

The paper reported that CWH could be worth up to \$6 billion should owners, the Gance and Verrocchi families follow through on the move to float the business.

Board changes rego exam format

INTERN pharmacists taking their registration examination in 2021 will be the first to sit a new shorter format.

The Pharmacy Board of Australia released details of the revised exam framework yesterday.

From 01 Jan 2021, written and oral examinations will take place three times a year - in Feb, Jun and Oct - in line with the current oral examination schedule.

The duration of the written exam will be reduced from three to two hours, while the oral assessment will be 35 minutes long, 10 minutes shorter than the current duration.

Candidates will be required to have completed 75% of the approved supervised practice hours required for general registration by the respective examination date to be eligible to sit them.

Interns will no longer be required to pass the written exam to be eligible to sit the oral assessment, and will be able to sit either or both

exams during the same period. Candidates will be required to successfully complete both exams within 18 months to be eligible to apply for general registration.

The Board said the changes were "informed by the outcomes of the Intern Year Blueprint project".

"These changes are in line with the Board's strategic objective of efficient and effective regulatory functions, and the objectives of the National Registration and Accreditation Scheme (National Scheme)," the Board said.

"This includes the National Scheme objective of protecting the public by ensuring that only health practitioners who are suitably trained and qualified to practise in a competent and ethical manner are registered."

Today is one of those days, after it emerged that four lions at Barcelona Zoo in Spain had tested positive for COVID-19.

While readers may have ethical issues with zoological gardens, imagine being the poor unfortunate sent into the enclosure to take the swabs, with little more than latex gloves and a face mask for protection!

Media reports have confirmed the testing involved the same process as for humans - a swab down the throat, then up the nose.

Spanish authorities have confirmed that two staff members at the zoo have also tested positive for the virus, as investigations into how the big cats caught the virus continue.

The Veterinary Service of Barcelona has contacted experts at Bronx Zoo in New York for advice, with the American zoo the only other place where large felines have contracted COVID-19.
