Pharmacy sector welcomes stimulus

THE government's new \$17.6 billion stimulus package will help support pharmacists through the COVID-19 crisis, with peak industry bodies saying the funding is "welcome and needed".

The announcement includes grants for small and medium businesses of up to \$25,000, an increase of the instant asset write-off threshold to \$150,000, and the abolition of waiting periods for social security sickness payments for casual workers.

A time-limited investment

incentive will support economic growth by accelerating depreciation deductions, while welfare recipients will receive a one-off \$750 cash payment.

The payments for businesses will apply to those which withhold tax on their employees' salary and wages, with a tax-free payment of 50% of the amount withheld.

Pharmacy Guild of Australia National President, George Tambassis, said the measures were timely and necessary, "at a time when many community pharmacies - along with other businesses across the economy - are feeling stress and facing challenges thrown up by the onset of COVID-19".

He said the package would help directly support Australia's 5,700 community pharmacies and the over 60,000 staff directly employed by the industry.

Pharmaceutical Society of Austalia President, Chris Freeman, said the measures would help many pharmacies continue to provide much needed care to their patients.

Earlier in the week the government also announced a major health funding package to help deal with COVID-19, including the acceleration of electronic prescriptions and funding for home medicine services.

Freeman said all of the measures were "essential to ensure pharmacists can continue their crucial role protecting Australians".

Canberra CCPF

Vic pharmacist meningococcal jabs

VICTORIAN pharmacists will now be able to administer Meningococcal ACWY to people aged 15 years and over, under new arrangements announced yesterday by the Vic state government.

The changes have also seen the lowering of the minimum age for pharmacist-administered measles/ mumps/rubella and whooping cough vaccines lowered by a year, to people aged 15 and up.

The expanded immunisation abilities will become effective from 01 Apr. while on the same date previously announced changes

Changes to the Secretary Approval: Pharmacist Immunisers regulations will also allow greater flexibility for pharmacists to provide vaccinations via mobile and outreach services of a hospital, pharmacy or pharmacy depot, with all of the developments welcomed by the Pharmaceutical Society of

Australia.

"At a time when our health care system is under extreme pressure, increasing options for Victorians to access vaccination services is extremely helpful," said Pharmaceutical Society of Australia Victorian President John Jackson.

"Pharmacists are well trained in the administration of these vaccines and are more accessible to the community than any other health provider," he said.

THE challenge of tackling the COVID-19 crisis is a complex and urgent proposition, made even more difficult when the conference proposing to come up with the way to stop its spread is cancelled due to, you guessed it, COVID-19.

The British Council on Foreign Relations dropped a roundtable conference which was meant to take place last week, with the meeting's organiser saying "the Council on Foreign Relations, like many other organisations, has suspended all in-person events effectively today through at least o3 Apr...our foremost concern is for the health and safety of Council members".

Let's just hope there is no meeting scheduled to talk about ways to stop COVID-19 prevention meetings from being cancelled.

Sigma pulls out of APP

SIGMA Healthcare has confirmed its withdrawal from next week's Pharmacy Guild of Australia APP conference on the Gold Coast.

The move follows a decision by Sigma to also postpone this year's Amcal and Guardian Retail conference (PD 11 Mar), which was also scheduled to take place in the lead-up to APP.

"Sigma's number one consideration is to limit the potential risk to attendees, given the spread of coronavirus (COVID-19) in Australia," the company said.

"This decision is supported by recent events including the World Health Organization's declaration of a pandemic, and recent confirmed

cases in Australia and Queensland in particular," a statement added.

A spokesperson for Sigma said it was unclear at this stage whether the pullout would impact the planned participation of the company's CEO, Mark Hooper, who had previously been announced as part of a key industry panel at APP.

Hooper, who is also Chair of the **National Pharmaceutical Services** Association, continues to be listed on the APP agenda as a member of the key State of the Industry panel taking place at 8.30 on Thu 19 Mar.

Sigma Healthcare is also still highlighted on the APP2020 website as a "Principal Sponsor" of the event, alongside Pfizer, Arrotex, GuildSuper and Guild Insurance.

A COMBINED meeting of the National Registration and **Accreditation Scheme last** month has seen the release of an ambitious strategy to embed cultural safety into the Australian health system.

Strait Islander health experts, regulators and other health organisations, have backed the plan which aims to create a "culturally safe health workforce through nationally consistent standards, codes and guidelines across all registered health practitioners in Australia".
