# **Preventing vector-borne diseases**

PHARMACISTS around the world are being urged to play their part in combating vector-borne diseases, with environmental and societal changes contributing to the proliferation of these illnesses.

Launching a new publication, Vector-borne diseases: A handbook for pharmacists, International Pharmaceutical Federation (FIP) President, Dominique Jordan, said pharmacists have a key role to play in preventing the spread of diseases such as malaria and dengue, which have spread beyond tropical and subtropical areas due to climate change, deforestation and migration.

"Vector-borne diseases account for nearly one fifth of all infectious diseases and cause over 700,000 deaths every year." he said.

"In addition to their health burden, their economic impact is enormous, especially so because they disproportionately affect the world's poorest countries.

"Combating vector-borne diseases is fundamental for achieving many of the United Nations' Sustainable Development Goals.

"Most of these diseases are preventable and pharmacists are ideally placed to support

# Vaping big tobacco's Trojan Horse

**"FALSE** claims" about the use of e-cigarettes as smoking cessation aids being made by 'big tobacco' lobbyists need to be called out, pharmacist-turned Federal Australian Labor Party MP, Emma McBride believes.

Speaking in the House of Representatives yesterday, McBride, backed bipartisan calls for the Government to hold firm on plans to limit access to vaporised nicotine and e-cigarettes, noting the Public Health Association of Australia had described vaping as a "Trojan Horse".

"As the only pharmacist in this place and someone trained in nicotine addiction and smoking cessation, I thought it was important to bring the debate about e-cigarettes back to where it should be and to examine some of the key facts," she said

"First, no brand of e-cigarette has been approved by the Therapeutic Goods Administration (TGA) for assisting people to quit smoking. "Systematic evidence and quality trials have found no conclusive evidence that e-cigarettes are an effective quit aid or that they are more effective than approved, established methods for quitting smoking.

"According to National Health and Medical Research Council reports, e-cigarette use in nonsmokers is associated with future uptake of tobacco cigarette smoking, countering claims that e-cigarette use is mainly by long-term smokers to help them quit.

"The market for e-cigarettes is clearly young people and the tobacco industry's profit drivers to addict a new generation.

"Second, Australia has one of the lowest smoking rates in the world, despite what the lobbyists might tell you.

"Australian Institute of Health and Welfare data published in Jul shows daily smoking rates to be at an all-



time low of 11%.

"This has been hard fought in the face of strong opposition from big tobacco and vested interests.

"We must call out false claims by lobbyists that reductions in smoking prevalence have stalled or slowed as a means of aggressively promoting e-cigarettes as a quit method.

"Let's debunk a myth: the claim that e-cigarettes are safe or less harmful than smoke cigarettes.

"There is no scientific basis for this claim."

# Dispensary Corner

IT APPEARS that not everyone is happy about the ongoing success of clinical trials for the various COVID-19 vaccines which are under development.

There was a major sell-off of gun manufacturers on the US stock market overnight after the release of promising preliminary data from Pfizer's vaccine trial, which found it was 90% effective.

Investors who had been banking on increased unrest were also discouraged by the clear result in the US election.

Smith & Wesson fell more than 9% in trading, similar to rival Sturm Ruger & Co, while ammunition retailer Vista Outdoor slumped 12%.

THERE was also some good news for residents of Washington state in the US - it's now possible to compost dead bodies there, as an alternative to burial or cremation.

The state's first legal corpse composting company, with a website appropriately named recompose.life, is now taking bookings under a new law which allows bodies to be placed in a receptacle along with other organic material to speed up the decomposition process.

The site promises customers the opportunity to "become soil when you die," providing an end-of-life option that strengthens the environment rather than depleting it.

Each person who chooses the new option saves one metric ton of CO<sub>2</sub> from entering the atmosphere.

#### AFTER close to 12 months without an in-person conference, the Pharmacy Guild of Australia is set to host a new 'invite only' event in Brisbane in Feb 2021.

Former Guild National President, Kos Sclavos, said the three-day Pharmacy Groups Symposium will be limited to 180 attendees and will take place from 08-10 Feb at the Sofitel Brisbane Central.

The event is set to cover aspects of the Seventh Community Pharmacy Agreement, electronic prescriptions and issues around pharmacy rentals.

"From a strategic point of view, the Pharmacy Groups Symposium is a key event for the Guild," he said.

"Pharmacy brands/banner groups play an important role in the viability of community pharmacy, and we want to ensure we are working hand-in-hand with our pharmacy groups as we implement the new agreement.

"With the pharmacy industry's major conference - APP - a few months later in May 2021, there will
