COVID, bushfire 'double whammy'

WESTERN Australian pharmacies are facing a "double whammy" of crises as bushfires and fresh COVID-19 restrictions spark panicbuying.

Pharmacy Guild of Australia WA Branch President, Andrew Ngeow. told **Pharmacy Daily** that pharmacies across the state saw patient numbers in-store surge as Premier, Mark McGowan, announced a five-day lockdown of the Perth Metropolitan, Peel and South West regions, following the detection of a COVID-19 case linked to a hotel guarantine worker.

Ngeow said pharmacies in Perth saw a rush for face masks "as the Premier was making the announcement", noting the State was being hit with a "double whammy of bushfires and COVID".

With more than 70 homes destroyed by the fires, Ngeow praised the efforts of pharmacy workers in the face of the twin

crises, noting that some lived in fire-affected areas.

Meanwhile, Wizard Pharmacy Professional Services Manager, Jeanette Drury, told Pharmacy Daily that the group's stores were taking steps to tackle panic buying.

"With the WA Government's announcement on Sun, we saw increased panic buying, especially of masks," she said.

"Our pharmacies have all been very focused on maintaining stock levels to satisfy demand as best as possible, impacting our suppliers and wholesalers.

"We have implemented quantity restrictions on some essentials to ensure safe and fair distribution for all over this period, which we hope puts our customers at ease during this difficult time."

Drury said Wizard Pharmacy teams had moved "quickly and effectively" to implement the mandatory mask rulings, while

Drury noted that the bushfires were fueling concerns about air quality, but suggested the "lockdown mandate keeping people in their homes should actually help people with respiratory conditions as they will be less exposed to air pollution".

Time for face-toface rehab

HOSPITALS are being urged to prioritise the resumption of face-to-face rehabilitation programs for heart attack survivors.

The call was made after a Heart Foundation survey revealed that just 14% of patients recovering from a heart attack who were undergoing rehabilitation using telehealth services completed their program, while 73% of those who had attended in-person services in the past six months had finished their scheduled rehab.

Heart Foundation General Manager of Heart Health, Bill Staveski, said that while telehealth services had been beneficial during the COVID crisis, as restrictions ease faceto-face rehabilitation should be the standard form of care for patients. **LEGISLATION** aimed at boosting pharmacists' abilities to substitute prescribed medications is gaining support from both sides of politics.

Australian Labor Party Deputy Manager of Opposition Business, Mark Butler, voiced support for the Therapeutic Goods Amendment (2020 Measures No 2) Bill 2020, during yesterday's sitting at the House of Representatives.

"Members of this House will have heard story after story, for some years before COVID, of medicine shortages in Australia," he said.

"Under the existing legislative regime, pharmacists are able to substitute a different brand of the same medicine when the brand that has been prescribed by the prescribing doctor is not available or is in short supply.

"This bill will allow pharmacists to supply not only a different brand of the same medicine or the same therapy but a different therapy altogether.



"They won't have carte blanche to do this under this legislation.

Bipartisan support for substitution

"The Secretary of the Department [of Health] will have the ability to prescribe a particular type of medicine that can be substituted it's not carte blanche; it will be a particular type—and pharmacists will be able to do that.

"This is important when a patient needs a particular therapy and that brand's not available, and a different brand of the same therapy is not available, and the prescribing doctor is not available to issue a new prescription.

"So there are circumstances where this is important for quality of care."

Butler noted that members of the "medical community" had expressed concerns over the legislation, but added that "in their current form, we think these provisions are worthy of support, and we will be supporting them."

Handyside picks up UQ scholarship

PHARMACY PhD student, Louisa Handyside, is set to focus on instilling a culture of research in community pharmacy, after being named as the 2021 Alan Grant-Taylor Memorial Scholarship recipient.

Pharmaceutical Society of Australia National President, Associate Professor Chris Freeman, and UQ Faculty of Health and Behavioural Sciences Director of Interprofessional Education, Associate Professor Neil Cottrell, are set to act as advisors.

Handyside said she "caught the bug for research" while she was completing an extended research project as part of a Masters of Pharmaceutical Public Health at James Cook University.

"This scholarship will give me the opportunity to build my research skills and explore ideas with other inspiring pharmacists," she said.

"I hope to take steps to instil a culture of research in community



pharmacy - opening the door to new insights and continual improvements in pharmacy practice, medicines use and patient care.

"My PhD will explore how we can enable primary care pharmacists to be involved with high quality research that makes a real difference.

"I'll investigate how pharmacists can contribute ideas for research projects, invite their community to get involved, learn more about research and develop supportive relationships with other pharmacists and academics.

"Ultimately, I'll be exploring how to support pharmacists to find answers to the most pressing medication-related research questions in their community."

Handyside added that the scholarship would ease the burden of financial concerns while she completes her PhD.

TWC COVAX training events

TERRYWHITE Chemmart (TWC) is set to host a virtual vaccination event next week as the profession prepares to support the rollout of COVID-19 vaccination (COVAX) services.

The group will also conduct face-to-face training events in Mar and Apr, to ensure the network's 1,500 pharmacists are equipped with the latest information to support their communities.

TWC Chief Pharmacist, Brenton Hart, said the group was providing support to its pharmacy owners with the Federal Government's expressions of interest form.

Hart added that TWC has been working on an educational campaign to help address vaccine hesitancy amongst the community in the build up to the rollout of the COVAX program.

Cannatrek signs CWH partnership

BREAST cancer is a serious disease, so you have to admire the chutzpah of a group of people who were arrested overnight for trying to change Los Angeles' iconic Hollywood

Under the deal Cannatrek is set to train and education CWH pharmacists about "the benefits, any potential issues and applicability of medicinal cannabis products for a range of illnesses", the company said.

The company will also become CWH's exclusive telehealth partner for medicinal cannabis alongside general telehealth provider, Instant Consult, while also providing access to touch screens located in-store to enable patients to make enquiries about their eligibility to access CBD medications.
