CONSUMER Price Index (CPI) data released today highlights the need for action to be taken to ease the cost of prescription medicines, the Pharmacy Guild of Australia believes.

Guild National President, Trent Twomey, said the figures were a reminder that many households are struggling with the rising cost of living and have been forced to make choices between buying medicines on the Pharmaceutical Benefits Scheme (PBS), paying bills or purchasing groceries.

"Community pharmacies are seeing patients struggling to afford medicines from pay-cheque to paycheque and asking which medicines they can afford to skip for that month in order to meet other household costs," he said.

"There aren't many levers the Government can pull to reduce the cost of living but it does have the ability to make PBS medicines more affordable for middle income households.

"For many households, these medicines are the cost of staying alive.

"Research by independent pollster Insightfully found that almost a third of voters (30%) say

they or their families have found it difficult to afford medicines over the past three years.

"This is especially affecting middle income households, with over a quarter (26%) of people who aren't entitled to a concession card struggling to pay for their scripts at the point of sale.

"That's up four points since Jan this year, when the PBS copayment went up again, bringing the maximum cost of PBS medicine for non-concession card holders to \$42.50, doubling since the year 2000.

"Some people have been skipping medicines entirely, with 17% saying they have been unable to purchase their medicines.

"This is an issue right at the intersection of the voter priorities of health and cost of living.

"It is heartbreaking to see patients forced to choose between buying their prescription medicines and buying other essentials like food and fuel.

"The token cash handouts landing in people's bank accounts today will do nothing to address the growing unaffordability of health-preserving essential medicines."

Pharmacy owner cops 18-month ban

QUEENSLAND-BASED pharmacy owner, Qui Van Bui's professional registration has been cancelled for at least 18 months after being found guilty of unsatisfactory professional conduct.

The NSW Civil and Administrative Tribunal heard that between Jul 2015 and Sep 2016, Bui had purchased and received Schedule 4 and S4D medications from fellow pharmacist, Jason Nguyen (**PD** 04 Nov 2019), in the car park of Sydney's Star Casino, to distribute to members of the public without valid prescriptions.

In Sep 2017, the Pharmacy Council of NSW imposed a number of conditions on his registration, barring him from possessing, supplying, dispensing, administering or manufacturing benzodiazepines, which were removed in Jul 2019.

and subsequently became the proprietor of Westbrook Pharmacy, in the State's southeast.

In a submission to the Tribunal, Bui reported that since moving to Westbrook he has devoted one afternoon a week to professional education to ensure that the admitted and proven conduct relating to dispensing of S4D and S8 medicines is not repeated. He also told the Tribunal that

he has not been to a casino since 2017, and "no longer has any interest in gambling".

In a letter submitted to the Tribunal by employee pharmacist, Rabia Khan, who has worked one day a week at Westbrook Pharmacy over the last three years, she described Bui as "a responsible pharmacist who always puts his customers first", noting the he "displays remorse and always helps staff to meet practice standards".

Despite positive references from Khan and others of Bui's improved practice, the Tribunal ruled that "the available material does not support a finding that Bui is reformed".

The Tribunal cancelled Bui's registration, barring him from seeking a review of cancellation period for at least 18 months, and ordered him to pay costs.

Indigenous vax campaign launched

EFFORTS to improve uptake of childhood immunisations in Aboriginal and Torres Strait Islander populations is being given a shot in the arm with a new Federal campaign.

The Department of Health is aiming to encourage Indigenous parents and careers to get their children vaccinated on time through the National Immunisation Program. In a statement released yesterday, the Department noted that "vaccination rates for Aboriginal and Torres Strait Islander Children have decreased over recent periods, particularly at one and two years of age".

The campaign aims to build on the previous two phases of the Childhood Immunisation Education Campaign, using "search, social and online channels" to reach parents.

It will also use video, posters, brochures and personal stories to highlight the importance of getting children vaccinated on schedule.

Pharmacy to Indigenise curriculum

EFFORTS to assist a naturopath to produce fake COVID-19 vaccination cards have cost a Californian pharmacist her job.

Former Adventist Health Ukiah Valley Hospital Director of Pharmacy, Ranna Shamiya, was one of three people US Department of Justice prosecutors believe assisted naturopath, Juli Mazi, to sell falsified vaccination records and dodgy "COVID cures" North Bay Business Journal reported.

The Department alleged that Shamiya used her position to find legitimate lot numbers for authorised COVID-19 vaccines, which she passed on to Mazi.

The naturopath then used the numbers to produce fake vaccination cards, so her patients could falsely claim to have been immunised.

If convicted Shamiya could face up to five years behind bars, a US\$250,000 fine and three years of supervised release.

Reflecting on the investigation a spokesperson for the hospital said it was "a legal matter, and it's disappointing".

"I would note that at no point did this jeopardise our commitment to the safety of our patients," the spokesperson said.

"This is not a patient-facing charge she's accused of."

Meanwhile, Mazi has pleaded guilty to one count of wire fraud and a further charge of providing false statements related to healthcare matters. **PHARMACY** educators are taking steps to ensure the profession's workforce is equipped with a knowledge and skills to provide culturally safe care to Indigenous Australians going forward.

The Australian Pharmacy Council (APC) and the Council of Pharmacy Schools Australia and New Zealand (CPS) are developing a network - the Indigenous Health Strategy Group (IHSG) - to "Indigenise pharmacy curriculum".

APC Director and Leaders in Indigenous Pharmacy Profession Education (LIPPE) lead, Associate Professor Faye McMillan, welcomed the development.

"Twenty-one years since I graduated as the first Aboriginal person to graduate as a pharmacist in this country, I am proud to see the work that is taking place with LIPPE and the impact that this will have on the future pharmacy workforce," she said.
