Rural healthcare 'untenable': Guild

PHARMACISTS need to be empowered to play a greater role in the delivery of primary healthcare services in rural areas to ease GPs' workloads, Pharmacy Guild of Australia NSW Branch President. David Heffernan, believes.

In an opinion piece published in The Land on Sun, Heffernan noted that patients in some parts of rural NSW have been forced to wait more than six weeks for an appointment to see their GP, due to workforce shortages

"Patients shouldn't have to wait days or even weeks to access something like a travel vaccination, cholesterol test or to treat a simple skin infection," he said.

"An asthma attack doesn't wait for a GP appointment, a urinary tract infection doesn't wait for a GP appointment.

"These are common, manageable health conditions that could be safely delegated to well-trained local pharmacists with appropriate training.

"Enabling pharmacists to provide everyday health services is an obvious, practical step that can be taken to give quicker access to healthcare support now.

"We are not talking about pharmacists taking on major diagnostic work.

"We are talking about routine health care like administering the full range of vaccinations, travel medicine, antivirals, or conducting flu screening.

"This will free up GPs to deal with more complex issues.

"Queensland has already recognised this by permanently offering treatment of urinary tract infections at community pharmacies. The pharmacist follows the same protocol as a GP and the

program was supported by both sides of politics.

"The health system has some complex challenges and there will be a range of measures needed. "Regional community pharmacies are ready to be part of the solution."

QUM needs appropriate funding: PSA

PHARMACISTS need to be adequately funded to take advantage of opportunities to play a greater role in the promotion of quality use of medicines (QUM), the Pharmaceutical Society of Australia (PSA) believes.

Marking the seventh annual Meds Safety Week, which runs until 13 Nov, PSA National President, Dr Fei Sim, called on the Federal Government to look to provide pharmacists with access to the Medicare Benefits Schedule (MBS), to fund a range of pharmacist-led services.

Sim noted that evidence showed that close to half of the 400,000 emergency department presentations across Australia each year were the result of medicine-related problems, which pharmacists could help prevent.

"The use of medicines is the most common intervention in health care," she said.

The safe and appropriate use of medicines transforms people's



health for the better.

"Pharmacists already play an important role in medicine safety, but there are opportunities for us to be doing more.

"Pharmacists, as medicine safety experts, should be embedded wherever medicines are used to reduce the risk of medicine-related problems.

"All pharmacists, regardless of their practice setting, continue to play an increasingly important role in ensuring the QUM.

"As pharmacist [led] services continue to expand, we need to ensure that consultations are appropriately funded based on time and complexity, possibly through the MBS.

"This is something that PSA has been calling on the Federal Government to explore to ensure that access to expert pharmacist advice remains available to all Australians."

Pharmacy group backs sun safety

The group has launched a range of materials as part of the campaign, which it will distribute through its pharmacists and community partnerships with children's sports organisations.

Dispensary Corner

A NEW mum who breakfasted on a poppy seed bagel in the USA the morning before she delivered her baby has been battling with authorities, after a drug test taken on admission to hospital came back positive for opioids.

New Jersey-based Caitlyn Ricci took to social media to explain her plight and issue a warning to other expectant mothers.

She said she arrived at the hospital at 39 weeks to be induced, and was asked to give a urine sample.

"They drug test you in New Jersey at hospitals, which is not a big deal, I wasn't worried about it," she said.

However "they came back and told me my drug test is positive for opioids. Opioids! I was like, 'No, definitely not. Did you mix my sample up? I'm very confused'."

The nurse mentioned poppy seeds, at which point she and her husband realised they had eaten bagels earlier that day.

She subsequently delivered her new son after a long labour and eventually an emergency Caesarean, and the baby was tested for opioids too.

"So his test comes back negative, we think everything is fine," Ricci said.

"No, apparently now it needs to be reported to the state, like literally child protective services this needs to be reported to."

That ended up with an in-hospital interview, in turn requiring a check of her home and another drug test four days after the baby was born.

She urged midwives and obstetricians to tell pregnant women to avoid poppy seeds during their last trimester.

"I don't think anyone should have to go through some of the things I went through.

"I would have skipped the bagel had I known this was going to happen," she said.

CHEMIST Warehouse (CWH) says its new web-based marketplace (PD breaking news) takes the company "one step closer to being Australia's one-stop digital retailer".

France expands vaccine access

AUTHORITIES in France are moving to improve vaccine uptake by giving pharmacists the green light to administer all types of vaccinations. **Previously French**

pharmacists were limited to providing, flu, COVID-19 and monkeypox shots.

Additional legislation is set to be passed next year to allow pharmacists to prescribe certain vaccines that currently require a prescription.



assessment of the available platforms currently in use here.

"Marketplacer has an impressive portfolio of large retailers in Australia and met other functional and capability criteria when we were looking for a technology vendor with which to partner."

Blatt said there had been some technical difficulties with the integration, with CWH retrofitting the new marketplace into its existing e-commerce framework and technology stack.

"While this created challenges, it was the most suitable strategy for our intentions," he said.

"Not only was it important to understand how every main area of CWH operated, but also all the associated processes and workflows.

"Marketplacer has worked very closely with us for the past

12 months and the results of this effort are now live for our customers," he added.

Benefits for suppliers will include opportunities to sell more of their products to a "highly active and engaged audience", Blatt noted.

"For new suppliers, we now have an opportunity to support brands that may not have conventionally been in a position to be stocked and shelved in our stores".

The updated site, which is now live at chemistwarehouse.com.au, touts its credentials as "Australia's #1 Online Pharmacy", and offers in-store click and collect options as well as free shipping for orders over \$50 along with a flat rate of \$8.95 for orders under \$50.

Ramsey awaits sentencing

THREE firms, Natural Franchises Pty Ltd, SARMs International Pty Ltd, and Smart Labs Pty Ltd, and their sole director, Christopher Ramsey, have entered guilty pleas to more than 200 offences related to the manufacture, supply and promotion of unapproved therapeutic goods.

The Therapeutic Goods Administration (TGA) revealed that it conducted an extensive investigation in 2019 and 2020, which found Ramsey and his companies were manufacturing and selling selective androgen receptor modulators (SARMs) and nootropics, that were not included on the Australian Register of Therapeutic Goods (ARTG), in accordance with the *Therapeutic Goods Act 1989*.

The regulator described SARMs as "experimental medicines claimed to build muscle mass and bone density", noting they are scheduled as Prescription-Only medications in Australia.

In addition to the promotion and sale of products not listed on the ARTG, the TGA's investigation found that a product supplied by one of Ramsey's companies, Natural Franchises Pty Ltd, contained the Schedule 10 ingredient, Cardarine, which is prohibited in Australia due to being a potential carcinogen.

"Sentencing for this matter is set for hearing at Downing Centre Local Court in Sydney on 15 and 17 Mar 2023," the TGA said.

Low-dose aspirin doesn't save falls

DAILY low-dose aspirin does not reduce the risk of factures or serious falls in healthy older men and women, according to a new paper published this week by JAMA Internal Medicine.

The research is a sub-study of the ASPREE (ASPirin in Reducing Events in the Elderly) trial which aimed to determine if daily lowdose aspirin (100mg) reduces the risk of falls.

The placebo-controlled trial led locally by Monash University, which involves 16,703 Australians and 2,411 in the USA, found the risk of first fracture was similar in the aspirin and placebo groups, but the risk of serious fall was statistically significantly greater in the patients taking aspirin, with a total of 884 falls compared to 804 in those on the placebo.



The findings indicate a potential additional risk for the use of lowdose aspirin in initially healthy older people - but the authors also noted that the findings don't apply to those with a medical reason to take aspirin, such as after a heart attack. Monash Executive Director of Research and Innovation, Associate, Professor Anna Barker, noted that "older adults with a medical reason to take aspirin should continue to do so".

"[But] for healthy older people without heart disease or prior stroke, aspirin appears to provide little benefit and may do more harm than good by increasing a person's risk of having a serious fall.

"Falls are frequent for many older people and can have several negative impacts including fractures, soft tissue injuries, loss of confidence and independence.

"They are a frequent reason an older person attends an emergency department and needs to receive care in hospital," Barker said.
