Guild aligns with nurses

THE Pharmacy Guild has responded favourably to a submission for nurses, like pharmacists, to work to their full scope of practice, as a way to meet the growing health needs of an ageing population.

The Guild was responding to the Australian College of Nursing's (ACN) submission to the Cormack Review, otherwise known as 'Unleashing the Potential of our Health Workforce Review'.

Guild National President Trent Twomey (pictured) said nurses have a greater role to play in servicing the community and patients.

"The ACN's recent submission points out the benefits to patients, consumers, the health workforce and taxpayers of nurses working to their full scope of practice.

"The Guild agrees with Australia's nurses," Twomey added.

"Unfortunately, there is enough illness in Australia to keep all health professionals busy, but we need to work smarter not just harder to



meet the needs of our patients.

"Like pharmacists, nurses and other allied health professionals have the skills, knowledge and training to treat and diagnose more everyday health conditions.

"The Cormack Review is a rare opportunity to redesign the healthcare system so that all health professionals are working together in the interests of patients and the community," said Twomey.

"Pharmacists and nurses working to our full scope and expertise as part of the healthcare team will improve patient access and relieve pressure on our overstretched health system, especially emergency departments and general practice," he concluded. JG

Near-fatal error

A TODDLER was overdosed on seizure medication when a prescription was incorrectly labelled with a dosage 10 times the required amount.

The prescription bottle was meant to say 1ml but through error it was printed as 10ml, causing near-fatal symptoms and hospitalisation.

Health Minister Chris Picton said, "my heart goes out to the family for what has been a distressing experience".

"Private community pharmacists on the whole do a great job, but where serious medication errors occur it is incumbent upon the pharmacy to review what occurred and if necessary to be reviewed by the national pharmacy board."

A spokesperson for the Ahpra and the Pharmacy Board said, "a pharmacist has to exercise an independent judgement so the medicine is safe and appropriate for the patient".

Dispensary Corner

THE Wiggles' song *Hot Potato* was being played loudly, and on a loop, at the Graham **Bricknell Memorial Music** Shell in Bunbury, 200km south of Perth, in what the local council conceded was a bid to discourage people from loitering and congregating at the popular site.

The Wiggles said they're deeply disappointed that Western Australia's largest regional city is using their music to drive homeless people away from a regularly used shelter and sleeping spot.

In a statement released to the ABC, a spokesman for the Wiggles said the decision ran counter to their songs' purpose and message.

"The Wiggles' music is created to bring joy and happiness to children and families around the world," the spokesperson said.

"We are deeply disappointed to hear that it is being used in any other way."

The ABC understands the band has approached the City of Bunbury to request the song no longer be played.

In a statement, Bunbury Mayor Jaysen Miguel said the playing of looped music was an established way - across the state - of "discouraging people to congregate permanently in an area and would deter antisocial behaviour".

The City of Bunbury declined to comment on the band's statement and request, though as of late on Thu last week the song was stopped, the news outlet had reported.

"Amazing assets" awarded

THE Medicines Management Conference 2023 took place in Cairns recognising the depth of talent in the medical field.

Dr Karlee Johnston (pictured R) received the 2023 Society of Hospital Pharmacists of Australia's (SHPA) Australian Clinical Pharmacy Award.

A practicing clinical pharmacist, Johnston's groundbreaking research into 'pharmacist burnout' generated extensive publication, including 'The burden of COVID-19 on pharmacists', which was one of the 10 most downloaded papers from the Journal of the American Pharmacists Association in 2021.

'Karlee is an amazing asset to our profession whose impact is felt widely through her vast contributions to research the care she delivers to her patients and her genuine love for teaching," said SHPA President Tom Simpson (pictured top).

Russell Levy (pictured below L), a clinical authority on infectious diseases, with significant expertise in oncology and haematology, and pioneer of SHPA's annual Pharmacy Forecast Australia, was awarded SHPA's Medal of Merit.

"Russell is a trailblazer of the profession, and thanks to his foresight and determination we have insight into the future of pharmacy," Simpson added.

The 2023 SHPA Early Career



Pharmacist of the Year was Ashleigh Lawrence (WA), recognised for being a driver of innovation and a source of inspiration and mentorship for other early career pharmacists.

Honoured with the 2023 SHPA Technician of the Year was Tara Clayson-Fisher (Tas), recently appointed as the first Technician Observer to the SHPA Board of Directors and also inducted as an SHPA Fellow.

The VAD Pharmacy Project Team took out the 2023 SHPA Hospital Team of the Year honour for forging a safe and successful pathway for the operation of Voluntary Assisted Dying in Tas, while Emma Dall'Alba (Qld) won the 2023 SHPA Resident

Kay Dunkley won the prestigious Fred J Boyd Award (PD 03 Nov), and first female pharmacist MP Emma McBride (pictured below R) was also recognised for the rapid uptake of the ANZCAP Program (PD Fri Breaking news). JG
