# Talks disrupted by angry pharmacists

A FURIOUS protest in Parliament House by 200 pharmacists disrupted question time yesterday and sparked a warning from the Federal Health Minister that "they had broken a pledge to negotiate the funding deal in good faith", reported The Sydney Morning Herald.

The protesters shouted obscenities and heckled Prime Minister Anthony Albanese before storming out of the House of Representatives, just three days after Labor struck a peace deal with the Pharmacy Guild over its 60-Day Dispensing policy.

Health Minister Mark Butler told Parliament he had agreed with the Pharmacy Guild last week to bring forward talks on the next funding agreement to Mar 2024 after the industry had called for \$3.3 billion in extra funding to help with the impact of the prescription changes and other cost pressures.

But he sent a warning to the pharmacies that the government expected the good faith to be "reciprocated" in the months of talks over the new deal.

"That commitment was contingent upon a decision by the Guild to stand down their campaign against this measure," Butler said, after the pharmacists had heckled from the public galleries and drawn warnings from officials.

"A reasonable person in this building might question whether that commitment is being delivered upon," Butler told the publication.

The Speaker of the House of Representatives, Milton Dick, has asked for a security review into the behaviour of the protesters toward Parliament House staff as well as concerns that members of parliament had signed pharmacists into the building.

Employment Minister Tony Burke, who leads government business in the House, said parliamentary staff had allegedly been subjected to verbal abuse by some pharmacists on their way out.

Independent MP Zali Steggall expressed dismay at the protest and accused the Coalition of supporting the disorderly behaviour in Parliament.

While the Coalition complained about her accusation at Question Time, Coalition MPs gestured to the pharmacists in the public gallery while accusing Butler of failing to consult them on the policy.

The Guild has stated it was not involved in the protest. JG

#### **APC** applications

**THE** Australian Pharmacy Council (APC) will accept accreditation applications for Medication Management Reviews and the Aged Care On-site pharmacist program.

From 01 Sep, education providers can apply to have their programs accredited against APC's standards.

CEO Bronwyn Clark stated that accreditation is a critical enabler for enhancing the safety and quality of healthcare and expanding scope.

"APC supports the growth and expansion of pharmacist roles, and accreditation of programs to deliver Medication Management Reviews and aged care on-site pharmacist services will assist in quality outcomes for the community.

"As the trusted body to assure quality in pharmacy education, we're thrilled to expand our accreditation work into this area," said Clark.

"We look forward to receiving applications from education providers who will then be able to credential pharmacists for these roles."

The Department of Health and Aged Care provides funding for pharmacists to undertake specific roles via targeted programs.

One requirement for funding is that a pharmacist must complete an education program accredited by APC.

# Sigma pulls off Summit

#### Apply tax evenly

THE Pharmacy Guild of Australia, Victoria Branch President, Anthony Tassone said that while no one likes paying taxes, the payroll tax is a well-established cost of running a business or a health practice, including pharmacies, as well as other primary healthcare and allied health professional practices.

"If the Victorian Government grants a payroll tax exemption to some GP practices, the government should do the same for all primary healthcare professionals," he stressed.

"Why should one health profession receive an exemption and not others?

"Many hard-working health professions, including community pharmacies, dentist practices and physiotherapy clinics among others, are already complying with the legislation and paying their fair share of payroll tax," said Tassone.

"Nobody likes paying tax. "Tax should be as low as it can be, tax should be fair, and tax should be paid.

"Payroll tax should be applied consistently for all.

"It's important that patients have more options when it comes to primary healthcare due to the challenges of getting an appointment with a GP in a timely manner.

"Exemptions in payroll tax and special treatment for general practice is not the answer," Tassone added. JG

### Dispensary Corner

**EARLY** this year, shortly after China lifted strict "zero-Covid" measures that had kept it isolated for three years of the pandemic, Lydia Huang headed across the border to Hong Kong to do something she felt couldn't wait any longer.

"Finally got to freeze my eggs," Huang, 38, a financial professional from Shanghai, wrote on social media, NBC News has reported.

"It was what I had always dreamed of."

Egg freezing has become a growing topic of discussion in China, where officials alarmed by the country's first population decline in six decades are trying to boost the birth rate even as young people are increasingly putting off marriage and childbearing or avoiding it altogether.

But unmarried women like Huang are legally barred from undergoing the procedure in China, prompting some to do it elsewhere at a much greater cost in a bid to extend their reproductive window.

After posting about her experience, Huang said she received a flood of messages from women asking for advice or sharing their own experiences.

Current law in the country, where having children out of wedlock is frowned upon, prohibits unmarried women from using any assisted reproductive technologies, including egg freezing.

Men are allowed to save their sperm regardless of their marital status, NBC News has reported.

# Eye tracking reads gaze

MORE than 50% of Australians living in residential aged care facilities have a dementia diagnosis, with aged care services around the world preparing for the number of older people aged 65 years and above to double in the next 30 years.

For the first time, experts at the Caring Futures Institute at South Australia's Flinders University are using eye-tracking technology to ensure that the voices of all older people are heard to drive effective and positive change.

"Older adults living with a diagnosis of dementia in residential care can find it challenging to respond to traditional text-based questionnaires to rate the quality of life and quality of care they receive.

"By using eye-tracking technology we can collect crucial information about how older people with dementia read and respond to questionnaires, helping to understand how we can better design and adapt these for their needs," said senior research fellow Dr Rachel Milte, the lead for the study published in the Quality of Life Research.

In the study, researchers asked



41 residents ranging from 'no' to 'mild or moderate' cognitive impairment to complete a simple quality-of-life survey while sitting at a computer installed with eyetracking technology.

In real-time, the technology records where participants focus their gaze while completing the questionnaire, the text they read and don't read, and parts of the questionnaire they spend the most time looking at.

"This information helps us to design questionnaires which are easier for older people to complete, as well as understand whether they are reading all the key information to give high-quality data for use in assessing the quality of care in residential aged care homes," explained Milte.

# 'Real opportunity' to fix 60DD

**PHARMACY** Guild National President, Professor Trent Twomey has told Guild members that negotiations to bring forward an 8th Community Pharmacy Agreement (8CPA) are a real opportunity to resolve the problems created by 6o-Day Dispensing (6oDD).

Speaking at the opening plenary session of the Pharmacy Connect Conference in Sydney on Fri, Twomey said community pharmacists needed an agreement to start as "soon as practicable".

"It allows us to implement sufficient funding mechanisms to accommodate the disruption of 6oDD," he told delegates and members.

"It will provide certainty and viability of community pharmacy for the next five years."

The Guild suspended its campaign on 6oDD after the Federal Government agreed in principle to an early commencement date of the 8CPA on 01 Mar 2024, 15 months before the current CPA was due to expire.

"The Guild's success of our public information campaign means we enter negotiations in a position of considerable strength," Twomey explained.

It's the first time in the 30-year history of the CPA a Federal Government has agreed to an early start date, explained the Guild.

#### Life's busy, but breast screening is a priority

A NEW BreastScreen NSW campaign is urging women to book in for a life-saving mammogram before it's too late, with more than 50% of NSW women aged 50-74 behind on their breast cancer screening.

Voiced by Australian entertainers Kat Stewart and Amanda Keller, the new campaign warns women that while you're living life, 'Breast Cancer Doesn't Wait'.

NSW Health Minister Ryan Park said while a record number of

women have returned to the BreastScreen NSW service over the past few months, there are still more than 625,000 women who haven't booked in for their breast screen.

"We know life gets busy and reminder letters to get a breast screen often get lost under a mountain of paperwork and endless to-do lists," Park said.

"The message is simple, a breast screening appointment only takes 20 mins every two years and could save your life."
