### Telehealth service

TODAY, Sexual Health Victoria (SHV) has introduced a telehealth medical abortion service across the state, through a strategic partnership with a pharmaceutical provider network.

The service addresses the issue of limited access to medical abortion services and medications, particularly in regional areas.

SHV stated that with only one in 10 GPs actively engaged in prescribing abortion medicines, it is hopeful the telehealth service will provide a practical solution.

# Consultation on new Aged Care Act

THE Department of Health has announced that a new Aged Care Act will be introduced to Parliament this year, with a further amendment bill to be put forward to establish the Support at Home program to start in 2025.

The Royal Commission into Aged Care Quality and Safety had uncovered that the current Aged Care Act and its related legislation are no longer fit for purpose.

This is because it was structured around providers and how to fund them, rather than around the people accessing services and what they need, said a Dept statement.

The new rights-based act will put older people who need aged care at the centre of the system.

While the new act will affect everyone involved in the aged care



sector, a key recommendation will be that medical practitioners must trial and document alternative strategies in the care recipient's clinical record before prescribing psychotropic medications.

Practitioners and pharmacists will need to check for any contribution of current medication to confusion. sedation or other side effects

potentially causing distress or behaviours of concern.

Restrictive practices will also be used only as a last resort to help prevent harm to older people in aged care and their carers.

Recent changes to laws strengthen existing requirements and put measures in place to reduce the inappropriate use of restrictive practices.

Healthcare professionals will also need to identify and document the risk of harm to the person or others that medication used as restraint seeks to address.

The Department of Health has also confirmed it is holding another round of consultations up until 16 Feb for people to have their say on the exposure draft of the bill for the new Aged Care Act, HERE. JG

# Injections guide

# Cancer study win A CHARLES Darwin University

study revealed that cannabis extract showed positive results in slowing down melanoma cell growth and increasing cell death rates, explained Dr Nazim Nassar, a practising pharmacist and pharmacologist, and the research's co-author.

"The damage to the melanoma cell prevents it from dividing into new cells, and instead begins a programmed cell death, also known as apoptosis," said Nassar.

"This is a growing area of important research because we need to understand cannabis extracts as much as possible, especially their potential to function as anticancer agents.

"If we know how they react to cancer cells, particularly in the cause of cell death, we can refine treatment techniques to be more specific, responsive and effective."

Dr Nassar said the next challenge was developing a targeted delivery system development to the melanoma cells to get it ready for preclinical trials.

He said that while the use of cannabis extracts to treat a variety of health conditions is stigmatised, future research into its application could change cancer treatment.

Lead author and RMIT biotechnologist Prof Nitin Mantri emphasised the necessity for a long-term follow-up to ensure the sustained effectiveness and safety of the cannabis extract in cancer treatment over extended periods.

THE International Pharmaceutical Federation's (FIP) Young Scientist Award 2024 aimed at recognising research excellence is calling on early-career pharmacists and pharmaceutical scientists under 35 years to participate.

Entrants will present at the 82nd FIP World Congress from 01 to 04 Sep to develop professional skills and gain exposure to a global platform, which provides collaborating opportunities to enhance careers.

FIP stated interested individuals are invited to submit their abstracts and application forms for either a poster or podium presentation at the Congress.



A webinar will be held to assist those interested in preparing for presenting at the conference.

Both winners in each category (poster/podium) will be honoured during a ceremony at the event.

The submission deadline to enter the competition is 15 Mar.

FIP stated that participants must, in addition to the abstract, submit a brief resume.
