HEALTH minister Nicola Roxon has confirmed that the govt is considering the implementation of a new opt-in "health care card" which would record patient medical history and allow pharmacists to access full details of medications.

The Guild has backed the move, saying expansion of prescribing rights means there's more potential for interactions - and community pharmacists are the medicines 'hub'.

It's also pushing for involvement in the development of the card, saying that "tens of millions of dollars of public money has been wasted in failed e-health systems" in contrast to the Guild which has a strong track record of success in ehealth processes.

The Guild also raised a number of other issues relating to the card,

New TGA minister

SENATOR Jan McLucas says she's planning to focus on her Qld constituents after stepping down from her role as Parliamentary Secretary for Health and Ageing.

The move coincides with a wider cabinet reshuffle, and came just days after McLucas was criticised for incorrectly accusing pharmacists of discarding unopened vials of chemotherapy medication during Senate Estimates committee hearings last week (PD Fri).

The new Parliamentary Secretary for Health is Mark Butler, who was elected to the SA seat of Port Adelaide in 2007 and is a former union official for the SA branch of the Liquor, Hospitality and Miscellaneous Union where he led campaigns in industries including hospitals and aged care.

The Australian Self-Medication Industry welcomed Butler's appointment, with executive director Juliet Seifert saying "I am delighted that we have someone with firsthand knowledge of the real needs of those in the health system and I look very much forward to working with him."

Opposition slams chemo cut

Gum disease link to rheumatoid arthritis

US researchers have found that sufferers of both aum disease and rheumatoid arthritis can relieve both conditions by improving their mouth hygiene.

A paper published last week in the Journal of Periodontology report said there was a close association between the ailments, and patients who had dental treatments such as scaling also saw a significant improvement in arthritis symptoms.

THE Federal Opposition has joined the chorus of criticism of the government's proposed changes to chemotherapy treatment funding, which have been deferred for implementation until 01 Sep.

Shadow Parliamentary Secretary for Health Administration, Mathias Cormann, on Saturday echoed comments by the Community Pharmacy Chemotherapy Services Group (PD Fri), expressing concern about now former TGA minister Jan McLucas accusing pharmacists of discarding "whole unopened vials of expensive drugs".

Cormann said he had been quizzing the government about the impact of the chemotherapy measures in Senate Estimates since October last year.

"Departmental officials had no idea then how they would implement the measure...[and] they still have no idea of how to go about it, because things just don't add up," he said.

The budget describes the changes as 'more efficient arrangements for the payment of benefits for chemotherapy drugs' but Cormann claimed that "in practice it is nothing more and nothing less than a \$100 million budget cut to crucial chemotherapy treatment which will end up hurting patients."

He said that he had pressed the government to ask pharmaceutical manufacturers to adapt vial sizes in order to minimise waste, but been told this was "too hard"

"The bottom line is that based on the government's current approach, if they won't pay for the portion of the drug that has to be discarded, somebody else will have to.

"That will be either the patient or the pharmacist," he said - and with the government now undertaking to protect patients by legislating against any increase in out-of-pocket costs "that means it will be the

pharmacist who will have to cover the cost, which has been estimated at \$600 per dose per patient.

"The whole budget cut is based on the wrong premise, that there is significant avoidable waste in the way the drug is administered in Australia. The reality is there is not.

"The current 'wastage' is a function of the vial sizes and the different physiological requirements of different cancer patients.

"It is high time the Rudd government got its head around that fact, instead of persisting with a measure that will end up hurting vulnerable cancer patients," Senator Cormann said.

Gongs for pharmacists

YESTERDAY'S Queen's Birthday honours list included awards for four Australians involved in the pharmacy industry.

Queensland pharmacist Peter Brand was named as a Member of the Order of Australia, with the citation: "for service to the pharmacy profession as a practitioner and through representative and educational roles."

Veterinary expert Peter Holdsworth was also named as a Member of the Order of Australia "for service to the animal health industry, particularly as a contributor to the development of international standards for the veterinary pharmaceutical sector."

Professor Graeme Blackman, former Professor of Pharmaceutical Chemistry at the Victorian College of Pharmacy, was awarded an Order of Australia Medal "for service to the pharmaceutical industry, and to the community through a range of church, heritage and welfare organisations."

And Tasmanian pharmacist Gerald Kay was awarded an Order of Australia Medal for his "service to the community of north west Tasmania as a fundraiser".

DISPENSARY CORNER

TECHNOLOGY is coming to the aid of wandering Alzheimer's patients and their carers, with a US firm specialising in miniature GPS devices fitting tiny satellite tracking equipment into shoes.

"The technology will provide the location of the individual wearing the shoes within 30 feet, anywhere on the planet," said one of the developers, Andrew Carle from George Mason University.

He said a "geo-fence" could be placed around a person's home and an electronic alert sent to a mobile phone or computer when a programmed boundary is crossed.

"Sixty per cent of individuals afflicted with Alzheimer's Disease will be involved in a 'critical wandering incident' at least once during the progression of the disease - many more than once," he said.

INTERGALACTIC space travellers are likely to end up being short, fat and bald, according to a British astrobiologist.

Dr Lewis Dartness says that the lack of effort needed to move around in low gravity, along with the temperature-controlled space cabin environment would mean that "future spacemen and women are likely to become pretty chubby."

He cited other effects, including weakened bones and muscles due to living without gravity which were likely to leave astronauts "stunted and weak".

And to top it all off, he predicted that "with no need for hair to insulate the head or eyelashes to flick dust from their eyes, future humans may become completely hairless."
