Osteoporosis approval

THE US FDA has approved Prolia, a new injectable treatment for postmenopausal women with osteoporosis at high fracture risk.

Prolia (denosumab) is a six-monthly fully human monoclonal antibody injection which works to decrease the destruction of bone and lift bone mass and strength.

PSA welcomes Guild plan

THE Pharmaceutical Society of Australia says the Pharmacy Guild's new *Roadmap* for community pharmacy (**PD Wed**) is a welcome contribution to the debate on pharmacy's future in Australia.

PSA President Warwick Plunkett said the Guild document has a clear focus on the business side of community pharmacy "and this is in keeping with the Guild's membership base of community pharmacy owners."

"This focus is also reflected in the professional programs which the *Roadmap* correctly addresses as playing a central role in pharmacy's future, which PSA had already identified in its *Issues Paper on the Future of Australian Pharmacy*," Plunkett said (**PD 26 May**).

However the PSA's *Issues Paper* had been developed with a view to generating wide-ranging debate on the future of the profession and provides a whole-of-profession approach and debate, "which unfortunately the *Roadmap* will not do," Plunkett added.

SHPA updates CPD

Safety Update

THE TGA has published the third edition of its *Medicines Safety Update* which replaces the former Australian Adverse Drug Reactions Bulletin.

Issues covered include 61 reports of suspected adverse reactions to sibutramine after preliminary results from a trial which showed higher rates of heart attack and stroke in subjects who were obese or overweight and were using it.

"The TGA is reviewing the safety of the product and while that review is ongoing has reinforced existing advice to healthcare professionals to carefully review the sibutramine Product Information before prescribing the product," the update warns.

There's also a review of reports of drug-induced pancreatitis associated with exenatide (Byetta) and an article emphasising the importance of identifying the AUST L number on the label of complementary medicines suspected of causing adverse reactions.

HIP directors resign

HEALTH Corporation Limited, the parent company of the Health Information Pharmacy franchise group, has announced the resignation of its chairman Graham Dunkley and board member Greg Albert as non-executive directors, effective immediately.

MRAI update

THE Medication Review Accreditation Incentive (MRAI) payments cease on 15 Jun and won't continue under the Fifth Agreement - however transitional agreements mean that pharmacists currently undergoing MMR accreditation can still receive the \$1500 payment if they complete it within an appropriate timeframe.

To be eligible pharmacists must register by 15 Jun, and re-accreditation payment will also no longer be paid after 01 Jul 2010 so renewal applications must be finalised before that date.

NZ medicine recall review

NEW Zealand Health Minister Tony Ryall has announced an urgent review of medicine recalls, following the spate of recent incidents which have involved significant input from the country's community pharmacists (PD 28 May).

The move follows agitation by the Pharmacy Guild of New Zealand, with its president, community pharmacist Ian Johnson, having initiated legal action against GlaxoSmithKline over a January recall of warfarin as a test case.

There have been four medicine recalls so far this year in NZ, including an issue affecting more than 40,000 patients after reports of non-consistently sized tablets in atenolol manufactured by Alphapharm's sister company Mylan New Zealand.

The minister issued a statement saying "Pharmacists have asked whether the processes, contracting and compensation arrangements for medicine recalls are adequate."

"I believe the issue could benefit from closer scrutiny," he said.

The Director-General of Health will update the government on the matter in a month's time, after taking input from appropriate people in the sector.

The NZ Guild has urged that an experience community pharmacist be involved in the review, with ceo Annabel Young saying the establishment of clear procedures for managing recalls is "crucial for patient safety, the credibility of recalls and for how pharmacy is to be compensated for the time involved in managing recalls".

Asthma-burger link

EATING three or more hamburgers a week is linked to a higher risk of asthma, according to research published in the *Thorax* journal this week.

The researchers also found that eating fruit, vegetables and fish also appeared to cut asthma risk.

ConPharm hails winners

LAST weekend the AACP held its sixth Annual Consultant Pharmacy Seminar 'ConPharm '10' in Hobart, with about 300 delegates in attendance.

Outgoing AACP chair, Judith Liauw, welcomed the pharmacists and gave an overview of the organisation's achievements during her two year tenure which wraps up at the end of the month, when she will be replaced by consultant pharmacist Debbie Rigby.

The event featured a diverse range of clinically relevant presentations and workshops from a plethora of respected geriatricians, academics, researchers and other accredited pharmacists

Another event highlight included the announcement of the AACP Pfizer Consultant Pharmacist of the Year award which was this year jointly awarded to independent accredited pharmacist Penny Kraemer and Peter Tenni, manager of the clinical division of Medscope in which role he's recently been involved in the development of a novel tool to help pharmacists to identify drug-related problems when performing medication reviews.

Both winners were hailed for their dedication to enhancing the reputation of the profession of pharmacy, as well as their "outstanding and ongoing commitment to the development of consultant pharmacy."
