The Pharmacy Guild of Australia **THE** newly elected president of the Australian Self Medication Industry (ASMI) has promised to advance debate around healthcare and health products within the industry, as well as within the community at large.

Lindsay Forrest from Reckitt Benckiser was named as ASMI President last week (**PD** 25 Nov), and also committed ASMI under his leadership to improving the health literacy of all Australians.

"We will continue to mount a case for appropriate self care, so that there is increasing awareness of the opportunity for individuals to take greater personal responsibility for their health, and a new understanding of the innovative solutions to make the best use of healthcare resources," he said.

"One such opportunity is to expand the role of pharmacists in the treatment of many minor ailments as a way of alleviating the burden on overstretched GPs."

Speaking about the role of pharmacists in healthcare, Forrest said that the pharmacy sector "represents a vital link between the industry and the public", adding that he was eager to build on the existing relationship that ASMI has with professional pharmacy bodies.

Hospital waiting times

AUSTRALIANS made six million trips to emergency departments in public hospitals throughout 2009-10, according to the latest figures released by the Australian Institute of Health and Welfare .

100% of all resuscitation patients who presented to Emergency Departmentss received treatment immediately, whilst 70% were seen "on time" for their triage category.

According to the head of the AIHW's Hospitals and Performance Group, Jenny Hargreaves, 2009-10 ED figures also found that for 50% of presenting ED patients, treatment began within 23 minutes of arrival, and within 115 minutes for 90% of people.

The report also found a 2.4% year-on-year increase in the number of people receiving elective surgery in public hospitals.

"We strongly believe there is evidence to demonstrate that this can benefit Australia, and we want to work cooperatively with the professional associations to explore what, I am sure, can be a better outcome for all parties," he added.

TGA probe details revealed

 Opportunities for increased provision of public information on therapeutic goods in Australia Opportunities for improved public

King said the industry as well as consumers would be able to have input to the review, which is consistent with govt policy to improve public access to decision-making.

2011 flu vaccine

HEALTH experts are encouraging pharmacists to be prepared for the public seeking reassurance on flu vaccination for 2011, in light of safety concerns raised this season regarding the paediatric populartion, and initial private sector flu shot availability shortfalls.

According to infectious disease and vaccine expert from the University of Sydney, Professor Robert Booy, last season saw an abundance of mixed messages around the flu and the severity and prevelance of H1N1 pandemic.

"One third of severe (and fatal) cases occurred in healthy people¹, therefore it was not just those who have chronic diseases or preexisting conditions that were affected," said Professor Booy.

"It's important that people recognise this when considering the need for vaccinations," he added. In terms of paediatric vaccinations,

Booty said that parents should be presented "with the facts".

"Flu vaccines are very good and effective, but occasionally there is a problem and this needs further investigation, and improvements are then made.

"This way, we aim to make vaccines safer," he said.

In preparing for the 2011 flu vaccine season, experts are also reminding healthcare practitioners that 2010 stock can only be used if its within its expiry date, and complies with cold chain requirements.
