Anti-codeine voice

PAIN specialist Dr Michael Vagg says the current campaign against up-scheduling OTC codeine products is a "risk to patients".

Vagg is a dissenting voice to the chorus opposing the TGA proposal to make codeine S4, and yesterday issued a statement saying "there's a scare campaign going on, which really doesn't take account of the facts and drug safety.

"Harm from over the counter codeine continues and other countries have made a difference by making codeine prescription only....the TGA quite sensibly decided that the benefits from having codeine in some medications is low or non-existent and the risks sufficiently high to restrict access by leaving the decision to doctors in discussion with their patients," Vagg added.

He said up-scheduling codeine would bring Australia into line with many other developed nations including the USA, Germany, Belgium, Switzerland, Finland, Italy, Hong Kong, Japan and more.

"Pharmacists will be able to advise on alternative codeine free products and if someone needs acute pain relief that needs an opioid medication, they should be consulting their GP," he contended.

My Health med record push

UP TO 230,000 hospitalisations in Australia annually are attributed to medication misadventure, many of which may be avoidable, Medicines Australia (MA) has asserted in its submission to the federal government on the proposed My Health Record.

MA is calling for patient medication records to be a mandatory inclusion in eHealth profiles to improve the safe use of medicines by better data collation, coordination and records access via the My Health Record system.

The submission from the peak industry body says, "Optimising My Health Record to improve the recording, sharing and management of prescribed (and

The organisation identified community pharmacists, physiotherapists or occupational therapists, mental health workers or psychiatrists, and communitybased services liaison workers as appropriate team members.

Chair of the guideline development group Bernard Walker said: "when social care and health practitioners work together well, it helps both people using services and their carers to have choice and control over their care.

"It also avoids unnecessary duplication of services," he said.

"Movember" osteo link

THE annual 'Movember' campaign encouraging the growth of facial hair to focus on men's health is now being linked to raising awareness around osteoporosis by NPS MedicineWise.

According to NPS, osteoporosis is an "under-investigated and under-treated condition in men" with effects in males more common than in women.

An estimated one in four men over the age of 50 will experience a minimal trauma fracture due to osteoporosis, NPS said - yet less than 15% are being treated.

NPS MedicineWise clinical adviser Andrew Boyden said asking men a few questions to find out if they had had a minor bump or fall could lead to diagnosis and treatment which could keep them out of

AD med packs change

THE UK Medicines and Healthcare products Regulatory Agency is working with the pharmaceutical industry to ensure more helpful packaging is designed to assist Alzheimer's Disease (AD) patients.

From 2016, all AD medications will need to be presented in calendarised platforms to minimise compliance failure.

George McNamara, head of policy at Alzheimer's Society, said, "It's great that the voices of people with dementia have been heard and much-needed action is being taken.

"Medication packaging can be confusing for people with dementia. Simple modifications, such as indicating the days of the week or making the font clearer to read, can have huge implications for both the independence and the safety of people living with dementia," McNamara said.

New Products

Ceprotin (protein C) is indicated in purpura fulminans and coumarin induced skin necrosis in patients with severe congenital protein C deficiency. Protein C is available as a powder for injection in a vial containing 500 IU supplied with 5 mL of diluent and 1000 IU supplied with 10 mL of diluent.

Ofev (nintedanib esilate)

is a triple angiokinase inhibitor, blocking vascular endothelial growth factor receptors (VEGFR 1-3), platelet derived growth factor receptors (PDGFR α and β) and fibroblast growth factor receptor (FGFR 1-3) kinase activity. Ofev is indicated in combination with docetaxel for the treatment of patients with locally advanced, metastatic or recurrent non-small cell lung cancer (NSCLC) of adenocarcinoma tumour histology after failure of first line chemotherapy. Ofev is also indicated for the treatment of idiopathic pulmonary fibrosis (IPF). Ofev is contraindicated during pregnancy. Ofev is available as 100 mg and 150 mg capsules in packs of 60's.

Ozurdex (dexamethasone) is an intravitreal implant indicated for the treatment of diabetic macular oedema (DME). It is contraindicated in the following conditions: patients with active or suspected ocular or periocular infection, including most viral diseases of the cornea and conjunctiva, including active epithelial herpes simplex keratitis (dendritic keratitis), vaccinia, varicella, mycobacterial infections, and fungal diseases; patients with advanced glaucoma; aphakic eyes with rupture of the posterior lens capsule, and in eyes with an anterior chamber intraocular lens (ACIOL), iris or transscleral fixated IOLs, and rupture of the posterior lens capsule. Ozurdex is available as an intravitreal implant containing 700 microgram of dexamethasone.

Soolantra (ivermectin) is indicated for the topical treatment of inflammatory lesions of rosacea (papulo-pustular) in adult patients 18 years and over. Soolantra is available as a 30 g tube containing 10 mg/g of ivermectin.

Spiolto Respimat (tiotropium bromide; olodaterol) is a combination long acting anticholinergic and beta,-agonist, respectively. It is indicated as a once daily maintenance bronchodilator treatment to relieve symptoms in adult patients with chronic obstructive pulmonary disease. Spiolto Respimat is contraindicated in patients with a history of hypersensitivity to atropine or its derivatives, e.g. ipratropium or oxitropium. Spiolto Respimat is available as a cartridge containing solution

for inhalation and one inhaler delivering 60 metered dose puffs each containing 2.5 microgram olodaterol and 2.5 microgram tiotropium.

Safety Related Changes

Pradaxa (dabigatran etexilate) is now also indicated in the treatment of deep vein thrombosis (DVT) and pulmonary embolism (PE), and for the prevention of recurrent DVT and PE in adults.

Pradaxa (dabigatran etexilate) is now also contraindicated with a lesion or condition at risk of major bleeding (including current, recent GI ulcer; malignant neoplasm with high bleeding risk; recent brain/ spinal injury, brain/ spinal/ ophthalmic surgery, intracranial haemorrhage; oesophageal varices including suspected; arteriovenous malformation; vascular aneurysm; major intraspinal, intracerebral vascular abnormality) and also with concomitant anticoagulants, e.g. unfractionated heparin (excluding when given to maintain open central venous, arterial catheter), LMWH (e.g. enoxaparin, dalteparin), heparin derivatives (e.g. fondaparinux), or oral anticoagulants (e.g. warfarin, rivaroxaban, apixaban) excluding when switching anticoagulant therapy.
