## Asthma handbook practice update

THE National Asthma Council has announced the release of version 1.3 of the Australian Asthma Handbook

This revision includes "important and timely guidance on treatment implementations of thunderstorm asthma, managing allergic rhinitis in people with asthma, treating patients with asthma-COPD overlap," the Council said.

Developed by an interdisciplinary team of medical experts and incorporating feedback from primary care providers, the Australian Asthma Handbook is a useful online searchable resource and includes new information on thunderstorm asthma events.

**THE** Australian Competition and Consumer Commission (ACCC) has launched Federal Court proceedings against GSK Australia and Novartis Consumer Health Australasia, alleging they made "false or misleading representations in the marketing of Voltaren Osteo Gel and Voltaren Emulget pain relief products".

Similar to the case brought against RB regarding its "pain specific" Nurofen products, the ACCC alleges that Novartis and GSK represented that Osteo Gel was specifically formulated for treating osteoarthritis conditions, and was more effective than Emulgel to treat those ailments, even though the two products are identcal.

Voltaren Emulgel and Osteo Gel both contain diclofenac diethylammonium gel 11.6mg/g.

"We allege that consumers are likely to have been misled into purchasing Osteo Gel thinking that it is different to Emlugel and more effective for treating osteoarthritis conditions, when this is not the

# **Medicinal mushrooms**

#### Pharmacist role grows

**INCREASING** use of psychiatric drugs in the US is highlighting the increased demands on the role of pharmacists, according to a research letter published in *JAMA Internal Medicine*.

The research revealed that one in six adults in the US reported taking psychotropic drugs during 2013, prompting University of Alabama Clinical Pharmacist and Clinical Professor Cherry W. Jackson to identify areas of concern.

The largest increase has been in the prescribing of antipsychotics, antidepressants and drugs used to treat ADHD, Jackson said.

"It does seem like there's growth in the prescribing of psychotropics to children and the elderly, and those are two big causes of concern for us," Jackson said.

"Pharmacists can play a critical role in evaluating and promoting medication adherence," Jackson told *Drug Topics*.

"Nonadherence can be a contributing factor in overprescribing because physicians may increase the dose of a medication or write a prescription for an additional medication without knowing the patient is not taking the first prescription as prescribed."

Adherence concerns are "a really big role for pharmacists, I think," Jackson emphasised, adding these medications also have a lot of side effects, which need monitoring "by pharmacists and other members of the care team."

## New Zytiga PBS listed

A NEW formulation of Zytiga (abiraterone acetate) of 500 mg film-coated tablets is now available on the PBS, reducing pill burden for men with metastatic castrateresistant prostate cancer from four 250mg uncoated pills to two pills per day - see pbs.gov.au.

The drug is an androgen biosynthesis inhibitor indicated for the treatment of patients with metastatic castrationresistant prostate cancer who are asymptomatic or mildly symptomatic after failure of androgen deprivation therapy or who have received prior chemotherapy containing a taxane.

## **CSL Vitaeris link**

**CSL** and Vitaeris Inc. have announced they have entered into a strategic collaboration and purchase option agreement to expedite the development of clazakizumab, an anti-IL6 MAB, formerly ALD518, as a therapeutic option for solid organ transplant rejection.

Clazakizumab is a humanised, monoclonal antibody that binds to and inhibits Interleukin-6 (IL-6), an important driver of the inflammatory response and known to play a key role in transplant rejection, the joint release stated.

The deal will see US\$15m paid by CSL along with milestone payments "over several years" and includes an exclusive option for CSL to acquire Vitaeris.

### **PBA Communiqué**

**THE** Pharmacy Board of Australia has released a communique in relation to its most recent meeting, summarising activities including the new joint statement on compounding medicines in conjunction with the Medical Board of Australia (*PD* 27 Nov 17).

The Board also reminded pharmacists of the importance of renewing registration, with the current "late renewal period" expiring on 31 Dec 2017.

Practitioners who apply for renewal after 01 Jan 2018 must lodge a new application, rather than simply a renewal, and will be removed from the national register.

A 'fast track' application can be made, but only during Jan 2018, and the pharmacist cannot practise until it is processed and the national register is updated "which can take time," the Board said.

The Pharmacy Board met with the Pharmacy Council of New Zealand in Wellington on 28 Sep 2017 to discuss matters of common interest in relation to the regulation of pharmacists.

The communique also notes a Research Seminar held last month by AHPRA and the UK's Health and Care Professions Council to discuss the issue of patient safety in practitioner regulation.

Attended by about 150 people, the joint event looked at how National Boards learn from data to improve regulatory effectiveness, patient safety and professional standards internationally.

# Dispensary Corner

**THE** first ever prescription video game will be approved in America in 2018 to help children with ADHD, after a pivotal clinical trial.

Developer Akili says playing tailor-made video games can help children with attention deficit hyperactivity disorder (ADHD), according to results from the study revealed on Mon.

Experts say it will pave the way for what would be the first such 'digital' prescription product.

The Wii game (**pictured** below) will be used to stimulate "specific cognitive neural systems" located inside the brain.



**THE** term 'tortured artists' has been used to describe some of history's greatest painters, from Vincent Van Gogh to Pablo Picasso.

According to a new study in the INFORMS journal *Management Science*, personal unhappiness, particularly that experienced in times of mourning or bereavement, can actually cause a significant decrease in the value of an artist's work.

Paintings created in the year following the death of a friend or relative saw a decline in value of about 35% compared to the rest of the artist's catalogue.

The researchers analysed 10,000 paintings by 33 French impressionist artists and 2,000 paintings by American artists.
