SA pharmacy vax

SOUTH Australians will have greater access to vaccinations via pharmacists, with the SA Health Department expanding the range of vaccines they can administer.

Rather than having to make an appointment with a GP, people aged 16 and over will have the option to obtain vaccines for measles, mumps, rubella, whooping cough, diphtheria, tetanus, and polio from their local authorised pharmacist.

Since pharmacy vaccinations began in early 2015, more than 300 pharmacists across the state have completed the required training to be authorised to administer the influenza vaccine.

Training for pharmacists to administer the expanded range of vaccines will ensure they have the knowledge and skills to deliver the vaccine, as well as identify and treat any possible side effects.

The pharmacist will also need to work in a pharmacy approved by SA Health, with the expanded range of vaccines administered in pharmacy following the successful implementation of the pharmacistadministered flu vaccination program in early 2015.

THE German Government has country's largest OEM health

announced hefty fines for parents who fail to vaccinate their children in the face of a measles epidemic spreading across Europe, reports the Daily Mail.

Under the new laws, kindergartens will be required to report parents with no evidence of vaccination, potentially resulting in fines up to €2,500 (~AU\$3,750) for ignoring the new rules.

The World Health Organisation has alerted European leaders of the disease's ubiquitous spread which is blamed largely on the discredited controversy around the measles-mumps-rubella (MMR) link to autism.

"Continuing deaths from measles cannot leave anyone indifferent," Health Minister Hermann Gröhe told German tabloid Bild.

"That's why we are tightening up regulations on vaccination," he said. Soon, failure to provide a doctor's note proving vaccination could mean expulsion of the child from daycare centres in Germany.

Medical authorities at the Robert Koch Institute said the country had 410 measles cases by mid-Apr this year, compared with 325 for the whole of 2016.



NO kidding - the latest fitness craze sweeping the globe is 'Goat Yoga" and it could be coming to a studio near you.

The phenomenon was created by American farmer Lainey Morse, who found her goats helped her after being diagnosed with an autoimmune disease as well as becoming divorced.

Sound weird? Not according to animal behaviourist Roger Mugford who said goats help drop peoples' heart rates because they release the "cuddle chemical" oxytocin.

However participants are urged to wear old clothes, because the goats are prone to nibbling!



MUMS, it's not all in your head apparently daughters do bring out the 'softer side' in dad.

A study published in the Behavioural Neuroscience journal looked at the way dads treated their sons and daughters.

In 52 daily dad interactions randomly recorded over 48 hours, fathers responded swiftly when their daughters were anxious but paid less attention to their sons.

Makeba Parramore Wilbourn, Assistant Professor of Psychology and Neuroscience at Duke University in Durham said, "cultural influences rather than biology probably underpin the way fathers behaved" and that girls are still more encouraged to express their emotions than boys.

TGA ticks Oz sunscreens

THE Therapeutic Goods Administration (TGA) has laboratory tested 31 commonly used sunscreen products, including lotions, creams and aerosol sprays, sourced from pharmacies and supermarkets, and given the allclear for every product evaluated.

Following a large number of reported concerns during the past Australian summer that sunscreens were failing to provide adequate sun protection, the TGA undertook the comprehensive assessment of products for their labelstated ingredients.

They were also tested for compliance with the Australian regulatory guidelines for sunscreens in terms of content of sun protection ingredients (90-120% of the labelled claim), finding all products compliant.

Also, following concerns raised through the use of aerosol spray products, the TGA said it undertook preliminary testing to investigate their delivery rates revealing the

amount of sunscreen delivered per second differed between brands.

Given this, it is important consumers follow the labelling instructions to 'apply liberally' to ensure proper coverage of the sunscreen, the TGA said.

With more than 24 million people in Australia there are many millions of applications of sunscreen each year and, given the widespread use, the rate of reported problems is relatively low.

> Between 01 Jan and 31 Dec 2016 the TGA received a total of 27 reports of adverse reactions to sunscreens of which 15 were reports of allergic reactions, namely a rash, and 12 reports of a product

not being effective.

Cancer

The Cancer Council and medical colleges have emphasised the importance of applying sunscreens liberally and regularly, as these products are commonly underapplied, and frequently removed by sweating, washing or towelling off. See items tested at tga.gov.au.
