

#### **PBA** intern survey

THE Pharmacy Board of Australia has extended the deadline for its Pharmacy Internship Experience Survey (PIES), which can now be completed up to 9am AEST on Mon 09 Apr 2018.

The Board said due to the Easter break it wanted to ensure that everyone invited to participate had a fair opportunity to provide a response to the survey, which seeks feedback from interns and preceptors to help improve the supervised practice process.

Emailed invitations contain a link to the survey which takes 15-20 minutes to complete.



# **CM** compliance improves

AN INCREASE in complementary medicines (CM) regulatory activity by the Therapeutic Goods Administration has seen a significant drop in the proportion of CMs with verified compliance breaches over the last six months.

The TGA has released a half yearly performance snapshot, which also confirms a jump in complementary medicines which had their registrations cancelled by a sponsor after a TGA request for information - from 20% in Jul-Dec 2016 up to 73% for the second half of 2017.

The TGA has previously been criticised for the proportion of medicines with verified compliance breaches, which ran at 80% for Jul to Dec 2016.

This figure dropped to 56% for the same period in 2017 with the increase in targeted reviews, including a strong focus on sunscreens.

# Paramedics prescribe

**ADVANCED** paramedic practitioners are now entitled to train to become independent prescribers across the UK, NHS England has announced.

According to a report in the *Pharmaceutical Journal*, it is estimated that around 700 paramedics working in hospital emergency departments, GP surgeries and minor injury units are poised to begin training to qualify to prescribe by 2019.

# e-prescribing tick

**IMPLEMENTATION** of an electronic prescribing system for the Hunter New England Local Health District has resulted in a number of significant benefits for prescribers, dispensers and ultimately for patients, according to a report in *Australian Prescriber*.

Electronic prescribing across the district has improved patient safety, communication and accountability, and provided an electronic record of medication prescribing and administration, authors concluded. Access the article at nps.org.au.

31 Dec 2017 in relation to the TGA's regulation of therapeutic goods for safety, effectiveness, performance and quality, tracking progress against nominated priorities.

The agency also highlighted an increase in approval rates for new prescription medicine applications and changes to existing ones within target timeframes.

Generic medicines also received a boost with shorter times to approval conclusions.

The reformed orphan drug program, which came into effect on 01 Jul 2017, created a fairer scheme aligned more closely with international criteria, the TGA said, and the Special Access Scheme (SAS) Category C notification pathway was made available on 03 Jul to improve timeliness of access to goods deemed to have an established history of use, without prior approval.

The biologicals list and conditions of use in SAS Category C - which enables supply of goods deemed to have an established history of use without prior approval - have been updated this month and are immediately effective.

# **Industry GMP forum**

**THE** Therapeutic Goods Administration (TGA) has announced the inaugural 2018 Good Manufacturing Process (GMP) Forum registrations are now open.

The TGA will host the forum in conjunction with the Royal Australian Chemical Institute, the Association of Regulatory and Clinical Scientists to the Australian Pharmaceutical Industry, the Parenteral Drug Association Australia Chapter and the International Society for Pharmaceutical Engineering.

Topics to cover will include the international regulatory environment, GMP clearance, transition to the new PIC/S GMP Guide PE009-13 along with GMP Obligations for Small and Medium Enterprises, SME Education and GMP inspection requirements.

The forum is recommended for industry personnel employed by sponsors and manufacturers of prescription, over-the-counter and complementary medicines, as well as consultants working with the therapeutics industry.

Presenters will be senior TGA speakers who are subject matter experts in GMP.

A bidding process initiated by Pfizer last year has seen GSK, Reckitt Benckiser and Johnson & Johnson all exit from the auction, with Pfizer hoping to raise US\$20b.

Benefits are already flowing, with increased script numbers, customer satisfaction and uptake of professional services, Wakim added.

# New hope for uveitis and psoriasis

JANSSEN pharmaceuticals has announced the addition to the Australian Register of Therapeutic Goods of a new biologic therapy for psoriasis, which it says is set to challenge the current dominance of Humira (adalimumab).

Tremfya (guselkumab) is the first biologic approved in Australia that selectively blocks cytokine IL-23, a protein that plays a critical role in the pathogenesis of plaque psoriasis, the company said.

Tremfya is not funded on the PBS, but the company is running a special access scheme.

MEANWHILE in another release, the Pharmaceutical Benefits Scheme (PBS) is now funding Allergan's Ozurdex (dexamethasone 700μg) a sustained-release intravitreal implant for patients with non-infectious posterior segment uveitis, along with other specific conditions.

# Heat Doward claims dominance
