Temple Touch recall

The affected lot number is 5216, printed on the base of the unit.

The TGA says that to date, no other lots of the Rite Aid Mini Digital Temple Touch Thermometer are affected by this recall.

7CPA on APP2018 agenda

THE Pharmacy Guild will convene a special session at the upcoming Australian Pharmacy Professional (APP) conference to seek input from delegates on the Seventh Community Pharmacy Agreement.

7CPA negotiating lead Trent Twomey will join with Guild executive director David Quilty and national president George Tambassis to explore a "broad range of initiatives and issues facing community pharmacy".

The interactive session will take place from 9am-12.30pm on Sun 06 May, seeking feedback on the

"critical issues that will frame the 7CPA and the future of community pharmacy".

The Guild will also present key outcomes of its CP2025 research and strategy planning project during the session.

The 6CPA is now in its third year, with the next agreement set for implementation from Jul 2020.

As well as being able to voice their views directly to the Guild's senior leaders during APP, delegates will also be able to express their opinion via an interactive survey.

THE Pharmacy

Guild of EPIPEN 2-PAK Australia has advised there are now limited stocks of EpiPens coming into Australia, with more received last week and now in the process of being labelled and distributed.

EpiPen supply hope

The shortage is a worldwide issue due to problems with the overseas manufacturing plant, with signs the matter is being addressed.

In Forefront this week the Guild noted the TGA is monitoring the situation, and advises pharmacists to contact Alphapharm on 1800 274 276 for an emergency supply as well as advise patients to retain their soon-to-expire EpiPens and use them in case of an emergency, as long as the liquid inside isn't discoloured or contains sediment.

The TGA has also organised a temporary supply of a similar product called Emerade (marketed by Bausch + Lomb in the UK) and these should also be available in the next few weeks.

In addition a third company is looking to enter the Australian market with an EpiPen-like product in the middle of 2018.

Dispensary Corner

A BRITISH man suspected of swallowing a drug stash has been freed after he refused to go to the toilet for over six weeks.

24-year-old Lamarr Chambers was arrested in Essex on 17 Jan and charged with two counts of possessing class A drugs, reports *The Independent*.

He allegedly swallowed a package of crack cocaine and heroin while being chased by officers from the police gang and urban street crime unit.

The alleged offender refused to be X-rayed or take laxatives during his time in custody, with police tweeting daily updates of what they described as "poo watch".

After a series of seven hearings on extending his stay in the cells, the alleged offender was released "following medical and legal advice," with a spokesman saying 'his health, wellbeing and dignity were paramount at all times".

Sick-leave tickets a plus

COMMUNITY pharmacists take their responsibilities under the Act seriously, and should at all times comply with guidelines jointly developed by the Pharmacy Guild of Australia and the Pharmaceutical Society of Australia, the Guild has said in a formal statement.

The Guild was responding to a warning from peak employer body the Australian Industry Group (AIG) which earlier this week expressed scepticism about the validity of absence-from-work certificates issued by pharmacists - and mainstream media reports criticising advertising of \$20 sick notes from Chemist Warehouse.

Guild president George Tambassis noted that the Fair Work Act has made pharmacist-generated certificates legal for almost a decade.

"Under the guidelines, the issuing of an absence from work certificate must be within the scope of practice of the pharmacist, acting within their competency and professional expertise.

"Pharmacists need to carefully consider whether or not the illness or injury that is the subject of the certificate is within their recognised area of practice," Tambassis said.

"Given the waiting time that might be required for a doctor's appointment, the fact that workers who are legitimately ill or injured can obtain an absence from work certificate more conveniently at a pharmacy is actually a plus for productivity, not a minus," he said.
