Education ordered

WESTERN Australia's State Administrative Tribunal has suspended the registration of a pharmacist for two months and ordered him to undertake education in ethics and dispensing, after he was found to have engaged in professional misconduct.

According to the Pharmacy Board of Australia, evidence was presented at a hearing in relation to pharmacist Michael Man Ho Tse, alleging that between Sep and Oct 2016 he dispensed fentanyl patches to a patient without a valid prescription or verbal authority from a medical practitioner.

In addition Tse did not make any record of dispensing fentanyl to the patient, and altered the dates of several scripts to reconcile the supply of patches for which he did not have a valid prescription.

The pharmacist admitted engaging in professional misconduct, including his failure to make contact with a medical practitioner when he was aware the prescribing doctor was away.

"With no prior history of misconduct, Mr Tse was remorseful and cooperated early with the Pharmacy Board of Australia and the WA Department of Health," the board noted, with the pharmacist also required to be mentored monthly over a six month period.

Drug shortages law passed

OUT OF

A NEW mandatory reporting scheme for medicines shortages has now become legislation, forcing pharmaceutical companies to report shortages of important medicines within two working days.

The new national system for managing medicines supply will come into effect on 01 Jan 2019 after the Therapeutic Goods Amendment (2018 Measures no. 1) Bill 2018 passed through the Federal Senate on Mon night.

Mandatory reporting will apply to all prescription medicines as well as other vital medicines such as EpiPens and inhalers.

A critical medicine will be deemed to be in shortage if there is not enough, or likely will not be enough, for all Australian patients who take it or may need to take it, at any time in the next six months.

In addition, if a critical drug is being removed from the market, the department must be notified at least 12 months in advance, or "as soon as possible".

Non-critical drug shortages will need to be reported within 10 working days.

Tough penalties will apply to companies that do not comply with these new laws, including fines of up to \$210,000 for each infringement and the possibility of further court action.

Health Minister Greg Hunt said he made "no apologies" for taking a hard-line approach to ensuring patients aren't kept in the dark

about potential shortages.

Earlier this year. Australia was one of several countries hit by a shortage of EpiPens (PD 09 Mar), and

without early notification to the Therapeutic Goods Administration, patients and doctors were not alerted in time for them to make alternative arrangements, Hunt

Hunt thanked industry bodies including Medicines Australia, the AMA, SHPA, the Pharmacy Guild, ASMI, NPSA, PSA and the GBMA for their involvement in the consultation and design of the new approach.

Society of Hospital Pharmacists of Australia ceo Kristin Michaels said introduction of the new protocol was a big win that would "make a huge impact on the effectiveness of hospital pharmacists in Australia, liberating their time to spend on crucial face-to-face cognitive pharmacy services on the ward, maximising their input into multidisciplinary medical teams".

The Pharmacy Guild of Australia also welcomed the new legislation, saying "too many times in the past community pharmacists have been affected by shortages with no warning or readily available information.

"This legislation will significantly reduce the likelihood of substandard patient care arising from unforeseen and un-notified medicine shortages," the Guild said.

New Rx drugs

NPS MedicineWise has summarised three new drugs that may cross your pharmacy store counter this month: benralizumab for asthma, dulaglutide for type 2 diabetes and trifluridine/tipiracil for colorectal cancer

The summaries are published in the NPS Australian Prescriber.

Fasenra (benralizumab) by AstraZeneca is a humanised IgG1 monoclonal antibody that presents in a pre-filled syringe.

Trulicity (dulaglutide) from Eli Lilly is a genetically engineered protein and is marketed in pre-filled pens and syringes, while Lonsurf (trifluridine/tipiracil) by Servier is a fixed-dose combination tablet therapy and is indicated for people with metastatic colorectal cancer under specific conditions.

Twomey team testimony

QUEENSLAND Pharmacv Guild branch president Trent Twomey and his pharmacist proprietor wife Georgina have both spoken this week before the Qld Parliamentary Committee Inquiry into the establishment of a Pharmacy Council and transfer of pharmacy ownership.

The state president said he believed the Guild had had an opportunity to put its case to the committee over the course of its public hearings, along with a



NEW research published in the Journal for Healthcare Quality has demonstrated the positive value of the clinical pharmacist in the Patient Care Medical Home Model (PCMH) - a multidisciplinary, teambased approach to healthcare that focuses on actively involving the patient in clinical decision making.

The US Veterans Health Administration, while aiming to deliver primary care services, used the principles of the PCMH model to design its patient-aligned care team (PACT) and sought to evaluate the role of the clinical pharmacist when injected into this model.

This single-centre crosssectional study was conducted at an integrated Veterans Health Administration system and electronically surveyed PACT staff practising in the Tennessee Valley Health Care System in Oct 2016.

Of the 91 complete responses received, most perceptions were positive, with 79% rated as either a moderate or major contribution.

substantial written submission.

He told the panel the inquiry "should be about ensuring that medicines are provided in a safe and efficacious way to all Queenslanders regardless of where they live," noting that there is a "big gap in terms of the standards for community pharmacies in Queensland because of the absence of a Pharmacy Council".

Twomey also urged the removal of all impediments to pharmacists practising to their full scope, and cited testimony by Pharmacy Board chair Bill Kelly who said it would be desirable to establish a "premises regulator" in Queensland in order to ensure minimum standards and as a step towards national harmonisation.

Georgina Twomey (pictured) also spoke in support of the need for a Pharmacy Council in Queensland, to provide certainty for both pharmacy owners and patients.

"As a pharmacist who has complied with the Pharmacy Business Ownership Act, I want to be able to be confident that other pharmacy businesses have also complied - a level playing field is fair, and in the interests of consumers," she said.

With the hearings over, the Committee will now draft a report to the state Government, which is due to be submitted by 30 Sep.

After the blast she was rushed to hospital, with surrounding homes evacuated while bomb squad detectives searched for other sticks of dynamite.


Unfortunately the 30-yearold female received significant injuries to her face and hands, and may lose several fingers.
