UK pharmacist plan

AUTHORITIES in the UK have announced a funding plan which will see 2,000 pharmacists working in general practices by 2020.

Under a new five-year GP contract agreed to by the British Medical Association and NHS England, a "directed enhanced services" contract will incentivise doctors to form Primary Care Networks (PCNs) covering catchments of between 30,000 and 50,000 patients.

Initially each PCN will be funded to the tune of £37,810 to cover 70% of the cost of employing a pharmacist, with expectations that by 2024 each network will have five clinical pharmacists - or the equivalent of one per practice.

Pharmaceutical Services Negotiating Committee CEO Simon Dukes said the deal offers "a unique opportunity for [pharmacists] to embed ourselves further within primary care".

"GPs will be bringing together local healthcare providers into the new networks and we must engage proactively with them and find ways to position ourselves within those PCNs...all pharmacies will need to take steps to work as closely with local GPs as they can."

Asset write-off boost

THE Pharmacy Guild of Australia has welcomed a Federal Government announcement this week that it has raised the threshold for the instant asset tax write-off arrangement from \$20,000 to \$25,000.

Guild National President George Tambassis said the move would result in cash flow improvements which would help pharmacists reinvest in their business and replace or upgrade their assets, resulting in "rapid and tangible benefits to Australia's 5,700 community pharmacies". **THE** new Pharmacy Programs Administrator website, Registration and Claiming Portal, and Support Centre went live at 9am today, meaning there are new processes for all claims associated with 6th Community Pharmacy Agreement programs effective immediately.

Previously managed by the Pharmacy Guild of Australia, the administration is being taken over by AHA Consulting which was awarded the services agreement following a competitive tender process undertaken by the Dept of Health (*PD* 29 Oct 2018).

AHA already administers the Community Service Obligation (CSO) funding pool and the Chemotherapy Compounding Payment Scheme (CCPS).

The company is operating the 6CPA portal under the new Pharmacy Programs Administrator brand, which will now look after the 23 Community Pharmacy Programs funded under the 6CPA.

From today all claims must be submitted via the new portal which is available at ppaonline.com.au.

All users previously registered with the Pharmacy Guild will have had an account automatically created, and will receive a "welcome" email today with info about logging in for the first time.

Global MedAdvisor

LISTED medication adherence firm MedAdvisor is gearing up for international growth, with an ASX update yesterday confirming it had aligned its information security compliance systems to address US Health Insurance Probity and Accountability Act regulations.

CEO Robert Read said MedAdvisor was investing \$3m "to make our product and business ready for US expansion". For most major programs the new portal will check and validate claims in real-time, meaning they will be approved immediately with payments made within three business days of submission.

Currently these fast-tracked payment arrangements are in place for Dose Administration Aids, MedsCheck and Diabetes MedsCheck, Staged Supply, Home Medicines Reviews and Quality Use of Medicines, and will be extended to other programs in due course.

Chay Boss-Walker, Director of the Pharmacy Programs Administrator, said today's launch followed three months of intensive work.

"We've worked closely with pharmacists to build an entirely new and streamlined Registration and Claiming Portal, and to train our Support Centre Team," he said.

"We'll be drawing on feedback and input from pharmacies and other stakeholders to continuously improve users' claiming experience," Boss-Walker promised.

Location rule "win"

MELBOURNE pharmacist Dominic Stambe has successfully challenged a decision by Health Minister Greg Hunt which allowed the opening of a pharmacy in a medical centre a few hundred metres from Stambe's two outlets.

Despite the proximity, the Minister had approved the new pharmacy on the basis that it offered a 24 hour service, unlike other pharmacies in the area.

The application had previously been rejected by the Australian Community Pharmacy Authority.

Stambe applied for a judicial review in the Federal Court, which found Hunt had failed to give "genuine and realistic consideration" to information provided before using his discretion to approve the new pharmacy.

Stambe argued that there was a "saturation level of pharmacies in the area" and noted that they were open to match the hours of the GP services, seven days per week.

With the new pharmacy already open, the Minister's approval could not be reversed by Justice Debra Mortimer, who ruled that the parties should now negotiate on appropriate final orders, including costs, and if that failed, they were to make separate submissions.

With the strengthening and streamlining of the generic drug review process, FDA Commissioner Scott Gottlieb said the regulatory body had achieved record numbers for approvals and tentative approvals for generics in 2017-18.
