Generics fast track

THE Therapeutic Goods Administration (TGA) is seeking comments from interested parties on proposed improvements to the generic prescription medicine authorisation process.

The TGA wants to explore “ideas and opportunities to improve the supply of generic medicines in Australia”.

Proposals include ways to reduce regulatory burden, make the application process easier, support international work sharing and options to encourage applications for generic medicines of special interest.

Submissions are to reach the TGA by COB 21 Mar 2019 - tga.gov.au.

Pregabalin misuse

DATA from the PBS around the dispensing of pregabalin shows that its use in Australia is on the rise, rapidly, according to an editorial in the latest edition of the *MJA*.

The numbers of self-poisonings and deaths are also increasing, mirroring the experience in Europe and North America.

Pregabalin is now the seventh most expensive drug in terms of Pharmaceutical Benefits Scheme (PBS) expenditure - see mja.com.au.

Medicare for pharmacists?

A NEW Medicare payment for non-dispensing pharmacists to provide medication management services to patients with complex care requirements has been proposed by the Allied Health Reference Group working on the government's Medicare Benefits Scheme (MBS) Review.

The Reference Group suggests the new Medicare item would be accessible up to twice a year, to pharmacists working “outside of usual retail pharmacy operations”.

Rationale for the move provided in a consultation document cites an estimated 230,000 medication-related hospital admissions each year, at an estimated annual cost of \$1.2 billion to the health system.

Rethinking anxiety

NPS MedicineWise has launched a new educational program focusing on the diagnosis and treatment of anxiety disorders, including a webinar, clinical audit and other educational materials for health professionals - nps.org.au.

the report says, also noting that consultations undertaken by pharmacists located within primary health care clinics had been shown to be effective in identifying and resolving medication-related problems in patients with complex care requirements.

Several submissions to the MBS Review supported funding for pharmacists to deliver medication management services as a way of improving health outcomes, including input from the NT Government, the Pharmaceutical Society of Australia and the Australian Healthcare and Hospitals Association.

Microdosing queried

NEW research investigating the concept of taking very small amounts of psychedelic substances on a regular basis, or “microdosing”, has found less-than-encouraging results for the proponents of the practice.

The Macquarie University study looked at the effects of microdosing on psychological and cognitive functioning - see journals.plos.org.

APC collaboration

THE Australian Pharmacy Council is set to host a Colloquium in May, this year partnering with the Australian Nursing and Midwifery Accreditation Council on the theme of professional collaboration.

The event is scheduled for Fri 03 May 2019 at the Sofitel Melbourne, with the theme *Together we can do more - educating for social accountability across the health professions*.

The program is designed to create awareness of how pharmacists, nurses and midwives can teach, learn and practice together and to demonstrate how health profession education is aligned to social accountability, including improving indigenous health outcomes, supporting those with mental health issues and developing empathy in student practitioners.

Speakers from Australia and New Zealand will address the research behind the theme and lead interactive sessions.

The final session of the Colloquium will be a “Prophetic”, which is described as a “dynamic and entertaining technique for engaging participants deeply”.

CMA calls for health check

COMPLEMENTARY Medicines Australia (CMA) has urged the Government to evaluate whether regulatory reforms under the TGA's Medicines and Medical Devices Review are being "appropriately implemented".

CMA's pre-Budget submission calls on authorities to check that the "policy settings are right," and meeting key objectives of the Review, including cutting red tape and improving timely and safe

access to quality therapeutic goods.

CEO Carl Gibson said new legislation introduced last year after the review "sets the regulatory framework for decades to come."

"A health check on the roll-out of the reform implementation is required to ensure that the regulations are fit for purpose and Australia remains competitive on the global stage," he said.

Gibson particularly applauded the implementation of the new approval pathway for listing complementary medicines with higher therapeutic indications and health claims.

He said this measure aimed to "encourage and reward greater investment in research and development by industry and be an incentive to further expand the clinical research base for complementary medicines".

CMA's submission also urges the government to support the growth of Australian exports, focus on preventative health, support investment in research, and restore private health insurance rebates for natural therapies.
