**THE** Consumers Health Forum of Australia (CHF) is seeking a voice at the table when negotiations begin for the next Community Pharmacy Agreement (CPA) following confirmation by Health Minister Greg Hunt that the Pharmaceutical Society of Australia (PSA) will also be involved (PD yesterday).

CHF CEO Leanne Wells commented, "We urge government to include consumers in these discussions which involve the provision of more than \$20 billion over five years for the dispensing of prescribed medicines to the community.

"While today's statement is a welcome move away from the bilateral negotiations between the retail pharmacy sector and government, it is time that consumers also have a seat at the table in deciding how best to serve the interests of patients and community," she said.

Wells also noted the PSA's new report Pharmacists in 2023 which highlights that pharmacists are custodians of medicine safety, responsible and accountable for safe and effective use of medicines.

### **Breastfeeding mode** affects microbiome

**THE** microbiome of infants is impacted by the mode of breastfeeding, according to a new report in Cell Host & Microbiome vesterday.

"Breastmilk contains a complex community of bacteria that may help seed the infant gut microbiota", authors wrote but milk microbiota composition and diversity "were associated with maternal factors (BMI, parity, and mode of delivery), breastfeeding practices, and other milk components in a sex-specific manner".

For example, pumped breastmilk was consistently associated with multiple microbiota parameters including enrichment of potential pathogens and depletion of bifidobacteria.

information they need about their medication," she claimed. Wells added that CHF's own research showed that "consumers trust pharmacists, value community

pharmacy and want pharmacy services to be opened up and integrated with the rest of the health system.

"Consumers have formed specific perceptions and preferences based on their experiences with the sector and these should be heard and considered as part of discussions to shape the future of pharmacy," she concluded.

**MEANWHILE** the Society of Hospital Pharmacists of Australia (SHPA) has also hailed "broader pharmacy representation" for the next CPA, saying that "all pharmacists, practising in all settings, should have input into the important funding agreement".

SHPA CEO Kristin Michaels said while the agreement was community-facing "the reality is medication-related incidents permeate through all healthcare settings, and programs to support optimal medicines management cannot be segmented".

### Software consultation

**THE** Therapeutic Goods Administration (TGA) is opening a consultation process seeking input from stakeholders on the regulation of software, including Software as a Medical Device (SaMD).

While software is currently regulated by the TGA under the existing medical device framework, it is not thought to adequately manage the emergence of apps.

The TGA said the new regulations will, where possible, harmonise with international practices.

### Dispensary Corner



# Pharmacists' opioids focus

**CONSIDERED** one of Australia's most urgent public health crises, opioid-related harm is the central theme in the latest issue of the Society of Hospital Pharmacists of Australia (SHPA)'s flagship organ the *Journal of Pharmacy Practice* and Research (JPPR).

Prompted by recommendations in the SHPA's *Reducing opioid-related harm* report published last Nov (*PD* 26 Nov), the *JPPR* includes a special article on the subject as well as research articles, reviews and reports on hospital discharge opioid guidelines, sustained-release subdermal buprenorphine implants to manage opioid use disorder, and administration of oxycodone–naloxone and systemic opioid antagonism and harm.

SHPA Chief Executive Kristin Michaels said the focus on opioids was a fitting reflection of the issue's importance to hospital pharmacists and the acutely unwell Australians in their care.

"Through meticulous research and stakeholder consultation –

including the inaugural Medicines Leadership Forum in Jul 2018 – we now have unprecedented insight into the post-surgery risk factors that can lead to opioid dependence in different patient populations.

"This year SHPA looks forward to conversations with consumers, government and pharmacy, medical and nursing stakeholders to mitigate and reduce the alarming prevalence of opioid-related harm through the 33 recommendations of our Nov 2018 report."

THE National Institute for Health and Care Excellence (NICE) and Public Health England have published new antibiotic prescribing guidance for patients with suspected pneumonia.
